The European Union's Shaping of the International Legal Order

On 27 May 2011, CLEER organised a conference on the 'The European Union's shaping of the international legal order' in Brussels at the University Foundation.

The conference was dedicated to the study of the interaction between the EU and the international legal orders and focused specifically on the influence of the former on the development and functioning of the latter. The key issues addressed the impact of the EU in shaping the international legal order, the Union's practice of recognition of statehood and the coherence of the EU's external action.

The EU's role as standardsetter was further illustrated from legal and policy perspectives: energy efficiency, international criminal justice and the application of visa regimes in the Eastern Neighbourhood.

A separate panel of distinguished speakers discussed in depth the EU's interaction with the global economic and financial institutions.

The opening keynote address was delivered by Prof. Dr. Gráinne de Búrca (Harvard Law School) and the closing speech was given by Dr. Andrew Williams (Warwick).

The conference papers will be collected and published in a volume edited by CLEER's conference directors Prof. Dr. Fabian Amtenbrink and Dr. Dimitry Kochenov.

First Annual CLEER lecture

Prof. Dr. Allan Rosas, Judge at the Court of Justice of the EU, delivered the first-ever Annual CLEER Lecture on 17 March 2011 at the premises of the T.M.C. Asser Institute in The Hague. Tackling the questions whether the EU constitutions a human rights organization, Rosas discussed the important developments that have taken place since the early days of the European integration process, when the focus was on economic integration and fundamental rights received scarce, if any, attention. He then paid attention to the role of human rights in EU external relations, the accession procedure to the European Convention on Human Rights, as well as the applicability of international humanitarian role to CSDP operations. Prof. Dr. Martin Kuijer, senior legal counsel at the Dutch Ministry of Security and Justice, acted as respondent. The event was organized in cooperation with the Embassy of Finland to the Netherlands.

The EU as Polity in International Law

On 28 June 2011, the Peace Palace hin The Hague hosted a conference on 'The EU as a Polity in International Law', co-organized by CLEER, T.M.C. Asser Institute, Carnegie Foundation/Peace Palace Library and Euroknow.

The conference focused on the nature of the European Union and its legal order from the perspective of international law. The Union's relationship with the international legal order and role in international relations were also touched upon.

The opening speech by Prof. Laurens-Jan Brinkhorst (Leiden University, former Minister for European Affairs) and the presentations by Judge Bruno Simma (ICJ), Prof. Michael Burgess (University of Kent), Prof. Christiaan Timmermans (Erasmus University Rotterdam, former judge at the ECJ) provided insights into the topic from various vantage points. Their strong views triggered lively discussion among a record audience of 200 registered participants. The conference was an initiative of Mr. Jaap Hoeksma, Director of Euroknow.
