European Commission's DG for Environment Consultation: Consultation on the evaluation of the EU Timber Regulation two years after its entry into application (15/04/2015 - 03/07/2015)

The objective of this consultation is to gain stakeholder and public input regarding a review of Regulation (EU) 995/2010 (the EU Timber Regulation; the EUTR). The review will provide essential elements for the mandatory report to be submitted by the Commission by 3 December 2015 to the European Parliament and the Council. The report may be accompanied, if necessary, by appropriate legislative proposals.
