#### 22 February, CLEER-ICCT Conference: 'The External Dimension of EU Counterterrorism Policy'

The Centre for the Law of EU External Relations (CLEER) and the ICCT-The Hague invited academics, legal and policy experts, policy makers, and stakeholders to Brussels on 22 February 2013 where they discussed some ten years of EU external action in countering terrorism.

# 19 April, CLEER Workshop on 'EU environmental norms and third countries: the EU as a global role model?'

The workshop was the second event in CLEER's research project 'Commercial power Europe: advancing societal and environmental goals through trade relations', implemented with the support of the Lifelong Learning Programme of the European Union. Academics, legal and policy experts, policy-makers, stakeholders and practitioners discussed the modalities of the EU employing trade and other instruments to promote sustainable development including protection of the environment. The collection of the presented papers was published in the CLEER Working Papers series.

#### **CLEER Presidency lecture series**

The Presidency lecture series, initiated in 2011, complements the events organised by Asser/CLEER. It focuses on a specific segment of EU external actions: the role of the incumbent EU Council presidencies in coordination and leadership in regional and global issues.

The Presidency lecture series has, to date, reviewed the experiences of the Hungarian (2011), Polish (2012), Danish (2012), Cyprus (2013) and Irish (2013) presidencies of the EU Council in the area of EU external relations. Representatives of ambassadorial rank provided clear insights to the major challenges and achievements in representation, negotiation and coordination at the helm of the EU Council.

The lecture series has been particularly successful in engaging the diplomatic contingent of EU countries posted in The Hague, giving them the opportunity to share their experiences with the broad networks of the T.M.C. Asser Instituut and CLEER.
