#### **Registration Procedure**

- 2. Each participant should use a separate form.
- 3. Upon receipt of the completed online registration form, you will be directed to a secure online payment environment.
- 4. Your place at the Masterclass is confirmed only when the online registration form has been submitted and the payment has been received.
- 5. The registration form constitutes a legally binding agreement. By submitting the completed registration form, the registrant declares to be in accordance with the requirements and provisions described therein.
- 6. The T.M.C. Asser Instituut cannot be held responsible for the non-arrival of registration information. If you have not received confirmation of your registration within 24 hours of submitting, please contact conferencemanager@asser.nl
- 7. The T.M.C. Asser Instituut reserves the right to withhold registration.
- 8. After successful attendance of the programme, a certificate of completion will be provided.

#### **Payment Conditions**

- 1. The online fee for each of the two Masterclasses mentioned above is €595.
- 2. A reduced fee of €445 has been made available for both IJI and Asser clients.
- 3. A reduced fee of €295 has been made available for (PhD) students and NGO (non-governmental organisation) workers.
- 4. The fees include lectures and study materials\*.
- 5. The full payment must be made within 10 days after receipt of the confirmation e-mail. You will only be secured of a place at the Masterclass once the T.M.C. Asser Instituut has received your payment in full.

#### **Cancellations and Non-Attendance**

- 1. Cancellations will only be accepted when your request for cancellation is submitted by e-mail to <a href="mailto:conferencemanager@asser.nl">conferencemanager@asser.nl</a>
- 2. You have the right to withdraw your participation within 14 days of completing the payment, and the full sum paid will be reimbursed.
- 3. Once the abovementioned 14-day withdrawal period has expired, if you cancel less than four weeks prior to the starting date of the Masterclass, no refund of the course fee will be given.
- 4. Once the abovementioned 14-day withdrawal period has expired, if you cancel within the allotted time (at least 4 weeks before the starting date of the course), a processing fee of €250 will be charged. The remaining sum will be refunded.
