The Summer Law Program in The Hague is the product of a unique collaboration between the War Crimes Research Office of American University's Washington College of Law, established in 1995 to provide specialised legal research assistance to internationalised criminal tribunals, and the T.M.C. Asser Instituut.



This summer programme offers participants an opportunity to study some of today's most important legal issues in the heart of the international justice community. The team of lecturers and instructors for the programme will include judges, prosecutors and staff members from the ICJ, ICC, ICTY and other organisations and universities. Visits to 6 major courts and legal organisations located in The Hague are also included in the programme.

# International Criminal Law & International Legal Approaches to Terrorism

The course on International Criminal Law will provide thorough understanding of ICL, from substantive crimes (genocide, crimes against humanity, war crimes) to functioning of the international tribunals (ICTY, ICTR, ICC and hybrid tribunals) to the general role of the defence and victims. The course on International Legal Approaches to Terrorism in the 21st Century will cover the salient aspects in the fight against terrorism, from different forms of terrorism (terrorism in the air, terrorism on the sea, terrorism in cyberspace) to the applicable law (International Humanitarian Law, International Human Rights Law ) to trying terrorist both domestically and internationally. Topics that will be covered:

- Crimes against Humanity, War Crimes, Genocide
- Immunities and Amnesties
- Modes of Liability
- Victim Participation and Reparations before the ICC
- Trying Terrorists Internationally / Trying Terrorists Domestically
- State responsibility for Terrorism
- Use of Force in Response to Terrorism
- Terrorism on the Sea / Terrorism in the Air / Terrorism in Cyberspace

# **Target Audience**

40 students from top US law schools will travel to The Hague, the City of Peace and Justice, to follow this quality programme and visit courts and tribunals that are making legal history as we speak.



An additional 10 places are available on this programme for interested students/young professionals from across the globe interested in pursuing careers in counterterrorism and related fields of work.

#### **CANCELLATION POLICY**

- 1. Cancellations will only be accepted when your request for cancellation is submitted by e-mail to educationtraining@asser.nl
- 2. If you cancel less than four weeks prior to the starting date of the Summer Programme, no refund of the course fee will be given.
- 3. If you cancel within the allotted time (at least 4 weeks before the starting date of the course), a processing fee of €200,- will be charged. The remaining sum will be refunded.
