# INTERNATIONAL SPORTS LAW

Twenty years ago the concept of "Sports Law" would have been foreign to most. Today, it is far more widely recognised as an established field of legal scholarship practice. As a corollary to the commercialisation. growing professionalisation, and globalisation of sport, athletes, sports clubs, and organisations' runins with the law have not only become more frequent, but also more apparent. While the autonomy of sport may have been once an effective defence against "outside"



legal interference, the sports world increasingly has come to accept that its autonomy is constrained by the rule of law and preconditioned on e.g. principles of good governance. Sports governing bodies also realise that they are unable to deal with various threats and challenges alone: e.g. doping, match-fixing, and other types of fraud. The burgeoning sports-oriented workload of courts (e.g. Court of Justice of the EU, Swiss Supreme Court) and disciplinary and arbitral tribunals (e.g. FIFA DRC , Court of Arbitration for Sport (CAS)) has had a significant impact on sports law as an academic field and helped contribute to its establishment as a global field of private practice.



# **PROGRAMME**

The Asser International Sports Law Centre provides a week-long educational programme (30 June -4 July, 2014) in The Hague led by a number of internationally renowned sports law experts (i.e. academics, practitioners, public officials etc.).

The programme includes a combination of lectures and workshops that will provide both a general knowledge of the legal principles at play and a practical experience of the legal reality on the ground.
