- Preliminary Hearing Judge -

Pursuant to Article 35 (2) h), Article 226 (1) and Article 227 (1) of the Criminal Procedure Code of Bosnia and Herzegovina, I hereby file the following

INDICTMENT

Against:

- 1. NISVET GASAL, aka Nisko, son of Fazlo and mother Tenzila nee Terzić, born on 25 May 1964 in the village of Oborci, the Municipality of Donji Vakuf, residing in Bugojno at the address Poljice 1 Street, number 29, Personal Identification Number 2505964191257, a criminal investigator by occupation, completed two-year post-secondary school, literate, Bosniak by ethnicity, BiH citizen, married, no prior conviction, in custody under the Decisions of the Court of Bosnia and Herzegovina Number: X-KRN-07/341 of 23 March 2007, 20 April 2007 and 19 June 2007,
- 2. MUSAJB KUKAVICA, son of Fuad and mother Habiba nee Bećar, born on 10 March 1970 in Jajce, residing Bugojno at the address Donjići I, number 32A, Personal Identification Number 1003970191268, a lathe operator by occupation, completed secondary school, literate, Bosniak by ethnicity, BiH citizen, married, no prior conviction, in custody under the Decisions of the Court of Bosnia and Herzegovina Number: X-KRN-07/341 of 23 March 2007, 20 April 2007 and 19 June 2007,

Due to the following acts:

During the war in Bosnia and Herzegovina, and at the time of the armed conflict between the Croat Defence Council /HVO/ and the Army of the Republic of Bosnia and Herzegovina, in the period between August 1993 and 19 March 1994, in the Football Club /FC/ Iskra Stadium Camp in Bugojno, as members of the Bugojno Public Security Station reassigned to the RBiH Army and as members of the RBiH Army, more specifically, the first-suspect Nisvet Gasal in his capacity as the Camp Warden of the FC Iskra Stadium, and the second-suspect Musajb Kukavica in his capacity as the Security Camp Commander of the FC Iskra Stadium, they acted contrary to the rules of international humanitarian law and thereby violated Article 3 (1) a) and c) of the Geneva Convention relative to the Protection of Civilian Persons in Time of War of 12 August 1949 by committing, inciting and aiding in the preparation and commission of the criminal offences reflected in an inhumane treatment of detainees of Croat ethnicity in the FC Iskra Stadium Camp who, without any grounds, were deprived of their liberty and detained in the referenced Camp, they kept them there in inhumane conditions, made them perform forced labour, allowed the other members of the RBiH Army to enter the referenced Camp and take the detainees out of the Camp for interrogation, on which occasion they were tortured, and some detainees have been unaccounted for ever since, and besides, they failed to take necessary and reasonable measures to prevent the torture of detainees in the Camp under their control and to punish perpetrators subordinate to them; to be more explicit:

1. NISVET GASAL AND MUSAJB KUKAVICA TAKEN TOGETHER

In the period from 21 September 1993 to 19 March 1994 and in the period from 21 September 1993 to 8 March 1994 Nisvet Gasal and Musajb Kukavica respectively were responsible for the operation of the FC Iskra Stadium Camp and were directly superior to all the guards and responsible for the supervision of the work of guards in the referenced Camp in which, under inhumane conditions, more than 300 persons - men of Croat ethnicity - were detained in unfit rooms in which standards of hygiene were deplorable and the detainees did not have enough food, water and necessary medical aid, whereas during the same period of time, a great number of detainees were exposed to inhumane treatment; they were taken out of the Camp to perform forced labour in Bugojno where they cleaned the streets, chopped wood for the needs of the RBiH Army and performed different physical work or were taken to the front lines held by the RBiH Army against the Republika Srpska Army and HVO in the direction of Donji Vakuf, Gornji Vakuf/Uskoplje, and in the direction of Kupres, more specifically, the places: Podripci, Sabljari, Pajić Polje, Donja Hrasnica, Gornja Hrasnica, Pirići, Duratbegović Dolac, Garačački Podovi and other places where they dug trenches and communication trenches and dugouts, there was a lot of shooting at these locations while the detainees were working, and they were often used as "human shields", a number of detainees suffered bodily injuries, including detainees were brought back to the Camp they were not provided with adequate medical aid; at the same time, a large number of camp detainees was tortured by guards in this Camp or by other members of the RBiH Army who were allowed to enter the Camp by the guards who were subordinate to them, only to torture the detainees of Croat ethnicity who were tortured in such a way that the guards, and sometimes Musajb Kukavica personally, took them out of a room in which they were detained and brought them to a corridor of the Stadium, on the open stands of the Stadium or the field of the Stadium where they were kicked, punched and struck with blunt objects all over their bodies by guards and members of the RBiH Army; the following persons were tortured in such a way:

and other detainees; many detainees were taken out of the rooms in which they were detained by guards, some were also taken out by Nisvet Gasal and Musajb Kukavica, and afterwards in order for them to be interrogated, they were taken by guards in the Camp and members of the Military Police from the Camp under their control to the premises of the BH Bank in Bugojno where the Military Police of the 307th Brigade had been based and where the Military Police Company of the West Operations Group of the RBiH Army was based since November 1993, and where they were tortured in such a way that military police officers kicked them, punched them and struck them with blunt objects; afterwards, with obvious injuries all over their bodies, they were brought back to the Camp, among the detainees being:

the following detainees were not brought back to the Camp after they had been taken for the second time to the BH Bank for interrogation, where they were tortured in the same way:

were not returned after

they had been taken there for the second time; also,

were not taken back to the Camp; these detainees have been unaccounted for ever since,

II. MUSAJB KUKAVICA ALONE

From the begining of the establishment of the FC Iskra Stadium Camp in August 1993 until about 9 September 1993, he was directly superior to all the guards in the Camp and responsible for the supervision of the guards' work in this Camp in which, under inhumane conditions, more than 300 persons - men of Croat ethnicity - were detained in unfit rooms in which the standards of hygiene were deplorable and in which the detainees did not have enough food, water and necessary medical aid, whereas at the same time period a large number of detainees was exposed to inhumane treatment in such a way that they were taken out of the Camp to perform forced labour, and Musajb Kukavica was often present when detainees were selected for the work, and sometimes he personally selected detainees for the work; detainees were taken to perform the forced labour in Bugojno where they cleaned the streets and performed other different physical work or were taken to the front lines which were held by the RBiH Army against the Republikate

Srpska Army and HVO in the direction of Donji Vakuf, Gornji Vakuf/Uskoplje, and in the direction of Kupres, more specifically towards the places of Prusac, Guvna, Bistrica, Pajić Polje, Donja Hrasnica, Gornja Hrasnica, Vejići, Pirići, Duratbegović Dolac, Garačački Podovi and other places where they dug trenches and communication trenches and dugouts, and were often used as "human shields" and tortured by the RBiH Army members who punched them and kicked them all over their bodies; while they were working, a number of detainees including

suffered bodily injuries, and when they		
were brought back to the Camp they were not provided with adequate medical aid, or were killed,		
including or were taken from the forced labour in Prusac to		
the Bugojno BH Bank premises for interrogation, where the Military Police of the 307th Brigade of		
the RBiH Army was based, among those being		
where they were tortured in such a way that the		
Military Police members punched them, kicked them and struck them with blunt objects all over		
their bodies, and as a result of the injuries he received during the torture in the BH Bank		
died, and was then carried by a vehicle in an unknown direction, so that all of them,		
except for who managed to escape, have been accounted for ever since, whereas in		
the same time period, a large number of detainees in the Camp were tortured by the guards in this		
Camp or by other members of the RBiH Army who were allowed by the guards subordinate to him		
to enter the Camp only to torture the detainees of Croat ethnicity who were tortured in such a way		
that the guards, and sometimes Musajb Kukavica personally, took them out of the room in which		
they were detained into the corridor of the Stadium, at the open stands of the Stadium or the pitch		
of the Stadium where they were punched, kicked, struck with blunt objects all over their bodies by		
the guards and members of the RBiH Army; the following detainees were tortured in such a way:		

and other detainees.

Therefore, during the war in Bosnia and Herzegovina, at the time of the armed conflict between the HVO and the RBiH Army, by violating the rules of international humanitarian law, more specifically, Article 3 (1) a) and c) of the Geneva Convention relative to the Protection of Civilian Persons in Time of War of 12 August 1949, they committed, incited and aided in the commission of the acts of inhumane treatment, torture, forced labor of the detainees, and as the superiors and responsible persons they failed to take necessary and reasonable measures in preventing the commission of the referenced offences and punishing the perpetrators of these offences,

As seen by the acts described in Counts I and II of the operative part, Nisvet Gasal and Musajb Kukavica committed the criminal offence of War Crimes against Civilians in violation of Article 173 (I) c) and f) of the BiH CC in conjunction with Article 180 (I) and (2) and Article 29 of the BiH CC.


PROPOSE


I. That the following persons be summoned:



INVESTIGATION RESULTS

The results of the investigation conducted by this Prosecutor's Office undoubtedly confirm the validity of this Indictment, that is, the allegations that the first and the second suspect, Nisvet Gasal and Musajb Kukavica, in the manner, at the time, in the place and under the circumstances stated in the operative part of the Indictment, committed the criminal actions stated in this Indictment, which constitute all the essential elements of the criminal offence of War Crimes against Civilians referred to in Article 173(1)(c) and (f), in conjunction with Article 29 of the Criminal Code of Busnia and Herzegovina and Article 180(1) and (2) of the CC BiH.

It has been established by the evidence which the Prosecutor's Office obtained during the investigation, both the physical evidence and the statements of the witnesses examined, that the suspects Gasal Nisvet and Musajb Kukavica committed this criminal offence in Bugojno during the war in Bosnia and Herzegovina and at the time of the armed conflict between the Army of the Republic of Bosnia and Herzegovina (hereinafter: the ARBiH) and the Croat Defence Council (hereinafter: the HVO), as members of the civilian police, that is, the Bugojno Public Security Station reassigned to the Army of BiH and as members of the Army of BiH, namely: Nisvet Gasal in the capacity as the Warden of the FC Iskra Stadium camp and Musajb Kukavica in the capacity as the Security Commander in the FC Iskra Stadium camp.

a) War in Bosnia and Herzegovina

Pursuant to Article 8 of the Decree Law on Defence (Official Gazette of the RBiH, number 4/92), upon the motion of the Main Staff of the Armed Forces of the Republic of Bosnia and Flerzegovina, at the session held on 20 June 1992, the Presidency of the Republic of Bosnia and Flerzegovina issued the Decision on declaring the state of war, by which the state of war in the territory of the Republic of Bosnia and Flerzegovina was declared.

The Decision on declaring the state of war was published in the Official Gazette of the RBiH, number 7/92, and it entered into force on the day when it was published in the Official Gazette of the RBiH, namely on 20 June 1992.

Based on the General Framework Agreement on Peace in Bosnia and Herzegovina of 14 December 1995, the Presidency of the Republic of Bosnia and Herzegovina, upon the motion of the Ministry of Defence, rendered the Decision on terminating the state of war at the session held on 22 December 1996.

b) Armed conflict between the HVO and the Army of RBiH

It is evident from the abundant amount of evidence collected by this Prosecutor's Office during the course of the investigation that there was an armed conflict between the ARBiH and the HVO in



the relevant period of time in the area of the Bugojno municipality, as well as in the area of the neighbouring municipality of Gornji Vakuf/ Uskoplje.

It indisputably follows from the physical evidence and the statements of the witnesses examined in the Prosecutor's Office of Bosnia and Herzegovina that the armed conflict between the ARBiH and the HVO in Bugojno began on 18 July 1993. The ARBiH attacked the HVO positions in Bugojno thereafter. This attack was not limited only to the HVO positions, but also numerous civilians of the Croat ethnicity were deprived of liberty at their homes and imprisoned.

The Interim Report of the operational body of the Bugojno Army Operations Command number 02-788-6 of 11 July 1993, which was sent to the West Operations Group, among other things, under item 2 states the following:"...the situation in the area of Bugojno is still complex and tense.", while item 3 states: "our forces are in full combat readiness. Activities regarding the combat operation planning and the regrouping of a part of the forces are ongoing".

The Combat Report of the Military Police of the 307th Motorized Brigade for the period between 18 July 1993 and 31 July 1993, number 1100-1083/93 dated 10 August 1993, among other things, states the following: "Since noticeable tension was felt in the relations between the Army of RBiH and the HVO forces in Bugojno for a fairly long time, and since it culminated on 18 July 1993, our unit was put in the state of full combat readiness. The Military Police Command facility was immediately secured in the appropriate manner and all members of our unit, except those who were on regular leave that day, were put in the state of full readiness. All necessary preparations were also made that day, so that the unit could start combat activities immediately at any moment."

On 19 July 1993, upon the order of the superior command, the unit was at its previously established positions, from where it initiated an action in the region called Sector 1V/2. On the same day, the action at the Hunting Club and private housing facilities in M. Tita Street was completed,... After that the action was initiated at Lamela in Dž. Bjedića Street, opposite to the PTT /Post, Telegraph, Telephone/ building. Immediately after the action was completed in the Hunting Club, a part of our unit linked up with the area units from Sectors II and III, and a joint operation of mopping up in the area began ... In the afternoon hours of 20 July 1993, the action was fully completed in Lamela in Dž. Bjedića Street and in the Catholic monastery near Lamela. A few days before the direct conflict with the HVO units, proper preparations were made with area unit members and civilian population from that part of Sector IV/2, so that that part was mopped up very quickly and without casualties on our side... Our forward platoon in the ZOIL /Personal and Property Insurance Co./ building in the town centre was under the command of the Ministry of the Interior, Public Security Station Bugojno, from the beginning of the conflict and, acting together with members of the Ministry of the Interior, it participated in actions involving enemy strong points in Sector IV/1. First the Inpo Department Store was captured on 20 July 1993, and our forward platoon directly participated in the capture of Ljubljanska banka, the Ustashas' stronghold in Tomo Ivković's house, the Kalin hotel and the 1st Battalion.... so that on that day, 21 July 1993, the action was also completed at the so-called Špic near the Catholic cemetery in Sultanovići, so that the task entrusted was completely fulfilled in this way, which means that the starting combat line towards Crniè and towards the villa Gorica was formed. After that our forces regrouped, consolidated its ranks and waited for next tasks... Soon afterwards enemy strong points in the town started falling one after another and our unit was given a task to take over the captured combatants and civilians, and then place them in appropriate places and take care of their security, which was done...."

By its Daily Operation Combat Report, strictly confidential No. 04/516-93 of 23 July 1993, the West Operations Group Command informed the 3rd Corps Command, among other things, of the following: "The units of the 307th Motorized Brigade and the Municipal Defence Staff captured part of the 1st Battalion, took control of the Spediciju company and took control of the area, so that 95% of the town area is under our control. One strong point remained in the town, namely the Kalin Hotel, where the HVO Military Police was located. The positions at the Kik hill above the village of Vesela have been strengthened by the forces of 4/307 battalion and the HVO prevented from taking complete control of Crnički Podovi. At the same time we regrouped the forces for the attack on the HVO parts in the area of the village of Peruzović-Jasika. An attack on the village of Humac has also been launched; the attack is still ongoing. Panic is reported in Ustashas' ranks...", while the Daily Operation Report, strictly confidential No. 04/521-93 of 24 July 1993, among other things, states that "in the area of the 307th Motorized Brigade ...the Kalin hotel strong point was occupied and on that occasion 100 combatants and 150 civilians were captured."

The Daily Report of the 3rd Corps Press Centre of 25 July 1993 states: "The major Ustashas' stronghold in the town, the Kalin Hotel, fell in yesterday's combat activities. A hundred of combatants were captured there and the Army gained control of the entire Goduša area."

The Regular Combat Report of the Bugojno Municipality Defence Staff number 02/263-80 of 26 July 1993, which was sent to the *West* Operations Group, states the following: "Around 21:00 hrs on 25 July 1993 the 2nd Battalion with the Commander Dragan Erkapić surrendered to our forces. 108 combatants in total surrendered..."

The Regular Combat Report of the Bugojno Municipality Defence Staff number 02/263-83 of 27 July 1993, which was sent to the West Operations Group, under item 2 states the following: "After capturing the villages of Perzović and Garačički Podovi, the defence line against the HVO is as follows:

- Tičija gl. trig point 1022 - Debelo brdo 952, Gladovo trig point 907 - Drinovi klanac - Vrpeć village - Gorica trig point 646 - Sultanovići village - Catholic cemetery - Vučipolje village - Kandija village - trig point 710 - Golo Brdo (Muslim cemetery) - Zlavast village in our hands - trig point 813 - Dubovik.

- There are a large number of civilians and around 1000 combatants within the delimited area (Kandija Crniče). We offered them the possibility to surrender via the UNPROFOR, but they refused.
- We estimate that they will attempt to break out towards the village of Gračanica or towards the village of Kordići. We are strengthening our forces in both directions with a goal of narrowing the encirclement and forcing them to surrender."

The existence of the armed conflict is also evident from other physical evidence proposed to be inspected at the main trial and the statements of the witnesses heard during the investigation and proposed to be examined at the main trial.

c) FC Iskra Stadium camp and the capacity of the victims - injured parties

At the session held on 24 August 1993, the Bugojno Municipality War Presidency issued the Decision on designating the lockup premises (detention) for civilians and military personnel who have been convicted or detained by relevant authorities on the premises under the stands of the *Iskra* football stadium. The Decision is registered under number 01-124-86/93.

Although the mentioned Decision was issued on 24 August 1993, the evidence collected by this Prosecutor's Office during the investigation indicates that the FC Iskra Stadium was prepared for the reception of HVO detainees and civilians of the Croat ethnicity as early as the beginning of August 1993 and that civilians and HVO members were detained on the premises under the *Iskra* stadium stands already by 15 August 1993.

First of all, the witness stated that on 5 August 1993 he was transferred to a guard post within the compound of the FC Iskra Stadium Iaklië and described that he and others first had the task to relocate the stadium fence and place it under the stadium stands towards the entrance and then to place an observation post at the stadium stands to secure the prison. He further stated that, according to his information, there was an order to establish this prison-detention. The witness also confirmed these allegations, saying in his statement that sometime between 6 and 7 August, in mid-August 1993, from the Vojin Paleksić Elementary School, where he was detained for some time, he and several other detainees were taken to the Iskra Stadium, where they were placing pallets and boards in changing rooms under the stands and preparing the premises, that is, the camp for all HVO members and civilians who were detained. He stated that a guard who escorted them from the school to the stadium told them what the purpose of the preparations at the stadium was and that they were working on these preparations for three to four days, and then all of them were transferred from the school to the stadium.

The witnesses who were examined confirmed that the transfer of the detainees to this space had

taken place before the decision on establishing the prison was issued. They stated that they were detained at the FC Iskra Stadium as early as in the first half of August 1993.

The second suspect Musajb Kukavica himself spoke in favour of the foregoing assertion. It follows from the Record of the questioning of the suspect Musajb Kukavica number KT-RZ 125/07 dated 20 April 1993 that Musajb Kukavica, together with Ibro Letić, was transferred from the Bugojno Public Security Station to the FC Iskra stadium some 15 days after the end of conflicts and that Meho - Mehmed Sadiković was assigned to the position of Warden at the stadium. Bearing in mind that the conflicts in Bugojno ended on 25 July 1993, it is evident that the suspect Musajb Kukavica started performing duties as the guard commander at the FC Iskra stadium in the first half of August 1993. All of this is confirmed by the physical evidence, the personal record card and the unit file for Musajb Kukavica, from which it is evident that he was transferred from the Bugojno Public Security Station to another unit on 5 August 1993.

Although the evidence collected by the Prosecutor's Office confirms that the Bugojno Municipality War Presidency was thinking even earlier about establishing the Prison for members of the Army of RBiH at the FC Iskra Stadium, it is evident that this intention was realized only after the direct conflict between units of the Army of RBiH and the HVO in Bugojno and that the Prison was indeed established, however, not for ARBiH members, but for captured Croats. It is evident from the Order of the Bugojno Army Operations Command number 01-933-1 of 26 July 1999 (although 1999 is written on this document, it is obvious that this is a typing error and that 1993 should be written instead) that, after the end of the conflict, members of the ARBiH, Ministry of the Interior and Military Police committed certain crimes against captured civilians and HVO members. After the end of the direct conflict in the Bugojno town, HVO members and Croat civilians were imprisoned at several locations, namely: a garage in Donjići, the Furniture Showroom Slavonija DI, premises of the Marxist Centre - Nuns' Cloister, the Vojin Paleksić Elementary School, the Stipo Derek Elementary School and the Culture and Sports Centre, which were under the ARBiH control, as well as in the Bugojno Pubic Security Station and Gimnazija /Grammar School/, which were under the civilian police control. HVO members and Croat male civilians were escorted from all the mentioned detention facilities, except the Bugojno Public Security Station and the Grammar School, which were under the civilian police control, and imprisoned at the Iskra Stadium in August 1993. The detainees who were on the premises under the civilian police control were escorted to the Iskra Stadium in late September or early October 1993. As it has been already stated above, preparations for the imprisonment of Croats at the FC Iskra Stadium began already in early August 1993. The Decision number 01-V-22/93 of 28 July 1993, issued by the Bugojno Municipality War Presidency, confirms that the preparations started even earlier. Mehmed Sadiković was appointed as the Warden of the temporary prison in Bugojno by this Decision.

A large number of the witnesses examined by this Prosecutor's Office during the investigation stated that in the very beginning the first Camp Warden was Mehmed Sadiković and that the

Suspect Nisvet Gasal was appointed to his post after a certain period of time. The suspects Nisvet Gasal and Musajb Kukavica confirmed this themselves. Furthermore, statement confirmed the foregoing assertion, since she stated that she worked as Mehmed Sadiković and that she was doing this job for about a month, until Mehmed Sadiković was transferred to work in the Bugojno Municipality, and after that she was also transferred to the Bugojno Public Security Station.

Although it was established as lockup premises (detention) for civilians and military personnel convicted or detained by relevant authorities, and although the names Bugojno Town Prison, Bugojno Military Prison and Lockup premises are also used, the Iskra FC Stadium was a camp in the true sense of the word. The entrance to the FC Iskra Stadium camp was fenced with wire, there was an observation post in the camp and there were guard posts at the entrance gate. The detainees were placed in one fairly large and several fairly small premises located under the stadium stands. The guard commander and the guards had their room at the stadium, while the Camp Warden's office was in a residential building near the camp, but the guards, shift leaders, the commander of the guard/security and the deputy warden regularly went and reported to the warden, and the warden himself regularly visited the camp.

The detainees in the camp FC Iskra Stadium were civilians and HVO members. However, at the time when the offences the suspects have been charged with were committed, the detainees did not take active part in combat activities, so they are to be treated as civilians in accordance with the case law of the ICTY and the Court of BiH. It was established in Paragraph 54 of the final judgment of the ICTY in The Hague in the Ielisić case, number 1T-95/-10, among other things, that reference to a civilian population would seek to place the emphasis more on the collective aspect of the crime than on the status of the victim, that is, that the notion of the civilian population must include all those persons bearing or having borne arms who had not, strictly speaking, been involved in military activities. The Trial Chamber concluded that the notion of civilian population in the strict sense also included all persons placed hors de combat when the crime was perpetrated. The case law of the Court of Bosnia and Herzegovina in the final judgment against Abduladhim Maktouf and the first instance judgments against Niset Ramié and Nikola Andrun goes in the same direction. It is important to note that all detainees in the FC Iskra Stadium camp were Croat men, among whom were at least two juveniles.

Disobedient ARBiH members were also detained at the FC Iskra Stadium during a certain period of time. However, conditions of their detention differed significantly from those of the Croat men in detention. The ARBiH members were detained in a room physically separated from the Croat detainees, they did not go to perform forced labour and they were detained only until the expiry of a certain punishment and then released.

It is evident from the physical evidence collected by the Prosecutor's Office of Bill in the course of the investigation that the authority over the FC Iskra Stadium camp was changing. Three

periods are characteristic: the period from the establishment of the eamp until mid-September, the period from mid-September until the end of October 1993 and the period from the end of October 1993 until the exchange of detainees and the closing of the camp in 1994. The first two periods are very specific since it is not clear who exactly was in charge of the camp. However, it is evident that in these periods the municipal authorities, Bugojno Defence Staff Command, Bugojno War Presidency, Bugojno Public Security Station, 307th Motorized Brigade and West Operations Group contributed significantly to the functioning of the camp. In the third period the camp went completely under the authority of the ARBiH West Operations Group. It is evident from the suspects' personal record cards and unit files and other evidence that there was a change of the authority over the camp. Also, in late October and early November 1993 there was a change in relation to the ARBiH Military Police. The Military Police, which had been within the composition of the 307th Motorized Brigade by that time and called the Military Police of the 307th Motorized Brigade, was directly resubordinated to the West Operations Group and named the Military Police Company of the West Operations Group.

On 19 March 1993, through the International Committee of the Red Cross (hereinafter: the ICRC), 294 Croat detainees from the FC Iskra Stadium camp were exchanged.

However, regardless of the change of authority over the FC Iskra Stadium camp, the responsibility and the capacity of the suspects Nisvet Gasal and Musajb Kukavica did not change.

d) Capacity of the suspects

It follows from the physical evidence obtained during the investigation that the first suspect Nisvet Gasal was the Warden of the FC Iskra Stadium camp in the relevant period of time, while the second suspect Musajb Kukavica was the Security Commander of the FC Iskra Stadium camp. This fact is evident from the objective documentation, the statements of numerous witnesses and the records of the questioning of the suspects.

I. Nisvet Gasal

The name of the first suspect Nisvet Gasal is written under number 64 of the list of the Bugojno Public Security Station (the PSS) members of 11 August 1993, which the Bugojno PSS Chief delivered to the Bugojno Municipal Secretariat of Defence with the covering document number 19-2/01-1-232/93 of 11 August 1993.

The Bugojno PSS Chief delivered to the Bugojno Municipal Secretariat of Defence the list of the Public Security Station members of 30 September 1993 inclusive, the list of newly-hired members of the Public Security Station, the list of members who are no longer assigned to the Bugojno



Public Security Station and the list of members who are reassigned with the covering document number 19-2/01-501/93 of 30 September 1993. The list of members who are reassigned contains eighteen names in total. Out of these eighteen names, 15 PSS members were reassigned to the *Military Police*, while three PSS members were reassigned to the *Prison*. The first of the three PSS members reassigned to the *Prison* is Nisvet Gasal. All 18 PSS members were registered as reassigned since 22 September 1993.

In the Official Note number 03-94/119 of 7 March 1994, made by an authorized officer of the Security Body of the 307th Mountain Brigade, the first suspect Nisvet Gasal is mentioned as the Warden of the Central Prison.

It is also evident from other documents signed by the suspect Nisvet Gasal that he performed the function of the warden of the FC Iskra Stadium camp. These documents are as follows:

- Warden's document number 530-3-/94 of 21 March 1994.
- Warden's document number 477-3/94 of 8 March 1994,
- Warden's document number 28 February 1994, by which he delivered information on weapons to the *West* Operations Group Commander,
- Warden's document number 331-2/94 of 14 February 1993, Warden's document number 318-2/94 of 11 February 1994 and
- Warden's document number 5/93 of 23 October 1993.

The last document mentioned is particularly interesting and it confirms that there was a change in the authority over the camp, but that the same person remained the Warden. The title of the mentioned document reads as follows: RBiH, Bugojno Municipality, Administration of the Lockup Premises – Detention Bugojno, while the seal reads: RBiH, Bugojno Municipal Assembly, Lockup Premises. In the abovementioned documents, which were obtained by the Prosecutor's Office during the investigation and issued by the warden after this document, the title reads: RBiH, ARBiH, West Operations Group, Lockup Premises, while the Warden continued using the same seal.

II. Musajb Kukavica

The second suspect Musaib Kukavica is listed under number 112 of the list of the Bugojno Public Security Station members of 11 August 1993, which the Bugojno PSS Chief delivered to the Bugojno Municipal Secretariat of Defence with the covering document number 19-2/01-1-232/93 of 11 August 1993. Hence, although according to the unit file and personal record card Musajb Kukavica was registered in another unit since 5 August 1993, the actual situation in 1993 was different, that is, he was still registered as a member of the Bugojno PSS. This is also confirmed by the Certificate of the Bugojno Defence Section number 17-21-11-03-32-814/06 of 20 March 2006.

The Bugojno PSS Chief delivered to the Bugojno Municipal Secretariat of Defence the list of the Public Security Station members of 30 September 1993 inclusive, the list of newly-hired members of the Public Security Station, the list of members who are no longer assigned to the Bugojno Public Security Station and the list of members who are reassigned with the covering document number 19-2/01-501/93 of 30 September 1993. The list of members who are reassigned contains eighteen names in total. Out of these eighteen names, 15 PSS members were reassigned to the Military Police, while three PSS members were reassigned to the Prison. The second of the three PSS members reassigned is Musaib Kukavica and he, as well as the remaining 17 PSS members, was registered as reassigned since 22 September 1993. The unit file and personal record card state that Musajb Kukavica transferred from the Bugojno PSS to another unit on 5 August 1993.

The statement number 1100-360-A-94 of 8 March 1994 mentions that the second suspect Musajb Kukavica performed the duty of the Security Commander of the Military Prison in Bugojno in that period.

The Decision number 493-3/94 of 10 March 1994, issued by the Camp Warden, states the following: "We hereby inform you that Musaib Kukavica, son of Fuad, is relieved of his duty as the prison security commander. He performed this duty from 21 September 1993 to 8 March 1994, and he is referred to the personnel and legal affairs."

The fact that the suspects Nisvet Gasal and Musajb Kukavica performed the abovementioned duties in the FC Iskra Stadium camp during the relevant period also follows from the statements of the following witnesses who were examined before the Prosecutor's Office of Bosnia and Herzegovina in the course of the investigation:

and others.

Finally, even the suspects Nisvet Gasal and Musajb Kukavica themselves do not deny that they performed the abovementioned duties, which is what they stated in detail when presenting their defence.

After the end of their duties in the *Iskra* camp, that is, the end of the reassignment and membership in the ARBiH, both Nisvet Gasal and Musajb Kukavica returned to their parent unit, that is, the Bugojno PSS, which is evident from the Decision number 21-1/10-120-1028-18/94 of 18 May 1995 for Nisvet Gasal and the Decision number 21-1/10-120-1028-19/94 of 18 May 1995 for Musajb Kukavica.

It is evident from the Order of the West Operations Group Command, confidential number 05/1790-1 of 21 April 1994, who the guards in the FC Iskra Stadium camp, that is, Members of the prison security unit, were. Nisvet Gasal and Musajb Kukavica were not mentioned in the list enclosed with this Order, given that they had already returned to their duty in the Bugojno PSS

earlier. Also, the list does not contain the names of some other guards who were relieved of their duties in the prison security by the decision of the Warden.

Also, it clearly follows from all the mentioned objective and subjective evidence that the suspects Nisvet Gasal and Musajb Kukavica, performing the abovementioned duties, had actual authority and power in the FC Iskra Stadium camp.

- e) Criminal actions the suspects have been charged with
- I. Nisvet Gasal and Musajb Kukavica together
- a) Inhumanc treatment by the detention in inhumane conditions

Numerous statements of the witnesses who were examined confirm that the detainees in the FC Iskra Stadium camp were detained in inhumane conditions. All witnesses identically stated that the life conditions in the camp were unbearable, there was no water, hygienic needs were reduced to a sheet-metal barrel and cans, food was meagre, although some meals that kept detainees alive were supplied, the detainees did not have adequate clothing and footwear in the winter period, they lay on wooden pallets in small changing rooms and other premises under the stadium stands, and there was no adequate medical aid.

Describing the conditions in the camp, the witness stated that: "the conditions in the camp were unbearable, there was no water at all, hygienic needs were reduced to a sheet-metal barrel and cans, and food was meagre, although twice a day we shared a meal that kept us alive." Speaking about the accommodation conditions in the camp, the witness pointed out that conditions in the camp were unbearable, since it was terribly cold and the detainees did not have adequate clothing and footwear and they had to lie on the pallets. The prisoners were detained under the stadium stands, in the changing rooms, toilet and an ancillary room for also spoke about the conditions in the camp, stating that equipment. The witness juveniles were also detained in the camp and that the conditions in the camp were deplorable and unbearable, taking into consideration the hygienic conditions, food and health conditions. He stated that 300 to 400 hundred detainees were detained in the eamp, depending on the period, and that there was only one toilet. The witness stated that the guards Džopa and Telbiz were very strict and that they maltreated and beat the detainees without any reason and forbade the detainees from using the toilet and establishing contacts with their families. The witness confirmed this, stating that he was taken together with 24 other detainees from the forced labour in Prusac to the Iskra Stadium camp, where they found a three-meter high wire fence, while an iron door was set at the entrance. He remembered that around 300 or perhaps more detainees were placed in the changing rooms, in fairly small rooms for referees and equipment and in the part with shower cubicles. The witness stated that the conditions in the camp were unbearable, since the detainees were crammed in very small rooms, without water and electricity, while meals were extremely meagre.

The witnesses also spoke about the conditions in the camp, stating that in October 1993 they were transferred to the Iskra Stadium, where they found a real camp ambiance, since a high wire was put up around the front part of the stadium where an observation post was placed, while a heavy metal door was at the entrance. They further stated that the quantity of food in the Iskra camp was minimal, sufficient for survival, the water was very meagre, and detainees were given medical aid only in exceptional circumstances such as when detainees suffered serious injuries. They said that a nun would come to the camp and bring Caritas humanitarian aid, but this aid was also distributed in minimal quantities, since the camp guards would take most of the humanitarian aid. These witnesses also stated that they had a bath only once in eight months while in the detention. They also stated that hygienic conditions were deplorable, so that they were infested with lice; the witnesses

and many other witnesses examined also spoke about this.

They further stated that Musaib Kukavica was punishing detainees to the extent that he forbade family members and nuns from bringing additional food to the detainees in the camp. The witness particularly spoke about the conditions in the camp, stating that he was detained in a changing room in the camp, and that he became seriously ill because of the bad conditions in the camp, so he was taken to the Health Centre - Bugojno War Hospital, where he was treated all until 29 September 1993 when, on the initiative of the warden Nisvet Gasal, he was sent back to the camp and imprisoned. He stated that the ICRC registered the detainees in the camp a day before 29 September 1993. The witness was detained on 23 July 1993. In November 1993 he had a bath for the first time. He stated that he had a privilege of having a bath three times within the eight months of detention, that is, until 19 March 1993. He further stated that the conditions in the camp were beneath human dignity, there was no food, medicines, water or electricity, and hygienic conditions were so unbearable that all detainees got lice very soon. The witness about the conditions in the camp, stating that there were over 300 detainees there and that they could use only one toilet, that is, an improvised barrel, that they drank water from a hose which was outside the room, and that a large number of detainees vomited and had diarrhoea due to the bad hygienic conditions. He stated that he had a bath for the first time 114 days after he had been detained, while the witness stated that he had a bath only twice within the eight months of his detention.

The witnesses and many others also spoke about the conditions in the camp, stating that only one toilet was used in the camp, that food was distributed once a day and consisted of a kind of thick soup and 8 or 9 loaves of bread for all detainees, that they slept in a part located under the stands, right under the roof which leaked, and that the detainees slept on floors and blankets. The witness in particular stated that the conditions in the camp were unbearable and particularly difficult in November 1993, because it




was constantly raining and it was cold in the area under the stands. The witness described the life in the camp as "the twilight zone", because the conditions were beneath human dignity, all human rights were denied, hygienic conditions were not good, detainees got lice and had numerous wounds caused by work and injuries they sustained.

The witness also confirmed the foregoing allegations about the conditions in the camp, since she, as a medical worker, powdered the detainces who were infested when she was allowed to enter the FC Iskra camp compound in late 1993.

b) Inhumane treatment - by participating in taking detainees to forced labour

The numerous statements of the witnesses examined confirm that the detainees in the FC Iskra Stadium camp were treated inhumanely. These witnesses stated that on several occasions they were taken from the camp to perform forced labour all over Bugojno, where they cleaned streets, cut wood for the needs of members of the Army of RBiH and performed other various physical labour or were taken to Army of RBiH front lines held against the Republika Srpska Army and the HVO in the direction of Donji Vakuf, Gornji Vakuf/Uskoplje, and in the direction of Kupres, more specifically the places: Podripci, Sabljari, Pajić Polje, Donja Hrasnica, Gornja Hrasnica, Pirići, Duratbegović Dolac, Garačački Podovi and other places, where they dug trenches, communication trenches and dugouts, where there was a lot of shooting around and where they were also used as human shields; during the work, a certain number of detainees suffered bodily injuries, while a certain number of detainees were killed; when they were brought back to the camp, the detainees were not provided with enough adequate medical aid.

Inhumane treatment - by taking to forced labour, is confirmed by the statement of the witness who stated that it was usual ever since they were detained in this camp that detainees were taken to perform forced labour at the front lines and to be used as human shields at ARBIH lines against the HVO or against the RS Army, as well as to perform agricultural work, and even construction, utility and sanitary work in the whole Bugojno region up to Uskoplje and Donji Vakuf. He personally dug communication trenches and trenches in the direction of Uskoplje on several occasions and he also cleaned roads all over Bugojno as a cleaner, on which The witness stated that occasion fellow-citizens remarked: "How is it going, together with 5 other camp detainees, managed to run away while working on a front line. also spoke about the inhumane treatment - by being taken to forced The witness labour. He said that in the latter part of September 1993, together with a group of detainees, he was taken towards Kupres, to ARBiH lines against RS members, to perform forced labour. He stated that the guard Džopa called him out in that work group. The fact that detainees from the FC Iskra Stadium camp were taken to perform forced labour is also confirmed by the material documentation proposed in the Indictment, primarily the following: Regular Combat Report from the Command of the 307th Motorized Brigade number 02/779-90 of 24 September 1993, Request for the detainee handover number 13-1259-1 of 17 October 1993, Regular Combat Report from the Command of the 370th Mountain Brigade, strictly confidential number 02-1-37/93 of 30 November 1993, Regular Combat Report from the Command of the 370th Mountain Brigade, strictly confidential number 02-1-38/93 of 1 December 1993, and Request for the engagement of prisoners from the Bugojno Public Security Station number 19-2/01-8/94 of 11 March 1994.

c) Torture - by participating in taking detainees to the BH Bank for interrogations

The numerous statements of the witnesses examined confirm that detainees from the FC Iskra Stadium camp were taken to the BH Bank, where they were tortured. These witnesses stated that they were taken out from the camp and tortured in the BH Bank on several occasions.

d) Torture - Nisvet Gasal by failing to take necessary and reasonable measures to prevent the torture of detainees and punish the perpetrators of the torture who were subordinate to him, and Musajb Kukavica by taking part in the torture and failing to take necessary and reasonable measures to prevent the torture of detainees and punish the perpetrators of the torture who were subordinate to him.

A number of the witnesses who were examined stated that detainees from the mentioned camp were tortured. They said that guards beat and tortured them and that during night hours guards called out some detainees by their names and took them to the centre of the stadium, then put a sack on their heads and then cold-heartedly beat and thrashed some of them without any reason.

detainees were taken to the stadium centre where they were tortured, and that Musaid Kukavica
was very often present when they were being taken out to be beaten. The witness
in particular stated that other ARBiH members would also come to the camp and beat detainees
and that the most severe beatings took place when the head of the guard shift was Secie, aka Flok.
This was also confirmed by the witness who stated that some combatants would
come in late night hours and take them, the detainees, out for the beating, but he did not know who
these combatants were, since they covered detainees' heads. He stated that detainees were most

that he heard dull blows and cries from the area where detainees were tortured at night. He stated
he knew that occupants of nearby buildings complained because they could not stand that noise.
The witness stated that guards in the camp allowed other ARBiH members to enter
the camp and torture and beat detainees. The torture was taking place during night hours and they
put bags on their heads during the torture so that they could not see the perpetrators and also that
they could not cry because they did not have enough oxygen. The witness
stated that he saw beaten in the camp. The witness stated that in
December 1993 he was tortured by the guard Cefo and several other members of the Army of
RBiH in the way that he was taken out to the stadium and beaten for around one hour. He stated

He also said he heard that on one occasion Dopa beat who limped as a consequence. When he saw him the following day, he asked him what had happened with his leg and said that he had stumbled over a stair, because he did not dare to say the real truth. The witness stated that on one occasion was taken out and that he was "black and blue" from the blows when he was brought back. a) Inhumane treatment – by detention in inhumane conditions
It follows from the statements of the witnesses
and other witnesses that the conditions in the camp were
deplorable since the very establishment of the eamp and the detention of Croats in the camp.

b) Inhumane treatment - by participating in taking detainces to forced fabour

The numerous statements of the witnesses who were examined confirm that detainees in the FC Iskra Stadium camp were treated inhumanely. These witnesses stated that on several occasions they were taken from the camp to perform forced labour all over Bugojno, where they cleaned streets, cut wood for the needs of members of the Army of RBiH and performed other different physical labour, or were taken to Army of RBiH front lines against the Republika Srpska Army and the HVO in the direction of Donji Vakuf, Gornji Vakuf/Uskoplje, and in the direction of Kupres, more specifically the places: Podripci, Sabljari, Pajić Polje, Donja Hrasnica, Gornja Hrasnica, Pirići, Duratbegović Dolac, Garačački Podovi and other places where they dug trenches, communication trenches and dugouts, where fire was often opened and where they were also used as human shields; during the work, a certain number of detainees suffered bodily injuries, while a certain number of detainees were killed; when they were brought back to the camp, the detainees were not provided with enough adequate medical aid. It is clearly evident from the statements of the witnesses

The fact that many detainees suffer from the post-traumatic stress disorder (PTSD) speaks best as to the severity of the conditions of the detention at the FC Iskra Stadium camp. We prove this fact by the documentation of the relevant services, which we propose to be inspected at the main trial.

f) Blanket regulation

Article 3 of the Geneva Convention relative to the Protection of Civilian Persons in Time of War of 12 August 1949 stipulates that:

(1) Persons taking no active part in the hostilities, including members of armed forces who have laid down their arms and those placed hors de combat by detention or any other cause, shall in all circumstances be treated humanely, without any adverse distinction founded on race, colour, religion or faith, sex, birth or wealth, or any other similar criteria.

To this end, the following acts are and shall remain prohibited at any time and in any place whatsoever with respect to the above-mentioned persons:

- (a) Violence to life and person, in particular murder of all kinds, mutilation, cruel treatment and torture;
- (c) Outrages upon personal dignity, in particular humiliating and degrading treatment;

Bearing in mind that we have already described above the capacity of the victims – injured parties in this criminal case, that is, that they are persons protected by the mentioned Geneva Convention, the suspects acted contrary to the mentioned provisions of the Geneva Convention by the criminal actions charged against them in the operative part of the Indictment.


Assessing comprehensively the factual substance contained in the operative part of the Indictment, which is confirmed by both physical and subjective evidence, the only possible conclusion that can be drawn is that the acts of the suspects constitute all the essential elements of the criminal offence of War Crimes against Civilians referred to in Article 173(1)(c) and (f) of the CC BiH in conjunction with Article 180(1) and (2) and Article 29 of the CC BiH, for which this Indictment against them is filed. In accordance with the foregoing, I propose that the preliminary hearing judge of the Court of BiH confirm the Indictment.



Motion to extend custody

Given that it can be concluded on the basis of the investigation results and the evidence collected that there is grounded suspicion that Nisvet Gasal and Musajb Kukavica committed the criminal offence of War Crimes against Civilians referred to in Article 173(1)(c), (e) and (f) of the CC BiH, in conjunction with Article 180(1) and (2) and Article 29 of the CC BiH, and holding that all custody requirements which existed also at the time when the decisions to order and extend custody were issued in the course of the investigation, still exist, pursuant to Article 227(3) and Article 137(1) of the CPC BiH, I propose that the Court, in case it confirms this Indictment, extend custody of the accused Nisvet Gasal and Musajb Kukavica because of the existence of the requirements referred to in Article 132(1)(b) of the CPC BiH.

In this Indictment, the Prosecutor's Office of Bosnia and Herzegovina proposed that a large number of witnesses – detainees in the FC Iskra Stadium camp, who were examined during the investigation in the Prosecutor's Office, be heard at the main trial before the Court of Bosnia and Herzegovina. All the witnesses proposed in the Indictment should testify before the Court of Bosnia and Herzegovina without any pressure and fear of possible consequences that might arise therefrom. Most of the witnesses proposed currently live in the Bugojno Municipality territory, in the immediate vicinity of the accused and their family members. Also, as already mentioned in the motions to order and extend custody of the then suspects, according to the reports of authorized officers of the State Investigation and Protection Agency (SIPA), witnesses in this case are afraid of the problems and consequences they might have if they testify in this case. In this respect, we refer again to the Official Note of the State Investigation and Protection Agency number

in which a specific risk for potential witnesses in this case is evident.



Furthermore, it can be clearly concluded from the Witness Examination Record number that witnesses in this case are exposed to direct threats, made against both the witnesses and their families, which is confirmed by the statement of the witness the mentioned record. The witness did not want to testify in this case because of fear. Likewise, it is evident from the statement of the witness that the witness in this case is afraid. In this case, the Prosecutor's Office also proposed the examination of the witnesses to whom the Court of BiH granted certain protection measures, namely the witnesses A, B and D. The allegations of the witness A that he was both attacked and physically injured in Bugojno only because of his Croat ethnicity, and that his family was attacked and threatened several times. confirm all the foregoing. The Court can assure itself of this by inspecting the Record of the examination of the Witness A. Bearing in mind that Bugojno is a small town, we particularly point out that most of the witnesses proposed in the Indictment are so to say neighbours of Nisvet Gasal and Musajb Kukavica. These witnesses have been trying to establish a normal life after the return to their pre-war homes. We believe that the release of the accused would make them feel insecure and they would certainly be exposed to influence, which would definitely have an effect on their testimonies at the main trial in this case.

We also note that this Prosecutor's Office is conducting an investigation, related to this criminal offence, also against other co-perpetrators who are still at liberty. Taking into consideration the charges against them, we believe that the accused, if released, would certainly make contact with these co-perpetrators in order to avoid criminal responsibility, whereby they would endanger and in this way hinder the further conduct of the criminal proceedings, which has been efficient to date.

Bearing in mind all the foregoing, the Prosecutor's Office of BiH submits that the circumstances indicating that the accused, if released, would hinder the criminal proceedings by influencing witnesses and co-perpetrators, still exist. These circumstances indicate that it is justified to extend custody of the accused for the reasons referred to in Article 132(1)(b).
