

# COURT OF BOSNIA AND HERZEGOVINA - The Trial Panel in the case X-KR-06/213-

In the case against the accused Gojko Kličković, Jovan Ostojić and Mladen Drijača, for the Criminal Offence of Persecution, a Crime Against Humanity contrary to Article 172 (1)(h) of the Criminal Code of Bosnia and Herzegovina (BiH CC).

Considering that on 14 December 2007 the Prosecution filed an Indictment No. KT-RZ-100/06 against Gojko Kličković, which was confirmed by the Preliminary Hearing Judge on 19.12.2007; that on 12 March 2008 the Prosecution filed an Indictment No. KT-RZ-19/08 against Jovan Ostojić, which was confirmed by the Preliminary Hearing Judge on 13.03.2008; that on 19 March 2008 the Prosecution filed an Indictment No. KT-RZ-22/08 against Mladen Drijača, which was confirmed by the Preliminary Hearing Judge on 21.03.2008; that by decisions of the Court of BiH Nos. X-KR-06/213 of 22 April 2008 and X-KR-06/213 of 23 April 2008 the criminal proceedings against the accused Gojko Kličković, Jovan Ostojić and Mladen Drijača were joined to be continued under the single number X-KR-06/213; that on 7 April 2008 the Prosecution provided the parties with a list of 76 witnesses to testify for the Prosecution in the joint proceedings: that the Defence and the Honorable Judges have on numerous occasions invited the Prosecution to file a joint Indictment against the three accused; that after the filing of the Indictments Nos. KT-RZ-100/06 of 14 December 2007, KT-RZ-19/08 of 12 March 2008 and KT-RZ-22/08 of 19 March 2008 the Prosecution has obtained some new pieces of evidence that can serve as evidence at trial, and that the evidence gathered and presented to date has shown a factual state which is partly different from the descriptions contained in the Indicaments Nos. KT-RZ-100/06 of 14 December 2007, KT-RZ-19/08 of 12 March 2008 and KT-RZ-22/08 of 19 March 2008,

Pursuant to the rights and duties set forth by Articles 35 (2)(i) and 275 of the Criminal Procedure Code of Bosnia and Herzegovina (BiH CPC),

I hereby amend the descriptions of the acts and the legal names of the criminal offense (the operative parts), the proposals of evidence to be presented, and the lists of evidence supporting the charges in the Indictments Nos. KT-RZ-100/06 of 14 December 2007, KT-RZ-19/08 of 12 March 2008 and KT-RZ-22/08 of 19 March 2008, by replacing them with the following:

#### OPERATIVE PART

#### Because:

From the beginning of April 1992, until 31 December 1992, within a widespread or systematic attack of the SDS paramilitary formations and the Army of the so-called Serb Republic of Bosnia Herzegovina directed against the non-Serb civilian population of the so-called Autonomous Region of Krajina, knowing of the existence of such an attack, and knowing that by their actions they were taking part therein GOJKO KLIČKOVIĆ, in his capacity as of President and vice-president of the Bosanska Krupa SDS Executive Municipal Board, president of the Executive Board of the Assembly of the Serb Municipality of Bosanska Krupa, Commander of the Crisis Staff of the Serb Municipality of Bosanska Krupa, member of the SDS Secretariat of the Serb Municipality of Bosanska Krupa, President of the Assembly of the Serb Municipality of Bosanska Krupa.

Krupa, President of the Assembly of the Serb Municipality of Bosanska Krupa, President of the Assembly of the Serb Municipality of Krupa na Uni, President of the SDS Municipal Board of Krupa na Uni, as well as in his capacity as member of the Main Board of the SDS, and MLADEN DRLJAČA, in his capacity as member of the Bosanska Krupa SDS Municipal Board, member of the Executive Board of the Assembly of the Serb Municipality of Bosanska Krupa, member of the Crisis Staff of the Serb Municipality of Bosanska Krupa, member of the War Presidency of the Serb Municipality of Bosanska Krupa, President of the Panel of the Provisional Military Court of the Serb Municipality of Bosanska Krupa, President of the Commission for Exchange of Prisoners of the Serb Municipality of Bosanska Krupa and member of the SDS Secretariat of the Serb Municipality of Bosanska Krupa, knowingly participated in a Joint Criminal Enterprise, which had come into existence as of Summer 1991, together with MIROSLAV VJEŠTICA, MILE DRLJAČA a.k.a. "TEHO", MILAN ŠTRBAC a.k.a. "BIJELI", LAZAR STUPAR, DMITAR CIGANOVIĆ, MILE VOJINOVIĆ, MIRKO ORELJ and other SDS members in the so-called Serb Municipality of Bosanska Krupa sharing the plan of partitioning the legally established Municipality of Bosanska Krupa by creating, through the use of military force, the so-called Serb Municipality of Bosanska Krupa as an area populated by an absolute Serb majority, where Serbs could assert control in all areas of power and administration and, during the same time, in their above listed capacities, GOJKO KLICKOVIC and MLADEN DRLJACA knowingly participated in a Joint Criminal Enterprise, which had also come into existence as of Summer 1991, together with RADOVAN KARADŽIĆ, MOMČILO KRAJIŠNIK, VOJISLAV MAKSIMOVIC and other members of the Main Board of the SDS and other members of the SDS at the national and regional levels and of the VRS, which Joint Criminal Enterprise was also joined by JOVAN OSTOJIC who, knowing of the existence of the above mentioned widespread or systematic attack, and knowing that by his actions he was taking part therein, as of 14 July 1992, in his capacity of Commander of the 11th Krupa Light Infantry Brigade, knowingly participated therein, and which Joint Criminal Enterprise shared a plan to link Serb-populated areas in BiH together, to gain and maintain control over these areas and to create a separate Bosnian Serb state, from which most non-Serbs would be permanently removed.

GOJKO KLIČKOVIĆ, being fully aware that the execution of the plans of the above Joint Criminal Enterprises would entail either as a necessity, or as a natural and foreseeable consequence all of the crimes charged against him in this Indictment, by his acts and omissions planned, instigated, ordered, perpetrated (including by participating in and contributing to the above-described Joint Criminal Enterprises), or otherwise aided and abetted in the planning, preparation or execution of the crimes charged against him in this Indictment, or failed to take the necessary and reasonable measures to prevent or punish the commission of the crimes charged against him in this Indictment by his de jure or de facto subordinates over whom he had effective control when he knew or had reason to know that his de jure or de facto subordinates were about to commit such acts or had done so, taking a leading role in furthering the plans of the above mentioned Joint Criminal Enterprises by, Inter alla, establishing, organizing and exercising effective control over a parallel system of Serb power in the so-called Serb Municipality of Bosanska Krupa, establishing, organizing and exercising effective control over Serb Police and Territorial Defence units that took part in the implementation of the plans of the Joint Criminal Enterprises, planning, coordinating and ordering the military implementation of the partition of the Municipality and the forcible removal of the non-Serb population.

MLADEN DRLJAČA, being fully aware that the execution of the plans of the above Joint Criminal. Enterprises would entail either as a necessity, or as a natural and foreseeable consequence all of the crimes charged against him in this indictment, by his acts and omissions planned, instigated, ordered, perpetrated (including by participating in and contributing to the above-described Joint Criminal Enterprises), or otherwise aided and abetted in the planning, preparation or execution of the crimes charged against him in this indictment, thereby taking an active role in furthering the plans of the above mentioned Joint Criminal Enterprises.

JOVAN OSTOJIC, being fully aware that the execution of the plans of the above Joint Criminal Enterprise would entail either as a necessity, or as a natural and foreseeable consequence all of the crimes charged against him in this Indictment, by his acts and omissions planned, instigated, ordered, perpetrated (including by participating in and contributing to the above-described Joint Criminal Enterprise), or otherwise aided and abetted in the planning, preparation or execution of the crimes charged against him in this Indictment, or failed to take the necessary and reasonable measures to prevent or punish the commission of the crimes charged against him in this Indictment by his de jure or de facto subordinates over whom he had effective control when he knew or had reason to know that his de jure facto subordinates were about to commit such acts or had done so, thereby furthering the plan of the above mentioned Joint Criminal Enterprise.

The execution of the plans of the above mentioned Joint Criminal Enterprises resulted in the following:

1. On 21 April 1992 Serb forces under the effective control of GOJKO KLIČKOVIĆ launched an artillery and infantry attack directed against the Muslim civilian population of the towns of Bosanska Krupa and Ostružnica,




- c. From 23 April 1992 to 30 April 1992 at least 43 prisoners were brought before the so-called Provisional Military Court, where MLADEN DRLJACA acted as Presiding Judge, where they were questioned without being informed about the reasons for their detention or questioning, subjected to random accusations and then were arbitrarily remanded in detention, or in few cases released, without having been informed about the decision of the court nor of its grounds, thereby being deprived of their right to a fair and impartial trial;
- d. On or about 1 May 1992, 35 detainees, who were remanded in detention by decision of the so-called Provisional Military Court, were handed over to the Military Police and transferred to the Petar Kočić School to be detained further.

3. From about 1 May 1992, until 21 August 1992, at least seventy-nine persons, including both combatants and civilians, were detained for a protracted period of time at the Petar Kočić School receiving inadequate food and living in unhygienic conditions, namely:

- The detainees were deprived of all their personal belongings, including identity papers, money and other valuables by some of the guards, notably by ŽELJKO SMOLJANAC;

- c. Several prisoners were repeatedly severely beaten by soldiers, in particular:
- d. On or about 4 May 1992, PWS-03 was raped by ZELJKO SMOLJANAC;
- e. On 10 May 1992, 24 detainees were coercively exchanged, thereby being forcibly transferred out of the so-called Serb Municipality of Bosanska Krupa;
- f. On 22 May 1992, 16 detainees were coercively exchanged, thereby being forcibly transferred out of the so-called Serb Municipality of Bosanska Krupa;
- g. The detainees were regularly forced to perform labor, including removing corpses, digging trenches and cleaning the streets in Bosanska Krupa, being intentionally exposed to dangers to life and limb, during which:
  - i. On a day between I and 22 May 1992, were forced by a Serb soldier to pose with their brooms as if they were aiming rifles in direction of the BiH Army positions, so that the ABiH soldiers shot in the direction of the two men who were forced to stand still while bullets whistled around them having been threatened to be killed if they moved;

- ii. On another occasion between 1 and 22 May 1992 was used as a 'living target' by being forced to stand on a balcony of a house on the Hum hill, while the ABiH Army was opening fire on that location;
- iii. On or about 14 May 1992 were forced to dig a trench on the Hum hill and subsequently used as 'living targets' by being

forced to stand on a porch within sight of ABiH positions on which was fired at and wounded: iv. On one or more dates around 20 June 1992, Bosniak captives were taken to perform labor on the hill of Hum, during which was forced to sit on a cannon aimed at ABiH positions, he was fired upon and died, whilst were killed by Serb soldiers: h. On or about 24 July 1992 who had been previously beaten on numerous occasions to the point that his wounds had become infected, was beaten by PETAR SENIC, ZRADVKO NARANCIC and another guard, and died soon thereafter: i. On or about 28 July 1992 who had been previously beaten on numerous occasions, was given a poison by some guards, and died about two days thereafter: j. On a day between 1 and 12 August 1992 JOJA PLAVANJAC entered the school during the guard shift of ZDRAVKO NARANCIĆ, whereupon he killed by firearm and 2 other unidentified male Bosniak captives: k. On 21 August 1992 all of the detainees who had remained at the Peter Kočić School, 20 in number, were tied, blindfolded and brutally beaten, whereupon they were transferred to the detention camp of the 2<sup>nd</sup> Krajina Corps in Kamenica, having been further beaten during the journey, where they were detained until 3 November 1992, during which time they were further abused, and four of them died as a result of the abuses, namely: 4. On 21 July 1992, in Skucani Vakuf, members of the Military Police of the 11th Krupa Light Infantry Brigade arrested and threatened the families of with death if they would not surrender the following day whereupon, on 22 July, the latter surrendering instead of his son surrendered in Lusci Palanka and were then transported to Jasenica where they were interrogated by members of the Military Police, including: MIROSLAV STANIC, MIROSLAV EGELJIĆ, MILE DRLJAČA aka TEHO, PETAR SENIĆ, VLADO VIGNJEVIĆ, and MOMIR ORUBISA and then they were kept in Jasenica for 2 or 3 days

- 5. On 24 April 1992 the Serb soldiers who were besieging the settlement of Arapusa allowed a group of six paramilitaries to enter the settlement, knowing that they would abuse the Muslim civilian population which they did, looting various houses, beating several persons and killing a pregnant woman named
- 6. On 1 May 1992, upon a written order issued by GOJKO KLIČKOVIĆ, the Muslim civilian population of the settlements of Arapuša, Velika Jasenica, Veliki Dubovik, Zalin and Potkalinje was forcibly transferred to the Municipality of Sanski Most.
- 7. On 24 May 1992, upon a written order issued by GOJKO KLIČKOVIĆ, the remaining Muslim civilian population of the settlement of Zalug and of the town of Bosanska Krupa was forcibly transferred to Bihać.

Therefore, within a widespread or systematic attack directed against the non-Serb civilian population of the so-called Autonomous Region of Krajina, knowing of the existence of such an attack, and knowing that by their actions they were taking part therein, with the intent to discriminate against their victims on political, racial, national, ethnic, cultural, or religious grounds, and in connection with the armed conflict on the territory of Bosnia and Herzegovina:

GOJKO KLIČKOVIĆ by his acts and omissions planned, instigated, ordered, perpetrated (including by participating in and contributing to the above-described Joint Criminal Enterprises), or otherwise aided and abetted in the planning, preparation or execution of the crimes described in Counts 1, 2, 3 (except for sub-counts e and 1), 5, 6 and 7 above; GOJKO KLIČKOVIĆ is also responsible by virtue of his position as de fure or de facto superior for the crimes described in Counts 1, 2, 3 (except for sub-counts e and 1), 5, 6 and 7 above perpetrated by his de jure or de facto subordinates over whom he had effective control, when he knew or had reason to know that his de jure or de facto subordinates were about to commit such acts, or had done so, and he failed to take the necessary and reasonable measures to prevent or punish the perpetrators thereof;

MLADEN DRLJAČA by his acts and omissions planned, instigated, ordered, perpetrated (including by participating in and contributing to the above-described Joint Criminal Enterprises), or otherwise aided and abetted in the planning, preparation or execution of the crimes described in Counts 2 and 3 (except for sub-count j) above;

JOVAN OSTOJIĆ by his acts and omissions planned, instigated, ordered, perpetrated (including by participating in and contributing to the above-described Joint Criminal Enterprise), or otherwise aided and abetted in the planning, preparation or execution of the crimes described in Counts 3 (except for sub-counts b, d, e, f, g (i), g (ii), g (ii), g (iv), and any acts or parts of acts described in the introductory paragraph of count

## **EXPLANATION**

The Prosecution is hereby replacing the descriptions of the acts and the legal names of the criminal offense (the operative parts) contained in the three separate Indictments, with the joint operative part outlined above. The joint operative part features some changes with respect to the three separate ones. Most of these changes are merely stylistic and bear no impact on the substance of the allegations; a few changes, however, constitute substantive amendments. The Prosecution submits that none of the amendments contain any new or more severe allegations against any of the accused, therefore they do not require confirmation. The amendments are as follows:

- In all cases when witnesses have either been assigned pseudonyms after the filing of the Indictments, or where the pseudonyms have been changed, they have now been referred by the latest pseudonyms.
- In the introductory paragraph, amongst the various positions held by Gojko Kličković, that of "Member of the SDS Secretariat of the Serb Municipality of Bosanska Krupa" has been added. Amongst the positions held by Mladen Drijača,

that of "President of the Panel of the Provisional Military Court" has been added. The nicknames of Milan Strbac and Mile Drijača have been added next to their names.

- Count 1 is based on, and replaces Count 1 in the Indictment against Gojko Kličković. The words "on areas predominantly populated by civilians" have been replaced, with the words "directed against the civilian population" in order to clarify the allegation. The reference to the absence of legitimate military target has been deteted because it is neither correct nor necessary. Any reference to the attack on Bosanska Otoka has been removed, and the part of the charge in that respect has been abandoned. The description of the duration of the attack on Bosanska Krupa and Ostružnica has been changed from "few days" into "several days". The number of persons killed as result of the attack has been reduced from 28 to 17, and their names have been listed. The number of persons wounded as result of the attack has been reduced from 46 to 14 and their names have been listed. The names of the three persons who were murdered in the course of the attack have been specified.
- Count 2 replaces Count 2 in the Indictment against Gojko Kličković and Count 1 in the Indictment against Mladen Drijača. The description is based on the one contained in the Indictment against Mladen Drijača, it being the most recent. The nationality of the victims has been changed from "muslims" to "non-Serbs" considering that at least one victim was of Croat nationality.
- Count 3 replaces Count 3 in the Indictment against Gojko Kličković, Count 2 in the Indictment against Mladen Drijača and Count 1 in the Indictment against Jovan Ostojić. The description is based on the one contained in the Indictment against Mladen Drijača, it being the most recent, except for sub-Count (j), which is based on the Indictment against Jovan Ostojić. Any refence to the status of the perpetrators as subordinate to Jovan Ostojić has been deleted from the factual description of the crimes. These deletions are merely stylistic, thus have no substantive effect on any crime alleged against Jovan Ostojić on the basis of his responsibility as a superior. In sub-Count (b), the names of the twelve captives have been listed. In the introductory part to sub-Count (g) the words "as follows" have been replaced with "during which", in order to evade any possible doubt that the incidents that listed in sub-Counts (g)(i) to (g)(iv) are only examples of the incidents occurred during during forcing labor, and not an exhaustive list thereof. Any other instance of forced labour under dangerous conditions is included in the formulation of the introductory part to sub-Count (g). In sub-Counts (g)(i) and (g)(ii) the initial date of the interval during which the incident may have occurred has been changed from 4 May to 1 May. In sub-Counts (g)(ii) and (g)(iii) the location where the incident has occurred has been more accurately described. In sub-Count (a)(iii) the cause of wounding of has been specified. In sub-Count (g)(iv) the dates of the incident have been better confined in accordance with recently discovered evidence. This incident is no longer charged

against Jovan Ostojić since it has been established that it happened before the beginning of his tenure as Brigade Commander. In sub-Count (h) the words "a few minutes" have been changed with the word "soon". In sub-Count (j) the date interval during which the incident may have occurred has been changed in accordance with recently discovered evidence. In sub-Count (k) the number of victims has been confined to four, and it has been specified that they died in consequence of the abuses.

- Count 4 is based on, and replaces, Count 2 in the indictment against Jovan Ostojić. Any referce to the status of the perpetrators as subordinate to Jovan Ostojić has been deleted from the factual description of the crimes. These deletions are merely stylistic, thus have no substantive effect on any crime alleged against Jovan Ostojić on the basis of his responisbility as a superior.
- Count 5 replaces, without any alterations, Count 4 in the indictment against Gojko Kličković.
- Count 6 replaces, without any alterations, Count 5 in the Indictment against Gojko Kličković.
- Count 7 replaces, without any alterations, Count 6 in the Indictment against Gojko Kličković.
- The closing paragraph is based upon, and replaces, the closing paragraphs of the three separate indictments. Due to stilistic constraints, the reiteration of the full description of the elements of the Joint Criminal Enterprises has been omitted. Such omission bears no substantive effect on the allegations against any of the accused. The individual Counts, sub-Counts or parts thereof charged against each of the accused have been enumerated in the closing paragraph. The legal names of the criminal offences have remained unchanged, except insofar as the charges they relate to feature under a different count number.

The Prosecution is also replacing the list of persons to be heard as witnesses contained in the three separate Indictments, with the joint list of persons to be heard as witnesses outlined above. The list features 73 out of the 76 witnesses enumerated in the list provided to the parties on 7 April 2008. The reduction reflects the fact that the Prosecution has decided not to compel the attendance of three witnesses who have failed to respond to the summons of the Court, namely:

The Prosecution is also replacing the proposal of evidence to be presented contained in the three separate indictments, with the joint proposal of evidence to be presented, outlined above. The joint proposal of evidence to be presented has been expanded and

updated as follows:

- It includes all of the pieces of material evidence listed in the three Indictments, with the exception of some which the Prosecution no longer considers relevant to its case;
- It further includes a number of pieces of evidence which the Prosecution has either received, or assessed as relevant, after the filing of the separate Indictments.

The list of evidence supporting the charges in the Indictment has been updated in accordance with the changes made to the list of persons to be heard as witnesses and to the proposal of evidence to be presented.

Any part of the Indictments Nos. KT-RZ-100/06 of 14 December 2007, KT-RZ-19/08 of 12 March 2008 and KT-RZ-22/08 of 19 March 2008 which is not expressly replaced by these amendments, nor superseded otherwise, remains in force.
