Pursuant to Article 35(2)(h) and Article 226(1) of the Criminal Procedure Code of Bosnia and Herzegovina, I hereby file the following

INDICTMENT

Against:

Damir Lipovae, son of Ante and Veronika, née Karačić, born on 5 October 1970 in Derventa, permanent residence in Slavonski Brod, at 5a Rozinka Street, Republic of Croatia, working and residing in The Netherlands, Spikenisse, Offenbach Straat 6, 3208 BH, electrical mechanic by occupation, completed military service, married, father of three minor children, Croat, citizen of Bosnia and Herzegovina and the Republic of Croatia, holder of the identity card number 102297565 issued in the Republic of Croatia, eurrently at large

due to grounded suspicion that:

in June 1992, during the armed conflicts in Bosnia and Herzegovina, in the territory of the Derventa Municipality, as a member of the 103rd Brigade of the Derventa Croat Defense Council and as the commander of the camp which was established on the premises of the primary school in Poljari, he acted in contravention of Article 3 of the Geneva Convention relative to the Protection of Civilian Persons in Time of War dated 12 August 1949, by participating in severe deprivations of liberty, murders, tortures, different forms of physical and mental abuse and the pillaging of Serb civilians who were unlawfully detained in this camp, in the manner that:

1. on an unspecified date, in early June 1992, he entered the camp premises where he hit the detainee security several times, unjustifiably accusing him of trying to escape, after which he took this detainee out in front of the camp and fired at him from an automatic rifle, thus depriving him of his life; immediately after that he took all the detainees out of the camp premises

- 2. in June 1992, he treated the detained civilians in an inhumane manner, forcing them to sing "Ustasha's" songs, cursing and insulting them on an ethnic basis, and on several occasions he took out of the camp premises several detainees and questioned them, physically abusing them in a brutal manner and insulting them, including:
 - detainee whom he beat with a bat and a rifle butt, punched and kicked him and put out cigarettes on his body;
 - detainee when whom he beat with a chair, inflicting on him a severe bodily injury in the form of a fracture to his left arm, burned his body with a red-hot wire, and kicked his mouth with his military boots on, thus knocking out his front teeth;
- 3. on an unspecified date in June 1992, he entered the camp premises where the detainees were held, and robbed them of their belongings by placing a blanket in the middle of the room and ordering all detainees to put on the blanket the money, gold, watches and other valuables they had on them, which they did, after which he unlawfully took these items,


Whereby he committed the criminal offense of War Crimes against Civilians in violation of Article 173(1)(e),(e) and (f) of the Criminal Procedure Code of BiH as read with Article 180(1) of the BiH CC.



RESULTS OF THE INVESTIGATION

The result of the conducted investigation undoubtedly confirms the grounds for the Indictment, that is, that the suspect Damir Lipovae committed the criminal offense of War Crimes against Civilians in violation of Article 173 (1)(c), (e) and (f) of the Criminal Code of BiH as read with Article 180(1) of the BiH CC.

number X-KRN 05/104 dated 17 October 2005 taking over the case which was previously delivered to the Rules of the Road Unit of the ICTY Office of the Prosecutor for review and assessment, which is when the acts of the suspect Damir Lipovac were marked with the standard marking A under the number: 036458/GB/RR1037 dated 29 July 2003.

It follows from the state of facts established during the investigation, which is based both on objective evidence and the testimonies of the examined witnesses, that during the conflict in BiH, the suspect, as a member of the 103rd Brigade of the Derventa Croat Defense Council and the commander of the *Poljari* camp, acted in contravention of



Article 3 of the IV Geneva Convention relative to the Protection of Civilian Persons in Time of War dated 12 August 1949 by depriving two prisoners of their lives, intentionally inflicting severe bodily pains and sufferings to the unlawfully detained civilians, while robbing them of their belongings.

The criminal acts the suspect Damir Lipovac has been charged with by this Indictment were committed at the time of the armed conflict. The existence of such conflict in the territory of BiH, and subsequently in the territory of Derventa, undoubtedly follows from the Decision on the Proclamation of Imminent War Threat by the Presidency of the Republic of BiH dated 8 April 1992 (Official Gazette Of R BiH no.1/92) and the Decision on Proclamation of a State of War by the Presidency of the Republic of BiH dated 20 June 1992 (Official Gazette of R BiH no.7/92) as well the testimonies of examined witnesses.

All criminal acts the accused has been charged with constitute severe violations of the Geneva Convention relative to the Protection of Civilian Persons in Time of War dated 12 August 1949 and are a consequence of the armed conflict.

The suspect's membership in the 103rd Brigade of the Derventa Croat Defense Council ensues from the Letter of the Federal Ministry for Issues of Veterans and Disabled Veterans of the Defensive-Liberation War number: 07-03-15/08 dated 28 April 2008 and the attached documents — unit and personal identification file in the name of the suspect Damir Lipovac, while the testimonies of the examined witnesses

indicate that in June 1992 the suspect performed the duty of the commander of the Poljari camp.

All victims mentioned in the Indictment were civilians who were at the time relevant to the Indictment persons protected by the mentioned Geneva Convention.

In their testimonies all witnesses confirm that they, as civilians, were unlawfully arrested and then unlawfully detained, describing when and in what manner they were arrested and then detained in the *Poljari* camp near Derventa, although they were never issued with any decisions on arrest or detention, nor were any proceedings conducted against them.

In their testimonies, the witnesses clearly, explicitly and consistently described the circumstances of their detention in the camp, as well as the circumstances under which they were exposed to murders, tortures, intentional infliction of severe bodily and mental pains and sufferings as well as the looting of belongings, particularly describing the acts committed by the suspect Damir Lipovac.


Through the institute of international legal assistance the suspect Damir Lipovac was examined by the investigative Judge of the Cantonal Court in Slavonski Brod, with the presence of his Defense Counsel Zoran Mataić, attorney from Slavonski Brod, whereby he used his legal right to conduct his defense by silence.

However, it undoubtedly follows from the collected evidence that the suspect was aware of his acts and wanted the perpetration thereof. The suspect Damir Lipovac, as a member of an armed formation, and particularly as the camp commander, must have known and must have been aware that the civilians were unlawfully detained in the camp since none of those civilians was arrested on legal grounds nor were any proceedings conducted against them, but they were arrested exclusively for their ethnicity. He was also aware that any kind of abuse, especially the deprivation of life of any person, particularly of the detainees in the conditions of imminent war threat and the state of war — constituted a crime and yet he willingly committed the criminal acts as charged by the Indictment.

Based on the foregoing we hold that there are sufficient reasons in support of grounded suspicion that the suspect Damir Lipovac committed the criminal offense as charged by this Indictment, and we therefore propose that the Preliminary Hearing Judge confirm this Indictment in its entirety.

TO ORDER CUSTODY AFTER THE CONFIRMATION OF THE INDICTMENT

Based on the foregoing evidence, the Prosecution holds that grounded suspicion that the suspect Damir Lipovac committed the criminal offense as charged ensues from these pieces of evidence, whereby the general requirement for ordering custody, stipulated under Article 132 (1) of the BiH CPC has been met.

When it comes to particular requirements for ordering custody, the Prosecutor's Office of BiH submits that the requirement under Article 132(1)(a) of the BiH CPC has been satisfied, that is, that the suspect is hiding from the prosecution authorities of Bosnia and Herzegovina and is on the run with the purpose of avoiding the criminal prosecution and liabilities before the competent authorities of BiH.

During the investigation against the suspect Damir Lipovae, the Prosecutor's Office of BiH established that the suspect is a citizen of Bosnia and Herzegovina and that in 1992 he had a permanent residence in the territory of the Derventa Municipality, in the place Polje, number 75. However, after the perpetration of the criminal offense he has been charged with, he left the territory of BiH and took a permanent residence in the Republic of Croatia where he obtained the citizenship of that country. It has been established that the suspect holds the identity card number 102297565 issued in the Republic of Croatia and that he has a registered permanent residence in Slavonski Brod at 5a Rozinka Street.

It further follows from the Record on the suspect examination of the Cantonal Court in Slavonski Brod number Kri – 468/07 – 7 dated 9 January 2008 that the suspect has a registered permanent residence in the Republic of Croatia, but that he has been living and working in the Kingdom of Holland at the address Spikenisse, Offenbach Streat no. 6, 3208 BH, since 1994.

The Prosecutor's Office of BiH then undertook legal measures in order to secure the presence of the suspect in the criminal proceedings, by sending summonses to the suspect Damir Lipovac for his examination in the investigation on 10 July 2008, both to the address in the Republic of Croatia and the address in the Kingdom of Holland.

Through the BiH Ministry of Justice we received the following responses:

- Response by the competent authorities of the Republic Creatia, from which it
 follows that the summons was not served on the suspect Damir Lipovac because
 he was not found at the given address, which can be seen from the return slip
 containing a postman's remark that the recipient moved abroad and that no one
 was found at that address.
- Response by the competent authorities of the Kingdom of Holland, from which it follows that the summons was served on the suspect Damir Lipovac himself, on 8 July 2008, which the mentioned person confirmed by his own signature.

Based on the foregoing, it ensues that the suspect Damir Lipovac has been duly served with the summons for the examination in the investigation and that he did not respond to that summons nor did he justify his absence in any manner. It is therefore the company of the company

obvious that the suspect is hiding from the prosecution authorities of Bosnia and Herzegovina by staying in foreign countries, and that he is already at large considering that he was informed of the grounds for suspicion against him when he was examined by the Investigative Judge of the Slavonski Brod Cantonal Court on 9 January 2008.

We believe that in the particular case no other more lenient measure for securing the presence of the suspect in the criminal proceedings, stipulated by the law, such as apprehension, house arrest or bail can be applied, considering that all the foregoing indicates that in order to evade criminal prosecution the suspect Damir Lipovac is staying in the territory of foreign countries over which the Court of BiH has no jurisdiction, and thus the ordering of such measures would have no purpose whatsoever.

For that reason, it is obvious that in the particular case the following other legally prescribed possibilities for securing the presence of the suspect in the criminal proceedings must be used:

- The issuance of an international arrest warrant, which is, pursuant to Article 443 of the BiH CPC, possible only if an order for apprehension or a decision on ordering custody of the suspect has been issued;

- Filing requests for extradition, which is, pursuant to Article 428 of the BiH CPC, possible only if the suspect is indicted or convicted or if a decision on the detention of the suspect exists (Article 416(3)(c) of the BiH CPC).

Based on the foregoing, we submit that the legally prescribed requirements for ordering the suspect into custody, set forth in Article 132(i)(a) of the BiH CPC, have been satisfied, and we therefore propose that the Court grant this Motion and render the Decision on ordering the suspect Damir Lipovac into custody.

Should the Court after the confirmation of the Indictment grant this Motion and order the suspect Damir Lipovac into custody pursuant to Article 132(1)(a) of the BiH CPC, we propose that the Order on the issuance of an arrest warrant for the suspect Damir Lipovac be issued, pursuant to Article 443 of the BiH CPC:




