I can't remember if it was put out in the operation order, but once we were in the village, we were also instructed to burn the village. We were CA'd into the village by chopper and I was on the first lift. As the first lift landed, we set up a perimeter around the LZ and awaited the arrival of the other lifts. When the whole company was on the LZ, we were went into the village on a line. The LZ was on the left or west side of the village and we drove thru to the east side of the village. I was in the second platoon on the left or north side of the line and the 1st platoon had the right flank or south side of the village. The 3d platoon
