- 2. I am an investigator with the James Mintz Group ("JMG"), an investigative firm of more than thirty experienced investigators, including former investigative reporters, federal investigators and prosecutors, with offices in New York, Washington, D.C., Miami, Chicago, San Francisco and London. JMG is involved in a broad range of fact-gathering assignments, including assisting attorneys and their clients in connection with litigation. I joined the Mintz Group in 1998 and co-manage the firm's litigationsupport practice.
- 3. JMG has assisted plaintiff's counsel in the investigation of this case involving the assassination of Archbishop Romero. Among the assistance we have provided is to conduct searches for information relating to the defendant, Alvaro Rafael Saravia, also known as Alvaro Rafael Saravia Merino.
- 4. Counsel has advised me that information obtained from a criminal complaint filed against Mr. Saravia in Miami, Florida in 1987 indicates that his date of birth is February 16, 1946. Using that date of birth and Mr. Saravia's name, we conducted a search of a ChoicePoint Public Records, Inc. subscription database. The report we obtained from the search indicated that an Alvaro Saravia with the same date of birth – February 16, 1946 -- has a last known address of 2401 Manor Oak Drive, Modesto, CA, 95355. According to the report, this Mr. Saravia also had previous addresses in Florida dating from sometime between 1986 and 1988. The report indicated that the Mr. Saravia residing in California has a Social Security number issued in Florida. Phone listings and other information also are provided. Attached hereto as Exhibit A is a true and correct copy of the ChoicePoint report relating to Alvaro Saravia.
- 5. Through other investigators we have engaged, we have also conducted interviews of Mr. Saravia's children and a former friend named Julio Villatoro, all of whom live in South Florida. The field investigator that did the interviews reported to me that Mr. Saravia's son said that he, his sister and their mother had not had any contact with Mr. Saravia for many years. The friend, Julio Villatoro, said Mr. Saravia had moved to California more than 8 years earlier and had established himself in

California. Mr. Villatoro also said that Mr. Saravia was part of a car dealership in California. I declare under penalty of perjury under the laws of the United States of America that the foregoing is true and correct. Executed on this 1st day of September 2004, in New York, New York.
