# Foreword

It describes our contribution to academia, students, practitioners, policy makers, the legal community and others active in the broad field of international law.

This last year has been a tumultuous one globally. The knock on effect of the banking crisis and resultant recession provided the backdrop for our endeavours. 2010 was both a challenging and rewarding time. In keeping with our strategy and with a keen eye on developments in our operating environment, we have initiated and responded to changes impacting on our activities. As an organisation, we continued to maintain the highest possible levels of research, consultancy and training support for our many clients and stakeholders.

At the start of the year we set ourselves some clear objectives. We are pleased to report that we have been successful in streamlining our research department into an efficient and cohesive unit with a new Head of Research. Priority has been given to putting in place the mechanisms to operate balanced and flexible inter-university research programmes resulting in measurable success. CLEER has been awarded a second grant by the European Commission under its Jean Monnet Lifelong Learning Programme to support its activities and the IHL/ICL and the International Sports Law interuniversity research programmes were formalised, ready for launch.

New appointments to bolster our research capacity and output have been achieved and whilst we bade farewell to some long standing colleagues through retirement, we are confident that we will commence the year 2011 with a capable and energetic workforce.

We are proud to have within our midst, two new Chairs, through the appointment of Robert Siekmann as Professor of International and European Sports Law at the Erasmus University, Rotterdam and Steven Blockmans, as Special Visiting Professor at the University of Leuven, Belgium.

We continued to contribute to international capacity building, working with local and global partners to support Rule of Law. We demonstrated our efficiency and expertise in delivering top quality seminars and conferences and we are proud to be awarded no less than three KNAW grants to ensure their delivery.

Our excellent publications, training courses, public dialogues, and invitation-only gatherings on a range of topics have contributed to building the expertise of the wider legal community. 2010 Education and Training highlights included the provision of judicial training in The Hague as well as in South Sudan, Serbia and Croatia.

As well as delivering on legal research and dissemination, a number of important strategic issues were advanced.

We forged new relationships and were instrumental in the establishment of contemporary initiatives such as the founding of the International Centre for Counter-Terrorism in The Hague with our fellow institutes – the Netherlands Institute of International Relations Clingendael and the Centre for Terrorism and Counterterrorism, Leiden University.

We negotiated an exciting new distribution deal for our T.M.C. Asser Press book programme with Springer Verlag.

Work was completed on the renovation of the Institute's library wing to provide contemporary conference facilities and training space for the Institute.

Having invested much time in contributing, with our (Hague Academic Coalition) partners in The Hague, to delineating the framework for the establishment of the Hague Institute for Global Justice, we are excited to see that this new organization will be launched in 2011.

We believe that the T.M.C. Asser Instituut is successful through the good will and personal contributions made by its members. Asser's team of professionals is knowledgeable and flexible in its approach. Ready for a challenge, quick with devising a solution and steadfast in ensuring that promises are delivered.

Rest to say, as this report demonstrates, we have had a successful year, a year filled with challenge, opportunity, and accomplishment. We would like to express our appreciation to the many other organisations that have collaborated with and supported us in 2010.

We have delivered training and advice, workshops and events to partners and participants in Europe, Asia, Africa the Middle East and the USA. We have welcomed to our many events in The Hague, international participants from the widest 'corners of the world'.



Our international network has, as a result, increased in size, as has our global impact.

# Highlights of Activities in 2010

### Research / Inter-University Knowledge Development

#### Inter-university research programmes

In 2010 The T.M.C. Asser Instituut continued to maximise its qualities by building forth on and continuing to improve and strengthen its inter-university research programmes which constitute the basis of Asser's research activities.

### Law of the European Union (with a focus on the external dimension thereof)



The Centre for the Law of EU External Relations (CLEER) is firmly established and is going from strength to strength.

### 2010 Highlights include:

The CLEER hosted a conference on the implementation of the external dimension of the Stockholm Programme, the EU's new multi-annual programme in the Area of Freedom, Security and Justice (5 February, 2010) with the keynote speech delivered by Dr. E.M.H. Ballin (then Dutch Minister of Justice). Four other conferences were organised by CLEER during 2010.

CLEER's working papers series was expanded with 7 new issues.

The first book carrying the CLEER label was published in cooperation with the Leuven Centre for Global Governance Studies.

The innovative 'CLEER Legal Brief on The Lisbon Treaty stipulations on Development Cooperation and the Council Decision of 25 March 2010 (Draft) establishing the organisation and functioning of the European External Action Service' was published (May, 2010).

CLEER was awarded a second grant by the European Commission (DG Education and Culture), under its Jean Monnet Lifelong Learning programme.



First visiting fellows: Dr. lavor Rangelov (Centre for the Study of Global Governance, LSE) and Nicole Betz (Research Fellow at the Max Planck Institute, Heidelberg) were welcomed to CLEER.

CLEER launched its News Service – a weekly comprehensive overview of official events and documents, as well as publications and conferences in the area of EU external relations.

### **Private International Law**

### 2010 Highlights include:

**CEPIL** The Centre for European Private International Law (CEPIL) saw its official launch in April 2010 during a one day conference. With the arrival of a new Coordinator for CEPIL – recruited with the assistance of Prof. Mr. H. ten Wolde, University of Groningen – in the last quarter of 2010, the cooperation was strengthened. Further appointments contribute to all involved having high hopes that this inter-university cooperation will be consolidated in the first quarter of 2011, with a view to realising the first academic output, in terms of publications, events and tenders, in the second half of 2011. The envisaged partners in this Centre are Groningen University, Maastricht University and possibly also Erasmus University Rotterdam.

In Close cooperation with the Dutch universities and Ars Aequi, the (9<sup>th</sup> edition of the student reader: "Internationaal privaatrecht – Rechtspraak" was prepared and will be published in January 2011.

### **Public International Law**

The T.M.C. Asser Instituut's long-standing research tradition in Public International Law combined with its location in The Hague ('City of Justice, Peace and Security' and host to a number of judicial institutions such as the ICJ, ICTY, ICTR and the ICC) makes it an ideal contributor and coordinator to offer law faculties a platform for inter-university research. It provides a natural interface with judicial practice, especially in the fields of International Humanitarian Law and International Criminal Law.

### 2010 Highlights include:

The signing of a **Memorandum of Understanding** on cooperation in the fields of IHL and ICL with the Amsterdam Centre of International Law (ACIL) of the University of Amsterdam, Leiden University and the Vrije Universiteit. Indirectly, Utrecht University, through Prof. Dr. T.D. Gill, is also represented in this research network.



**The first research themes** have been determined as IHL/ICL and media and IHL/ICL and business. For the first research theme, cooperation with the Centre for Holocaust and Genocide Studies was sought.

### Launch of new inter-university research programme

Preparations during 2010 and the concerted efforts of the UVA (Terry Gill), The VU (Elies van Sliedrecht) and Leiden University (Carsten Stahn) with Programme Coordinator Joe Powderly (Asser) paved the way for convening a cross-disciplinary expert conference "On the Front Line of Accountability – War Reporting and Related Contemporary Issues in International Humanitarian and Criminal Law", including journalists, which served as a launching event on 21 January 2011.

### KNAW award received

The Royal Netherlands Academy for Sciences (KNAW) has awarded a grant towards the organization of this launch conference.



### International Sports Law



The ASSER International Sports Law Centre provides high quality research, services and products to the sporting world at large (sports ministries, international and intergovernmental organisations, sports associations and federations, the professional sports industry, etc.) on both a national and an international basis. The Centre has a worldwide

network of academics and practitioners and cooperation agreements with various sports law institutes and centres in Europe and beyond, including Asia, South Africa and North and South America. Whereas in previous years, much attention was paid to EU-supported advice and assistance to the new EU Member States and candidate countries in Eastern Europe, in 2010 the Centre focused on cooperation with the rapidly "sports law" developing Asian region (in particular, China, India, and Indonesia).

### 2010 Highlights include:

Start of new **Hague International Sports Law Academy** (HISLA) the purpose of which is the organisation of academic conferences and workshops of international excellence which will be held in various parts of the world.

The establishment of the "Stichting Internationaal en Europees sportrecht" during the summer of 2010 and the subsequent appointment of Robert Siekmann as Professor at the Erasmus University Rotterdam. With a four-year subsidy from the municipalities of both The Hague and Rotterdam, the Stichting and Erasmus University have created a sponsored PhD position in the area of research.

Preparations made for the establishment, in the first half of 2011, of **inter-university research cooperation** with:

Erasmus University Rotterdam (Prof. Dr. R. Siekmann), University of Amsterdam (Mr.

R. Branco-Martins), Tilburg University and University of Leuven (Prof. Dr. Frank Hendrickx, Dr. Steven Jellinghaus), Free University Amsterdam (Dr. M. Olfers), Leiden University (Prof. Dr. S. van den Bogaert, also visiting Prof. at Free University Brussels), University of Leuven (Prof. Dr. R. Blanpain).

Two double issues of The International Sports Law Journal (ISLJ) were published in 2010 (spring and autumn).




### Research Output – Publications 2010



### **Associate Researchers**

### Asser Visiting Researchers Programme

Under the Asser Visiting Researchers Programme the T.M.C. Asser Instituut continuously hosts foreign scholars and visiting fellows for varied periods of time, providing all the facilities and services necessary, including academic counsel. Under special arrangements, scholars benefit from access to libraries and services of international organizations located in the vicinity of the Institute. The most prominent example is the world-renowned library of the Peace Palace.

### **Applied Research and Consultancy**

The T.M.C. Asser Instituut has a long tradition of serving the legal community in the Netherlands and abroad. The Institute's academic standing makes consultancy a natural extension of its research work. 2010 has been no exception. In addition to providing expert advice to Dutch and international law firms, courts, businesses and enterprises, we also advised national and international governmental and non-governmental organisations, including ministries, the European Union, Council of Europe and the United Nations. The vast experience and wide network of our team of legal experts enables them to provide fast and accurate answers to both simple and complex legal issues.

In many instances, Asser research staff has joined forces with combinations of external parties, working together to make significant contributions to a wide ranging clientele, in the Netherlands, in Europe and further afield.

### Examples of new (research) projects launched in 2010 include:

The updating of the **Handbook Implementation European Environmental Policy** (2010) together with the Institute for Environmental Studies, Amsterdam.

The strengthening of the rule of law to promote sound functioning of the **Judiciary in Macedonia**, by raising professional qualification of Judges and prosecutors and other legal judicial personnel.

Research into **the future of the second pillar of the Common Agricultural Policy** together with the LEI Wageningen, where the possibilities of a different legal form for the Common Agricultural Policy were explored.

A study on **the equal treatment of non-nationals in individual sports competitions**, consisting of an analysis on the issue of access to sports competitions, specifically individual competitions, by non-nationals, together with exhaustive knowledge of the discriminatory provisions adopted by sports federations in the Member states vis-à-vis Community nationals, while recognizing the extreme complexity of these issues.

Research into issues regarding the International Civil Aviation Organisation (ICAO) rules on behalf of The Dutch Ministry of Housing, Spatial Planning and the Environment (formally VROM, now the Ministry of Infrastructure and the Environment), addressing questions which are relevant for the airport spatial planning decision (LIB) Schiphol.

A study on the **Lisbon Treaty and EU Sports Policy** where the principle objective was to provide a panorama of the possibilities of EU Sports Policy, in particular to assess, from a legal point of view, the potential of the Lisbon Treaty to enable the EU to attain the objectives of greater fairness and openness in sporting competitions and greater protection of the moral and physical integrity of sports practitioners whilst taking account of the specific nature of sport.

Research into the systems of measures and sanctions – **Driving License Sanction Policy** – regarding the driving license in several European countries on behalf of the Dutch Ministry of Transport and Water Management.

**Social Dialogue in Professional Basketball** with the purpose of ensuring that stakeholders, focused on employers, become conscious of their ability to contribute to shaping employment relations / working conditions in an active and participatory way and to raise awareness of developments and good practices in adjoining sectors.

**Evaluation Dutch 'Rule of Law' Balkan policy 2004 – 2008 f**or the independent Evaluation Department of the Dutch Ministry of Foreign Affairs.

Identifying and assessing national competition rules and/or other rules that diverge significantly from Article 102 TFEU, for the College of Europe, such that that firms

engaging in cross-border trade may face differing treatments in different Member States.

**Technical assistance related to the precautionary principle in chemicals regulations** with Milieu Ltd.

### Academic Community Organiser

During the course of 2010, The T.M.C. Asser Instituut provided a full programme of events designed to enhance the knowledge and networks of the community it serves in The Hague, The Netherlands and beyond. These events have been responsible for bringing together various communities (leading legal scholars, faculties, students, policy makers, practitioners and other professionals) and delivering rich content to these specific interest groups on-time and to specification, whilst providing participants with the opportunity to convene, share, discuss and explore current and new knowledge and developments relevant to their specific interest areas.

Our Events Department staff worked efficiently and effectively to provide the planning, logistics and services to enhance the ideas and proposals of Asser academic staff and its network and deliver professional, innovative and topical events to the broader legal profession, the general public and other organisations.

In 2010, we conceived and delivered some **70 Lecture, Conferences, Seminars and Round Tables** to more than 2,000 registered attendees, often in partnership with other organisations.

Winning Team 2010 University of Amsterdam

The 33<sup>rd</sup> Dutch National Round of the **Philip C. Jessup International law Moot Court Competition** (6 February, 2010) which saw five teams pitch their best efforts in an exciting final. The winning team was from the University of Amsterdam. Team coaches were Mr. J. Temperman and Mr. C. Ahlborn. This Moot court was made possible by the financial contributions received from the Municipality of the Hague, Province Zuid-Holland, M.A.O.C. Gravin van Bylandt Stichting, Röling Foundation, T.M.C. Asser Press, BarentsKrans and Brill | Martinus Nijhoff Publishers. The **3rd Hague Prize Colloquium on Fundamental Principles of Law** (3 December, 2010) in partnership with the Hague Institution for the Internationalisation of the Law (HiiL). The colloquium was held in honour of Dame Rosalyn Higgins, the recipient of the 2009 Hague Prize for International Law. The topic was *"Temporal Issues in International Law"*. The event was sponsored by HiiL, The City of The Hague, The Dutch ministry of Foreign Affairs, The Dutch ministry of Justice, and the Royal Dutch Academy of Sciences (KNAW).

The ongoing success of the weekly **Supranational Criminal Law Lecture Series (SCL)**. Together with the Grotius Centre (Leiden University Campus Den Haag) and the Coalition for the International Criminal Court (CICC), the Section of International Humanitarian Law and International Criminal Law of the T.M.C. Asser Instituut organises the weekly Supranational Criminal Law Lecture Series which spotlights aspects of

international criminal law of current interest. The series runs for three seasons each year (Autumn, Winter and Spring). A full season's lectures are held, alternatively, at either the TMC Asser Institute or the Grotius Centre in The Hague.

The spring 2010 series started with a lecture on 'Policies and prosecutorial strategy of the Office of the Prosecutor of the ICC" by Mr. Luis Moreno Ocampo, Prosecutor at the International Criminal Court.

On 13 October, 2010, the special guest speaker was Ambassador Christian Wenaweser, President of the Assembly of State Parties of the ICC.

The Asser Round Table on the EU area of Freedom, Security and Justice in the wider world: Implementing the external dimension of The Stockholm Programme (5 February, 2010) drew some 60 participants. The keynote speech, delivered by the Dutch Minister of Justice Dr. Hirsch Ballin, was preceded by an introductory speech delivered by the Director General of the Ministry of justice, Dr. Rob Visser.

The event was financed with a subsidy from the Jean Monnet Fund and Dutch Ministry of Justice.

### Lecture Series: 'Europa in het dagelijks leven' ['Europe day-to-day'].

During the course of this Europafonds sponsored project, Asser researchers delivered a total of 24 lectures to the general public in libraries and town halls in 12 Dutch cities. Commissioned by the Dutch Ministry of Foreign Affairs the objective of this project was to inform the Dutch citizens of the role the European Union plays in terms of policy and decision-making and its impact on their day to day lives, and to ensure that citizens base their opinions on independent facts and sound knowledge of the European Union.

Furthermore, Staff of the T.M.C. Asser Instituut, contributed to the International Law Association's bi-annual conference " *De Iure Humani*-

*tatis Peace, Justice and International Law",* hosted by the NVIR in the Hague (15 – 20 August, 2010) and chaired a Water panel session entitled 'The Millennium Development Goals and Fresh Water Shortage: exploring pathways to solutions'.

### Hague Initiative for Law and Armed Conflict Lecture Series

The Forum is designed as a meeting place and platform to explore topics of current and fundamental interest, develop research proposals and projects, such as joint publications, conferences and symposia, and provide a framework for peer review of ongoing and completed research papers and draft publications.

### **International Crimes Database**

With the continued support of "het College van Procureurs Generaal" and "het Gerechtshof, Den Haag', The T.M.C. Asser Instituut continues the development of the International Crimes Database and Web Platform Project, which is published on the Hague Justice Portal under the name of 'DomClic project'. By the end of 2010, the database included almost 500 national cases with a multitude of relevant, up-to-date supplementary documents.

### The Hague Prize for International Law

The T.M.C. Asser Instituut hosts the Secretariat for The Hague Prize for International Law. The T.M.C. Asser Instituut in partnership with the Hague Institute for the Internationalization of Law (HiiL) co-organise the bi-annual colloquium in honour of the laureate. On 3 December 2010, the third 'The Hague Prize Colloquium for International Law' was held in honour of Dame Rosalyn Higgins, former President of the International Court of Justice.

### Knowledge Transfer

### Education and professional development

The T.M.C. Asser Instituut recognises the unique challenges faced by today's legal practices and is in a position to offer an extensive range of information and resources to support individuals and organisations. Tailor-made training programme development and delivery, in close collaboration with the commissioning parties, is a particular strength. Our specialist training programmes are designed specifically around the unique demands of our clients and focus on the main issues affecting legal practitioners. Such judicial training programmes allow practitioners to enhance their legal expertise and shape the direction of their career while meeting and discussing professional issues with their peers.

The start of 2010 saw cutbacks in government funding of programmes such as MTEC and MATRA. Fortunately, our long-standing reputation for quality, efficiency and an in-depth understanding of our field resulted in our success in acquiring new clients, commissions and partners.

2010 saw an increase in the number of education and professional training courses delivered by the Institute in cooperation with external experts. A total of **14 (tailormade) training programmes were developed and delivered (in The Hague and abroad) to a diverse population of participants ranging from students to supreme court Judges**.

Highlights include:



The 1<sup>st</sup> Summer School on Disarmament & Non-Proliferation of Weapons of Mass Destruction in a Changing World (August, 2010), in cooperation with the Organisation for the Prevention of Chemical Weapons (OPCW) was delivered in August 2010. This unique programme attracted some 28 participants from 14 countries. It received sponsorship in the form of student stipends from the Dutch Ministry of Foreign Affairs.

The 4th Annual Summer Law Program in The Hague (June, 2010). This ABA accredited, 4 week long summer programme ran in collaboration with the War Crimes Research Office of the American University's Washington College of Law and the participants were LL.M and J.D. students from a number of top American universities.





### Training programme on Arbitral Awards in International Commerce (October, 2010).

In cooperation with the US based Chemonics International, an international development consulting firm, and with sponsorship from USAID, we developed and delivered this week long programme to judges of the Supreme Court of Kazakhstan. We contributed to the **EUROMED Justice II** project by providing Judicial training to judges and policy advisers from the Mediterranean countries on the **Organisation and functioning of the European cooperation networks in criminal matters and functioning of Eurojust in cooperation** (November, 2010). Partners in this venture were EIPA, the Spanish General



Council of the Judiciary and the Dutch Ministry for Justice.

# The Right to Judicial Protection: Administration of Justice in Cross-border disputes, Belgrade, Serbia

We were also successful in winning one of the last MATRA tenders and delivered the first of three planned training programmes to members of the Serbian Judiciary in Novisad.





On behalf of the Hague Academic Coalition we continued in 2010 to develop and deliver training programmes on international law for the Judiciary. In March we welcomed judges from Laos for a course on **"International Criminal Law"**.

In June, a group composed of 19 investigative judges and police officers came to The Hague from Iraq to participate in a training programme on **"Management of Investigation**". The purpose of this training was to enhance the knowledge and skills of the Iraqi criminal justice system in the respective areas of responsibility of the

participants and to promote closer collaboration between the different actors in the criminal justice system. It was also aimed at raising awareness and practical application of the fair trial standards in criminal proceedings in full respect for the rule of law and human rights which should contribute to the effectiveness.

A training entitled **"International Law Course – Introduction to Selected Topics"** was delivered to a group of 18 Judges in Juba, Southern Sudan (15 – 20 November, 2010).

### Asser staff members lecturing at universities and elsewhere

In 2010 members of the Asser Research staff have once again facilitated university needs by contribution to both undergraduate and graduate LLM degree programmes as well as delivering single lectures in the following Universities and institutions: University of Groningen, University of Utrecht, University of Leuven, University of Amsterdam, University of Twente, Hague University of Applied Science, Wuhan University China and Lex Sportiva Instituta, Jakarta, Indonesia.

Campus The Hague / Leiden University, has founded The International Centre for Counter-Terrorism (ICCT) – The Hague

(<u>www.ict.nl</u>). The ICCT is an independent knowledge centre that focuses on information creation, collation and dissemination pertaining to the preventative and international legal aspects of counter-terrorism.

The core of ICCT's work centres on such themes as de- and counter-radicalisation, human rights, impunity, the rule of law and communication in relation to counter-terrorism.

Functioning as a nucleus within the international counter-terrorism network, ICCT – The Hague endeavours to connect academics, policymakers and practitioners by providing a platform for productive collaboration, practical research, and exchange of expertise and analysis of relevant scholarly findings. By connecting the knowledge of experts to the issues that policymakers are confronted with, ICCT – The Hague contributes to the strengthening of both research and policy. Consequently, avenues to new and innovative solutions are identified, which will reinforce both human rights and security.

The centre is a result of an initiative originating in the Dutch parliament and will, in its nascent years, receive financial support from the Ministry of Foreign Affairs.

perspectives, welcoming the new Centre and underlying the great opportunities and challenges that lie ahead.

**International Launch: ICCT** – The Hague held its International Launch Conference entitled '**Ten Years after 9/11: Evaluating a Decade of Intensified Counter-Terrorism'** From 12 - 13 December over 200 highlevel international experts from various governments, academic institutions and NGOs gathered to discuss the status of counter-terrorism as the year 2011 drew



near, in which it will be 10 years since the devastating attacks on the United States.

The T.M.C. Asser Instituut's publishing unit plays a significant role in efforts to build the capability of the profession.

Despite an uncertain world economy, reduced library budgets, and a weak British pound and US dollar, the T.M.C. Asser Press journals were able to hold their position in the market place during 2010.

**Key figures for 2010** show that T.M.C. Asser Press published 19 new book titles, 10 series, 1 reprint from the backlist and 6 journals issues. T.M.C. Asser Press currently has 194 titles in stock.

### 2010 highlights include:

The signing of a **long-term contract with Springer-Verlag** for the production, marketing, sales, and distribution of its English language book programme. The marketing and sales of the T.M.C. Asser Press journals remain with the journal division of Cambridge University Press. Springer is currently the world's largest academic book publisher and also the leading e-book publisher with more than 40,000 e-book titles. With offices in more than 20 countries around the world, Springer's extensive network also has the added benefit that Asser Press books will also be distributed as e-books.

**Increase in the number of consortia subscribers** through Cambridge Journals Online with now more than 1500 libraries worldwide having access to Asser Press journals electronically. The Cambridge Journals Digital Archive with the back volumes (prior to 2004) of our English language journals and yearbooks is performing well and has resulted in increased usage and visibility of our periodicals.

**Higher ranking and impact factor for The European Constitutional Law Review (Eu-Const)** in the important Science Citation Index (SCI) of Thomson Reuters (Philadelphia, USA). It is now ranked 64 out of 115 journals with an impact factor of 0.708. In the previous SCI report it was ranked 73 out of 104 journals with an impact factor of 0.524.

Three Law journals were accepted by Westlaw UK for coverage in its important online legal research service, namely: The European Constitutional Law Review, the European Business Organization Law Review and the Hague Journal on the Rule of Law.

The portfolio of student readers continues to do well, and 2010 saw the development of the **new student reader Inleiding Humanitair Oorlogsrecht** (B. Pieters and A. Vermeer), in cooperation with the Dutch Red Cross.

### Academic Cooperation

Successful examples of academic cooperation are the periodical publications under the auspices of the T.M.C. Asser Instituut and published by T.M.C. Asser Press, in which members of the Law Faculties of Dutch and foreign universities and staff members of the international organisations in The Hague participate, both as authors and/or board members.

# **Financial Overview**

This past year was challenging for the T.M. C. Asser Instituut, as we, like all other organisations dependent on public funding, coped with the effects of the recession.

The Institute's financial statements for 2010 are synopsised below and are in the process of being audited by our independent auditors, KPMG. Taken together, they present an Institute much strengthened financially over 2010 with the prospect of a positive book balance.

In addition to our regular activities, our ambitious plans at the start of the year to realise a modern conference facility on the premises have been realised.

For the year 2010 it was estimated that both the operating revenues and operating expenses would each be in the range of  $\leq$ 3,500,000. We are pleased to announce that our operating expenses have not exceeded our operating revenues.

The Institute's annual operating revenues for the year 2010 were  $\leq$ 3,600,000. A modest operating surplus of  $\leq$ 8,000 was achieved after giving effect to expenses of  $\leq$  3,600,000.

The Institute's net assets totalled €936,000 at the end of the financial year 2010, which is an increase of 1% on 2009. Annual operations contributed positively to the net assets.

It remains that in order for the Institute to continue to function as a vital research organisation a steady amount of new outside financial support must be secured.

The Statement of Activities below shows operating revenues and expenses for the year 2010.

These amounts are slightly, but not significantly, more than the figures for each of several prior years. Our operating revenues are derived primarily from the 1<sup>st</sup> and third money streams. 3<sup>rd</sup> money stream = returns from contract research and consultancy, Asser Press publications, Education, training and events.

# Organisation

### Governance


### **Executive Board**

The Executive Board directs and controls the affairs of the Institute and comprises an Independent Chair, and two Board members representing the constituent universities.

During 2010, the Directorate of the T.M.C. Asser Instituut convened on two occasions with its Executive Board. The Institute's positioning in relation to the Hague Institute of Global Justice, the Institute's inter-university research programmes, as well as the financial position of the Institute and its development within the framework of the Covenant with its governing body, the University of Amsterdam, were relevant agenda items.

### Directorate

The Directorate, responsible for the daily steering of the institute comprises a General Director and a Business Director.



#### **Management Team**

The Management team comprises the Directorate and the Heads of the following departments: Research, Human Resources, Operations, Education & Events, Finance & Control and The T.M.C. Asser Press.

Management encourages a culture where staff development is a continuous process and is a key accountability of all managers. Staff members are encouraged to develop their knowledge and skills and to work effectively both as individuals and as a team member.

### Staff

On 31 December 2010, a total of 46 persons (equivalent to 38 fte) were employed by the T.M.C. Asser Instituut, including temporary and project related staff. The latter category concerns, amongst others, personnel involved in projects of The Hague Academic Coalition such as The Hague Justice Portal and The Hague Forum for Judicial Expertise.

In 2010, J. Powderly, H. Brollowski, D. Pettengell, A. Oudshoorn, S. Stuij and N. Meijer joined the staff of the T.M.C. Asser Instituut.

In 2010 B.J. van het Kaar, D. Taylor, L. Massai, K. Swinnen-Pieters, J. Odermatt and H. Lammers left the Institute. Bert Barnhoorn left the Institute at the end of 2010 to go on retirement after having worked for the Institute for more than 41 years.

### Works Council

### Law of the European Union - Centre for the Law of EU External Relations (CLEER) http://www.cleer.eu



CLEER Hosted by the T.M.C. Asser Instituut, the Centre for the Law of EU External Relations, established in 2008, is a forum for debate and an authoritative research interface between

academia and practice dealing with the legal aspects of the role of the EU in the world. CLEER's ambition is to stimulate excellence in research, reflection and teaching in EU external relations studies in higher education institutions in and outside the Union and to promote innovative solutions to practical challenges to the external dimension of the EU's legal order. CLEER's in-house research capacity is complemented by a growing network of partner institutions.

CLEER's research programme centres on the analysis of (i) the reception of international law in the EU's legal order, (ii) the projection of EU law on the international plane and (iii) policy and institutional issues of coherence and consistency in EU external policy-making and implementation. Thematic research is focused on (i) the external dimension of the EU's Justice and Home Affairs; (ii) the protection and promotion of economic and financial interests; (iii) the protection of the environment, climate and energy; and (iv) the ability to provide military security.

#### **CLEER** activities 2010

5 February 2010. The T.M.C. Asser Instituut hosted a conference organised by CLEER on the implementation of the external dimension of the Stockholm Programme, the EU's new multi-annual programme in the Area of Freedom, Security and Justice. The debate revolved around three topics: (1) basic principles of mutual legal assistance and extradition agreements of the EU with third countries; (2) combating illegal immigration; and (3) data exchange and data protection. Dr. E.M.H. Ballin (Dutch Minister of Justice) delivered the keynote speech. Among other issues, the Minister called the participants to pay attention to the need for coherence between the internal policies in the AFSJ and the consistency of the EU's external actions. He stated the necessity of ensuring coherence between the institutions based in Brussels and agencies like Frontex, Europol and Eurojust. He also questioned the future role of COSI and the parameters for inter-institutional cooperation as set out by the Council. The three main topics were discussed by speakers from academia and from the world of policymaking, under the Chatham House Rule. The closing panel was chaired by Juan Antonio Martin Burgos, representing the Spanish Presidency. The event was financially supported by the Dutch Ministry of Justice and the European Commission.

9 July, 2010. CLEER, in co-organisation with the Leuven Centre for Global Governance Studies and the Swedish Institute for European Policy Studies, held a conference at the University Foundation in Brussels on the recent changes in the external action and representation of the European Union. The conference could not be timelier, as only one day earlier the European Parliament had approved the package agreed to in the so-called 'Madrid guadrilogue', thereby ending -by and large- the political wrangling. The topical nature of the conference was reflected in the high level of attendance and the debates triggered by the insightful comments of a remarkable line-up of speakers representing the legal services of the Council, Commission and EP, as well as several Member States' ministries of foreign affairs, including that of the EU Presidency. Renowned academic experts offered their analysis and constructive criticism on the two structural reforms brought about by the Treaty of Lisbon with regard to the external policy of the EU: (i) the rapprochement of the pre-Lisbon structures driving the previously called 'Community model' and the 'intergovernmental model', most tangibly embodied by Catherine Ashton, High Representative of the Union for Foreign Affairs and Security Policy and Vice-President of the Commission; and (ii) the creation of a European External Action Service (EEAS). The inclusion of the latter in Article 27(3) TEU and mention that it should comprise officials from 'relevant departments' of the Commission and the General Secretariat of the Council, as well as diplomats from the Member States, carried the obvious implication that the organisation and structures for external relations of EU institutions and Member States alike would be influenced by the emergence of the EEAS. In particular, the future disappearance of most of the Commission's DG Relex meant that many questions pertaining to the management, programming and implementation of external action and representation would be on the table. Indeed, what will effectively be the policy realm of the EEAS? Will the EEAS become a genuine diplomatic service of the Union? Will it allow the EU to assert itself in a more efficient, coherent an effective manner on the international stage? Will the creation of the EEAS upset the Union's so-called 'institutional balance'? These and many more questions where discussed at length at the CLEER-GGS-SIEPS conference on 9 July under the Chatham House Rule. The closing speech was delivered by Dr Luuk van Middelaar, member of the cabinet of the President of the European Council. The event was financially supported by the European Commission.

5 November, 2010. The T.M.C. Asser Instituut hosted a conference on 'The Influence of International Organizations on the European Union: The EU as an autonomous legal order?', organized by CLEER. The European Union is traditionally seen as a new, and partly separate, legal order within the global legal system. At the same time, more recent developments have revealed the EU as an important player in the global governance network. The strong and explicit link between the EU and a large number of other international organisations raises questions concerning the impact of decisions taken by other international organisations and of international agreements concluded by the EU and/or its Member States with those organisations on the autonomy of the EU legal order. The conference addressed the relationship between the EU and other international organisations by looking at the impact of norms enacted by international organisations on the shaping of EU law. Distinguished academics outlined the normative impact of decisions of international organisations and agreements concluded between the EU and international organisations. Representatives of international organisations (CoE, WTO, IMF, WIPO, FAO) and EU institutions (Commission and Council legal services) and agencies (Europol, Eurojust, Ombudsman) revealed how international organisations view and interact with the EU and how the EU perceives the influence of (other) international organisations, respectively. The conference papers will be collected in an edited volume and published by T.M.C. Asser Press.

CLEER's expanding network of specialists in the field of EU external relations law is maintained through the website and a quarterly electronic newsletter, the first one of which was sent to almost 300 subscribers to CLEER's mailing list.

Finally, CLEER launched a News Service to keep subscribers up to date with current developments on the EU's role in the world. CLEER's News Service provides a weekly comprehensive overview of official events and documents, as well as publications and conferences in the area of EU external relations. The News Service features handy weblinks to press releases, secondary legislation, preparatory documents, EP reports and case law, as well as lists of recently published academic articles, books and policy briefs. The News service documents are sent around via email to subscribers and published on the website.

In the Dutch universities, most of the private international law departments are small in size and increasingly autonomous in their operations. In the second half of 2009, Groningen University (Prof. Mr. M.H. ten Wolde) and Maastricht University (Prof. Mr. G.R. de Groot and Dr. S. Rutten) expressed their willingness to cooperate in a more inclusive research initiative coordinated by the Asser Institute. In 2010, they provided feedback on a conceptual framework for research cooperation under the flag of the Centre for European Private International Law. Due to a change of guard within the Asser Institute's cluster of private international law, further developments have been slow. With the arrival of new researchers – recruited with the assistance of Prof. Mr. M.H. ten Wolde in the last quarter of 2010, hopes are high to consolidate this new inter-faculty cooperation in the first quarter of 2011 and to produce the first academic output, in terms of publications, events and tenders, in the second half of 2011. Cooperation with the other universities (e.g. Erasmus University Rotterdam (Prof. Mr. T. van Mierlo, Dr. X. Kramer)) is envisaged.

#### International Sports Law - ASSER International Sports Law Centre (AISLC) http://www.sportslaw.nl



The T.M.C. Asser Instituut's research in international sports law is of an interdisciplinary as well as comparative law character, covering all fields of law in which the institute specialises, i.e., private international law, public international law including the law of international organisations, international commercial arbitration and the law of the European Union. The ASSER International Sports Law Centre (established in 2002, <u>http://www.sportslaw.nl</u>) emerged from the projects carried out up until then by Asser researchers.

The mission of the ASSER International Sports Law Centre is to provide a centre of excellence in particular by providing high quality research, services and products to the sporting world at large (sports ministries, international and intergovernmental organisations, sports associations and federations, the professional sports industry, etc.) on both a national and an international basis. The Centre has a worldwide network of academics and practitioners and cooperation agreements with various sports law institutes and centres in Europe and beyond, including Asia, South Africa and North and South America. Whereas in previous years, much attention was paid to EU-supported advice and assistance to the new EU Member States and candidate countries in Eastern Europe, the Centre focused in 2010 on cooperation with the rapidly "sports law developing" Asian region (in particular, China, India, Indonesia).

The Centre edits and publishes The International Sports Law Journal (ISLJ) (spring and autumn) and the Asser International Sports Law Series of books. It is also the organiser of a range of seminars, conferences and events, both in The Netherlands and abroad.

#### Hague International Sports Law Academy

The Centre is the co-founder and coordinator of the newly established Hague International Sports Law Academy (HISLA) the purpose of which is the organization of academic confer-

ences and workshops of international excellence which are held in various parts of the world.

In 2010, the seeds were sown for the establishment, in the first half of 2011, of an interuniversity research cooperation with:

- University of Leuven (Prof. Dr. R. Blanpain)

Recruitment procedure for the appointment of an academic coordinator was initiated in the last quarter of 2010. This person will be tasked with the actual development of this new inter-university research programme.

#### **Public International Law**

Thanks to its long-standing research tradition in Public International Law and its seat in The Hague, 'City of Justice, Peace and Security' and host to a number of judicial institutions such as the ICJ, ICTY, ICTR and the ICC, the T.M.C. Asser Instituut is well-placed to offer law faculties a platform for inter-university research and an interface with judicial practice, especially in the fields of International Humanitarian Law and International Criminal Law.

In the autumn of 2010, the T.M.C. Asser Instituut has signed a Memorandum of Understanding (MoU) on Cooperation in the fields of IHL and ICL with:

- Amsterdam Centre of International Law (ACIL) of the University of Amsterdam (Prof. Dr. T.D. Gill, Prof. Dr. H. van der Wilt)
- Leiden University (Prof. Dr. C. Stahn, Dr. R. Heinsch)
- Vrije Universiteit (Prof. Mr. E. van Sliedregt)

Indirectly, Utrecht University, through Prof. Dr. T.D. Gill, is also represented in this research network.

With the MoU, the above-mentioned institutions have expressed the desire to cooperate for the next four years, through an inter-university 'platform' coordinated by the T.M.C. Asser Instituut, in fields which lie at the crossroads of their own research programmes. Concrete research themes and projects will be determined by the inter-university 'forum'. The first research projects are IHL / ICL and media and IHL / ICL and business. For the first research theme, cooperation with the Centre for Holocaust and Genocide Studies was sought. A cross-disciplinary expert conference "On the Front Line of Accountability – War Reporting and Related Contemporary Issues in International Humanitarian and Criminal Law", including journalists, served as a launch event on 21 January 2011. The Royal Netherlands Academy for Sciences (KNAW) was awarded a grant for the organisation of this conference.

It is the intention to develop a second research theme once the first is up and running.

#### Asser Guest/Visiting Researchers

A distinguished panel of guest researchers who represent various aspects of international law also contribute to the insight of the T.M.C. Asser Instituut. In 2010 they included Mr. Leendert Erkelens, Dr. Flora Goudappel, Dr. Maria Nybondas and Dr. Fiona Mucklow.

### The late Dr. Avril McDonald

On 14 April 2010 we received the sad news that our much valued former colleague, Dr. Avril McDonald, had passed away.

Avril worked as a Researcher and as Head of the Section IHL/ICL for the T.M.C. Asser Instituut from 1997 until 2007. Thereafter, she continued her association with our organisation as "Associate Researcher". She was involved in the initiation and development of the Yearbook of International Humanitarian Law and the website of International Humanitarian Law.

Avril was holder of the Rosalind Franklin Chair in International Law and Contemporary Conflict at the University of Groningen.

#### Asser Visiting Researchers Programme

Under the Asser Visiting Researchers Programme (AVRP) the T.M.C. Asser Instituut continuously hosts foreign scholars and visiting fellows for varying periods of time, providing all the facilities and services necessary, including academic counsel. Study on the implementation of the World Anti-Doping Code in the EU

(December 2009 – July 2010)



In December 2009, the Minister of Sport of the Flemish Government commissioned a research project on the implementation of the World Anti-Doping Code in the 27 EU Member States to the T.M.C. Asser Instituut. The aim of the study was to make an inventory on how the

At the start of the Belgian EU Presidency in July 2010, the results of the study were presented to the other Member States and the European Commission, and additionally to the Council of Europe, UNESCO and the World Anti- Doping Agency (WADA) as a starting point for further consideration and discussion within the framework of the fight against doping in sport.




The lunch lecture presented the EU international cooperation law from an empirical point of view and gave examples of such bodies and the law enacted in order to emphasise the

**Regional Seminar on Cross–Frontier Child Protection in the Southern and Eastern African Region** (Pretoria, South Africa, 22 -25 February, 2010)

THE HAGUE FORUM FOR JUDICIAL EXPERTISE



This course was a follow-up seminar that took place in 2006 in The Hague on the role of the Hague Children's Conventions.

The seminar examined the role of the Hague Children's Conventions and addressed the practicalities and challenges of implementing the Hague Children's Conventions. Subjects discussed were amongst others: cross-border child support, international child abduction, child trafficking, protection of unaccompanied minors, refugee and displaced children.

Participants included senior officials from Ministries from member states of the Southern African Development Community (SADC) with responsibility for the development of child protection policy and the implementation of international instruments concerning children. International and regional organisations such as the African Union, SADC Tribunal, the UN committee on the rights of the child, UNICEF as well as professionals and judges.

THE HAGUE FORUM FOR JUDICIAL EXPERTISE The aim of this training course was to contribute to the effective and efficient administration of justice in Laos and to strengthen the rule of law by familiarizing the participants with international law.

The course focused on international law, international human rights law, international humanitarian law and international criminal law.

## Europol & Eurojust: Their Role in EU Police and Judicial Cooperation

(The Hague, May 17 – 18, 2010)



Aimed at fostering knowledge on the legal instruments of the EU in the fields of police and judicial cooperation in criminal matters as well as increasing knowledge on the role of the European institutions in the field of criminal justice, this course also served to promote cooperation between national judicial and police authorities with Eurojust and

Europol in the fight against transnational crime.

Co-developed with the principle organisations Europol and Eurojust, it convened a body of key experts in the field to deliver the programme.

Emerging specific issues such as the fight against illegal immigration and the role of **FRON-TEX** and other topics such as the protection of the financial interests of the EU and the cooperation of national authorities with **OLAF**, the anti-fraud office of the EU, were dealt with.

The course was intended for members of the police forces and the judicial authorities of the member States of the European Union.

#### Fourth Summer Law Program in The Hague (The Hague, May 31 – June 26, 2010)



The Summer Law Program provides participants the opportunity to study some of the most important legal issues today in the heart of the international justice community. The ABA-approved, six-credit summer program includes two three-credit courses:

- International Criminal Law In Search of Accountability provided an introduction to international criminal law and explored the various ways in which national, internationalized and international courts and tribunals have attempted to enforce criminal responsibility for serious violations of human rights and humanitarian law.
- International Legal Approaches to Terrorism in the 21st Century examined counterterrorism measures from an international and comparative law perspective and considered the interrelation between these measures and the obligations of states under international human rights and humanitarian law.

The program was attended by J.D. and LL.M. students from Washington College of Law and other prominent US universities.

#### **EuJust Lex/Benelux Management of Investigation Course** (The Hague and Luxembourg 31 May -18 June, 2010)





EUJUST LEX is designed to address the urgent needs in the Iraqi criminal justice system through providing training in the fields of management and criminal investigation to be given to senior officials and executive staff from the judiciary, the police and the penitentiary. From 1 June until 18 June 2010 EUJUST LEX and the Benelux countries jointly organized a Management of Investigation Course for 19 investigative judges and police officers from

Iraq. This was the eighth suchlike training programme for Iraq. The training took place in The Hague, Luxembourg, and Brussels, Belgium.

The purpose of this training was to enhance the knowledge and skills of the Iraqi criminal justice system in the respective areas of responsibility of the participants and to promote closer collaboration between the different actors in the criminal justice system. It was also aimed at raising awareness and practical application of the fair trial standards in criminal proceedings in full respect for the rule of law and human rights which should contribute to the effectiveness

Seminar on International Dispute Resolution & Regional Seminar on Choice of Court Agreements (Rio de Janeiro, Brazil, 5 and 8 November, 2010)





Two regional Seminars/ Courses for judges and government officials, who have experience in international legal cooperation.

The starting point for these Seminars was the parallelism between the 1994 Buenos Aires Protocol on International Jurisdiction in Contractual Matters - in force since 6 June 1996 - and the Hague Convention of 30 June 2005 on Choice of Court Agreements (the Choice of Court Convention), whose entry into force awaits a second ratification and is currently under examination of some MERCOSUR States. At respectively the regional and global level, both instruments are designed to reduce the time and expense courts and businesses face when dealing with international jurisdictional issues and enforcement of foreign court decisions.

One week training programme (18 participants) for judges and policy advisers. The broad based programme included issues relating to combating international crime, such as cybercrime, human trafficking, financial crime, etc.

Participants were from the 9 Mediterranean countries: Algeria, Egypt, Israel, Jordan, Lebanon, Morocco the Palestinian Authority, Syria and Tunisia.

This training was developed as part of the European Commission's regional project in the field of justice in the Euro-Mediterranean area. This project is implemented by a consortium lead by the European Institute of Public Administration (EIPA) and composed of the Inter-

national and Ibero-American Foundation of Administration and Public Policies (FIIAPP) and of the Spanish General Council of the Judiciary (CGPJ).

The overall objective is to contribute to the development of a Euro-Mediterranean area of cooperation on justice. The modernisation of the judicial system underpinning the principles of judges' independence and the consolidation of Mediterranean Partners, are priority areas. Another objective of the project is to develop networks.

One week training programme for 11 participants (judges from the Supreme Court of Kazakhstan and staff).

This tailor-made programme was designed in response to the requirement for assistance in aiding efforts to

increase the capacity of judges within the Supreme Court of the Republic of Kazakhstan along international guidelines. The aim of the training was to equip participants with knowledge and practical skills that will enable them to enhance their effectiveness in resolving commercial disputes in accordance with international standards and to provide support to arbitration in a manner that meets the needs of international commerce and contribute in preparing for ascension to the World Trade Organization (WTO). Also, to create understanding among the participants of the European judicial authorities and their roles, knowledge and abilities and to stimulate and strengthen the bilateral judicial cooperation between Kazakhstan and EU member states.

The programme structure embodied balance and interconnectivity between the three components: theory, practical skills training and study visits, with Arbitral Awards rendered in cases involving international commercial transactions being the focal point.

# Appendix 5: Institute for Counterterrorism -The Hague

# Institute for Counterterrorism (ICCT) Activities 2010

#### Official Opening ICCT – The Hague www.icct.nl

31 May, 2010. During a conference in the Peace Palace on the 31st of May 2010, ICCT – The Hague was officially opened by Dutch Minister for Foreign Affairs Mr. Maxime Verhagen, in the presence of approximately 200 distinguished guests. Ms. Michèle Coninsx (EUROJUST), Mr. Richard Barrett (UN Al Qaeda Taliban Monitoring team), Mr. Gilles de Kerchove (EU Counter-Terrorism Coordinator) and Professor Michael Buback presented on contemporary issues and challenges in the field of counter-terrorism from different perspectives, welcoming the new Centre and underlying the great opportunities and challenges that lie ahead.

#### Seminar 'Counter-Terrorism, Communication and Non-State Actors'

3 November, 2010. ICCT – The Hague organised a closed-session seminar on the topic of 'Counter-Terrorism, Communication and Non-State Actors', prior to the 3rd CVE Workshop hosted by the Netherlands Ministry of Foreign Affairs. The presentations by Dr. Beatrice de Graaf (ICCT – The Hague), Mr. Sadik Harchaoui (FORUM), Ms. Janny Groen (de Volkskrant) and Mr. Shiraz Maher (International Centre for the Study of Radicalisation, London) led to a vibrant debate on responses to terrorism and the added value of cooperation with non-governmental actors. Approximately 35 participants from various governments participated in this seminar.

#### Expert Meeting and Paper 'Lone Wolves: How to Prevent This Phenomenon?'

5 November, 2010. Leading experts discussed the rise of the Lone Wolf terrorists and analysed the challenges governments, police and intelligence agencies face in dealing with this threat. Professor Mark Hamm (Indiana State University), Professor Christopher Hewitt (University of Maryland) and Dr. Leena Mallkki (University of Helsinki) discussed best practices for policing, intelligence and policymakers in identifying and capturing lone wolves, as well as how to respond and develop the right counter-narrative. NCTb and KLPD experts concluded the meeting with a brief analysis of their institutional experience in dealing with this issue. Following the expert meeting, ICCT has published a paper on the phenomenon of Lone Wolf terrorism discussing the causes and characteristic of these terrorists, as well formulating policy recommendations on how to deal with this threat. The paper has been authored by Dr. Edwin Bakker and Dr. Beatrice de Graaf.

#### Seminar 'Where Are We Going? Counter-Terrorism and Human Rights'

7 December, 2010. ICCT – The Hague and the Centre for Terrorism and Counter-terrorism (CTC) of Leiden University/Campus The Hague hosted a seminar on the nexus of counter-terrorism measures and human rights, entitled: 'Where are we going? Is the double helix of human rights and counter-terrorism moving upwards or downwards?' Keynote speaker Professor Amos Guiora (University of Utah) analysed the American experience and ICCT – The Hague Research Fellow Dr. Quirine Eijkman looked at the current situation in Europe

and the Netherlands in particular. Approximately 30 participants engaged in a lively debate on the need for developing a long-term counter-terrorism strategy with full respect for human rights.

#### ICCT – The Hague International Launch Conference

12 - 13 December, 2010. ICCT – The Hague held its International Launch Conference entitled 'Ten Years after 9/11: Evaluating a Decade of Intensified Counter-Terrorism'. Over 200 highlevel international experts from various governments, academic institutions and NGOs gathered to discuss the status of counter-terrorism as the year 2011 drew near, in which it will be 10 years since the devastating attacks on the United States. The conference commenced with a welcome dinner accompanied a speech by Mr. Dan Gardner (Canadian Journalist and Author) on 12 December. Following the Conference's formal opening on December 13 by Professor Jaap de Hoop Scheffer, the plenary morning session started with two keynote speakers, Mr. Michael E. Rolince (former Special Agent in Charge of the FBI Washington Field Office Counterterrorism Division) and Mr. Imtiaz Gul (Journalist and Director of the Center for Research and Security Studies, Islamabad), who gave the audience a bird's eye overview of a decade of counter-terrorism from two very different geographical and institutional perspectives. During the subsequent plenary panel discussion, Prof. Dr. Martha Crenshaw (Stanford University) and Mr. Richard Barrett (Coordinator UN Al-Qaida / Taliban Monitoring Team) commented on the earlier presentations and presented their own analyses of implemented counter-terrorism policies and measures over the last ten years. The afternoon segment of the conference consisted of four Panel Workshops, each looking into the progress that has been made over the last decade in a specific area of counter-terrorism. At the end of the workshop sessions, each Chair reported back various policy recommendations and areas of future research in relation to the workshop's theme.

#### **ICCT Publications**

#### Conference Report 'Ten Years After 9/11'

A detailed report on the ICCT International Launch Conference proceedings, including a summary of the various presentations by the speakers and panellists has been published on the ICCT website early February 2011. This report also includes a range of policy and research recommendations that resulted from the panel workshops.

#### Research Paper 'Why Communication and Performance are Key in Countering Terrorism'

In this research paper, Research Fellow Dr. Beatrice de Graaf emphasises the importance of effective communication and performance in the fight against terrorism and the fear it aims to induce. Essentially, terrorists and states are conducting 'influence warfare', a battle to convince and persuade the different target audiences to rally behind them. In this battle of perceptions, the different government agencies need to be aware of the often implicit and unwittingly produced 'stories' they tell to counter those narrated by the terrorists.

#### Study 'Discriminatory Side Effects of Preventive Counter-Terrorism Measures'

Late March 2010, ICCT – The Hague published a study conducted by Dr. Quirine Eijkman on discriminatory side effects of preventive counter-terrorism measures. This study examined the prevent-strand of the counter-terrorism strategy in the Netherlands and the United Kingdom and the (potential) negative – specifically discriminatory – side effects of these

measures. The study made a number of recommendations on best practices and areas of improvement.

#### **ICCT Commentaries**

Approximately once per month, ICCT – The Hague publishes a commentary by one of its staff members on the website, dealing with current affairs or the dissemination of research findings related to (counter-terrorism. These commentaries have covered a range of topics such as the analysis of the legal measures taken in the fight against terrorism, the need for strengthening resilience to counter the fear terrorists aim to spread and the reason why the revolts in Egypt prove the bankruptcy of Al Qaeda's tactics.

#### Seminar 'Negotiating with Terrorist Organisations'

On 10 March 2010, ICCT – The Hague hosted a seminar entitled 'Negotiating with Terrorist Organisations'. During the seminar, Dr. Isabelle Duyvesteyn (Utrecht University) elaborated on the role that negotiations can play within a broader counter-terrorism context. Subsequently, Dr. Olivier Bangerter (International Committee of the Red Cross' Advisor for Dialogue with Armed Groups) offered his insights on the subject from a practitioner's perspective.

#### **Impunity Study**

Dr. Peter van Krieken, seconded to ICCT – The Hague by the Dutch Ministry of Security and Justice, is exploring the issue of (alleged) impunity of terrorists and examines whether current legal instruments are sufficiently capable to hold terrorists accountable for their actions. This research will cumulate in a comprehensive study in the first half of ICCT's second year.

#### Contributions to OSCE meetings in Kazakhstan, Uzbekistan and Bosnia and Herzegovina

Director Peter Knoope and Research Fellow Dr. Edwin Bakker were invited to participate in three OSCE conferences on terrorism. Peter Knoope gave two presentations: In Kazakhstan, on 14 October 2010, he delivered a keynote speech on successful strategies, effective policies and best practices to prevent terrorism. In Uzbekistan on 10 December 2010 he presented on the topic of violent extremism in Europe. Edwin Bakker presented on factors conducive to the spread of terrorism and at-risk communities during an OSCE Workshop on 'Public Private Partnerships to Suppress Terrorist Financing and Counter Violent Extremism and Radicalisation that Lead to Terrorism' in Sarajevo on 10 December 2010.

#### Informal Closed-Session Meetings

Throughout the first year, ICCT has organised a number of ad-hoc, informal closed-session meetings on a number of current affairs. For example, several meetings were held on the consequences of the 2010 Pakistan floods and the subsequent humanitarian relief efforts on the socio-political and security situation in that country. During these meetings, several representatives of NGOs and Humanitarian Aid Agencies and policymakers from various departments with a focus on humanitarian aid and security discussed their views on the impact of the unfolding situation and the societal and security context in which it took place. Another example is the closed-session organised at the Clingendael Institute on the effects the recent uprisings throughout Northern Africa and the Middle East, during which the effects and likely future scenarios of these developments were discussed in relation to Dutch/European (security) interests in that region.

### Appendix 6: T·M·C·Asser PRESS



In 2010 T.M.C. Asser Press published 19 new book titles and 16 journal issues, and one reprint of its backlist. It has now a backlist of more than 194 titles. Despite the uncertain world economy, reduced library budgets, and a weak British pound and US dollar the Press performed reasonably well.

T.M.C. Asser Press signed a long-term contract with Springer-Verlag for the production, marketing, sales, and distribution of its English language book programme. This new collaboration will not only have a positive impact on the marketing and sales efforts of the Asser Press books worldwide through Springer's extensive network with offices in more than 20 countries around the world, but also the added benefit that our books will also be distributed as e-books. Springer is not only the largest academic book publisher, but also the leading e-book publisher with more than 40,000 e-book titles. The Press will also be less vulnerable to foreign exchange fluctuations. The effects of this transition will be visible and measurable for Asser in 2011.

The marketing and sales of the Asser Press journals will continue with the journal division of Cambridge University Press. The journals were able to hold their position in the market place. The number of consortia subscribers grew steadily through Cambridge Journals Online. There are now more than 1500 libraries worldwide having access to our journals electronically. The Cambridge Journals Digital Archive with the back volumes (prior to 2004) of our English language journals and yearbooks is performing well and has resulted in increased usage and visibility of our periodicals.

The book *Principles of International Criminal Law* (Prof. Gerhard Werle (Humboldt Universitaet, Berlin) is now published in English, German, Chinese, Italian and Spanish. There are further plans for Russian and French editions.

The T.M.C. Asser Instituut continued its support for its important yearbooks, which resulted in the publication of the *Netherlands Yearbook of International Law*, Volume 40 (2009) under the General Editorship of Ige Dekker and Ellen Hey and the appearance of the Volumes 11 and 12 of the *Yearbook of International Humanitarian Law*. The publication of Volume 11 marked the last volume under the General Editorship of Tim McCormack, who was succeeded by Michael Schmitt.

The *European Constitutional Law Review (EuConst)* improved its ranking and impact factor in the important Science Citation Index (SCI) of Thomson Reuters (Philadelphia, USA). It is now ranked 64 out of 115 journals with an impact factor of 0.708. In the previous SCI report it was ranked 73 out of 104 journals with an impact factor of 0.524.

Westlaw UK has accepted the European Constitutional Law Review, the European Business Organization Law Review and the Hague Journal on the Rule of Law for coverage in its important online legal research service, which will enhance the usage and visibility of these three journals. Under T.M.C. Asser Press's Hague Academic Press imprint several titles appeared, such as *Jihad and its Challenges to International and Domestic Law* (Eds.: M. Cherif Bassiouni and A. Guellali) in its Hague Colloquium on the Fundamental Principles of Law Series; the *Dynamics of Constitutionalism in the Age of Globalization* (Eds.: Morly Frishman and Sam Muller) in the From Peace to Justice Series; and *Highest Courts and Globalization* (Eds.: Sam Muller and Sydney Richards) in the Law of the Future Series.

T.M.C. Asser Press successfully launched its new and innovative website (www.asserpress. nl), which will service customers and authors worldwide with up-to-date information on its publications. At a special conference at the Dutch Ministry of Foreign Affairs, Mr. Koenders (Minister for Development Cooperation) was presented with the first copy of The 1998 -2000 War between Eritrea and Ethiopia: An International Perspective (Eds.: A. de Guttry, H. Post, G. Venturini). T.M.C. Asser Press promoted its publications not only at a great number of local conferences, but also at major international conferences such as the American Society of International Law (Washington, DC), the European Society of International Law (Cambridge, UK), and the International Law Association (The Hague). Additionally, special book launches were organised at the Grotius Centre (The Hague) for Future Perspectives in International Criminal Justice (Eds.: Carsten Stahn and Larissa van den Herik) and The Notion of Progress in International Law Discourse (Thomas Skouteris); at the T.M.C. The following 2010 titles deserve special mention:

#### Netherlands International Law Review - Volume 57 - 2010 (Editor-in-Chief: P. Vlas)

Its first issue published the translation of Chapter 8 of the Report of the Dutch Committee of Inquiry of the War in Iraq: the Basis in International Law for the Military Intervention in Iraq. Its second issue was devoted to "One Hundred Years of the Netherlands Society of International Law (1910 -2010)".

#### *Nederlands Internationaal Privaatrecht - NIPR - Volume 28 - 2010* Eds.: X.E. Kramer et al.

This bilingual journal (Dutch and English) devoted its third issue to the Dutch Proposal on Private International Law (Book 10 of the Dutch Civil Code).

#### *The European Union and Peace building: Policy and Legal Aspects* Eds.: S. Blockmans, J. Wouters and T. Ruys

Like conflict prevention and crisis management, 'peacebuilding' forms an integral part of the European Union's external policy efforts to break the cycle of conflict, insecurity and poverty. A concept developed in the context of the United Nations, the EU's Lisbon Treaty mentions 'post-conflict stabilisation' among the tasks which the EU is set to perform in the implementation of the Common Security and Defence Policy. The proliferation of the EU's institutional and operational mechanisms to build peace in post-conflict environments has led to a whole series of new policy and legal questions, which are addressed by leading practitioners and academics in this unique book. The contributions take into account the final text of the Lisbon Treaty and the lessons learned from more than twenty military and civilian operations. It outlines the parameters for future decision-making and capacitybuilding. Thematic contributions are combined with concrete case studies, at the same time offering insights into how the EU's peacebuilding tools are implemented in practice

#### Environmental Finance and Socially Responsible Business in Russia: Legal and Practical Trends

The final result is a valuable introductory insight into the progress of environmental and socially responsible business practices in Russia.

#### The Effects of EU Citizenship: Economic, Social and Political Rights in a Time of Constitutional Change

#### F. Goudappel

This book explores the influence of the EU on citizenship rights, especially in view of the fight against terrorism and the constitutional changes negotiated in the last decade.

# The Application of EU Law in the New Member States: Brave New World Ed.: A. Łazowski

A unique book, which provides readers with an in-depth analysis of EU-related legal developments in the twelve new Member States of the European Union. One should not think of those countries as children of a lesser God, but rather a Brave New World negotiating its way in the contemporary Europe.

#### *The Constitutional Integrity of the European Union* Eds.: F. Amtenbrink and P.A.J. van den Berg ISBN 9789067043342

This book explores the consequences of European constitutionalisation for the integrative function of national constitutions, and examines in what way national constitutional orders contribute to the constitutional integrity of the European Union. It is highly relevant to the ongoing debate about constitutionalism in the context of the European Union, since many of the substantive ideas of the failed Constitution for Europe, shorn of its symbols and overtones, are being resurrected in the Treaty of Lisbon.

## The Integration of the Mediterranean Neighbours into the EU Internal Market K. Pieters

#### With a Foreword by Herman Van Rompuy, President of the European Council

This book offers the first comprehensive overview and analysis of policies and instruments employed to integrate the Mediterranean countries in the EU internal market. It examines the Euro-Med Partnership, the European Neighbourhood Policy, the 'Barcelona Process: the Union for the Mediterranean', the Euro-Med Association Agreements, and the ENP Action Plans, in combination with a thorough analysis of the most relevant case law of the European Court of Justice.

## Command Responsibility in International Criminal Law

#### Ch. Meloni

This book offers an in depth study of the *command responsibility* doctrine, pursuant to which military commanders and civilian leaders can be held responsible for the crimes committed by their subordinates that they failed to prevent or punish. It provides a systematic analysis of command responsibility, outlining its different forms and finding it a proper role within the complex net of responsibilities that connotes the commission of international crimes.

#### *Command Responsibility and its Application to Civilian Superiors* M.L. Nybondas

Article 28 of the Rome Statute explicitly provides that the command responsibility doctrine may be applied to both 'commanders and other superiors', and sets out separate criteria for the two categories of superiors. The question arises how the doctrine should be applied by the International Criminal Court and by other international courts and tribunals. The author examines the applicability of the command responsibility doctrine to civilian superiors, taking as a point of departure the origin of the doctrine and the unique position of the commander.

#### The Genocide Convention Sixty Years after its Adoption Eds.: Ch. Safferling and E. Conze

# This volume examines the Genocide Convention from historic, legal and social science perspectives. Contemporary witnesses also report on their experiences of the Nuremberg, the Eichmann and the Auschwitz trials. Their contributions offer a range of insights on the

practical problems and academic discussion surrounding the prosecution of genocide. It is an important contribution to the worldwide debate on and prosecution of genocide.

### International Criminal Procedure: A Clash of Legal Cultures

#### Chr. Schuon

This book provides brief depictions of procedural elements, allowing readers to acquaint themselves quickly with the civil law and common law systems' procedures; a summary of the analysis in a nutshell, making the book accessible for readers with little time at their disposal.

#### Permanent Court of Arbitration – Summaries of Awards 1999-2009 Eds.: B. Macmahon and F.C. Smith

This volume contains detailed, concise summaries of thirty-one awards, and a critical analysis of the PCA's contribution to international law and international dispute resolution by Professor J.G. Merrills, Professor of International Law at the University of Sheffield, United Kingdom.

#### *The State of Interdependence: Globalization,Internet and Constitutional Governance* IT & Law Series Volume 19

#### R.W. Rijgersberg

The State of Interdependence explores the implications of globalization for constitutional governance. The study examines how globalization, viewed as a process increasing the level of transnational interdependence between actors, is shaping modern governance in the public interest. It uses the Internet's interdependency-imposing nature as starting point for

the inquiry since the Internet is the most important and inclusive manifestation of the globalization phenomenon in terms of transnational interdependence. The interdependent context has far-reaching implications for today's democratic constitutional governance and ultimately calls for a re-examination of our philosophical understanding of decision-making in the public interest in terms of legitimacy, accountability and representation.
