

Dr. Asier Garrido-Muñoz is Assistant Professor at the University of Salamanca (Spain). His research project at CLEER deals with the ‘war paradigm’ of the EU counter-terrorism policy. His main areas of interest are International and EU Counter-Terrorism Policy and EU External Relations Law, as well as general topics of Public international law such Human rights Law, State and International Organizations responsibility and State succession to treaties.

He is Ph.D. with *Doctor Europeus* mention (University of Salamanca, 2011); LL.M. in International Humanitarian Law (Geneva Academy for International Humanitarian Law and Human Rights, 2009) and MA in European Studies (University of Salamanca, 2007). Between September 2013-May 2014 he was Law Clerk trainee at the International Court of Justice.

He has been invited expert contributor in the development of the academic program of the European Joint Masters in Strategic Border Management managed by FRONTEX, as well as researcher in the legal team that submitted an *amicus curiae* to the Inter-American Court of Human Rights in the case *Eduardo Nicolás Cruz Sánchez et al. vs. Peru* (still pending). He has also taught seminars at the Universities of Geneva and Neuchatel (Switzerland).
