### **Centre for the Law of EU External Relations (CLEER)**

- **16-17 February, Conference on “Tension between universal and regional unification of private law: Conflict between EU Law and maritime and transport law conventions”, The Hague**

The theme of this Conference was the tension, if not direct conflict, existing between uniform EU law and conventions of uniform private law to which EU member states are party, but the EU itself is not. The conference was organised by the Erasmus School of Law, in cooperation with the Centre for the Law of EU External Relations (CLEER), the Centre for European Private International Law (CEPIL) and the T.M.C. Asser Instituut.

With these events CLEER wishes to create closer cooperation with the diplomatic missions in The Hague and focus specifically on the Presidency’s role in shaping EU external relations law and policy after the Lisbon Treaty.

- **26 April, Sports Fraud Roundtable Seminar**

In April 2012, the ASSER International Sports Law Centre hosted the first of a series of Roundtables to discuss solutions to tackling sports fraud.

The increasing media scrutiny of various incidences of sports fraud (e.g. match-fixing and money laundering) is slowly but surely serving as a wake-up call to the sports community. To stimulate a well-informed and constructive debate on this complex problem and explore efficient mechanisms to tackle it, the ASSER International Sports Law Centre in The Hague is hosting a series of Sports Fraud Roundtables. The first roundtable brought together an interesting group of practitioners, academics, and law enforcers to identify the various types of sports fraud and the actors involved and discuss the threats they pose to the integrity of sports.

### **International Humanitarian Law/International Criminal Law**

- **7 December, Conference “Prosecutor, Watchdog, Diplomat, Manager: The Multiple Roles of the International Prosecutor”**

On 7 December 2012, the T.M.C. Asser Instituut, in cooperation with the International Humanitarian and Criminal Law Platform, will organise a conference on the international prosecutor.

The conference, which is financially supported by the Royal Netherlands Academy of Arts and Sciences, will be the first to bring together top researchers, practitioners and civil society to critically discuss and assess the multiple roles of the international prosecutor – a multifaceted

actor who plays an increasingly important role on the international (legal and political) plane, for instance as a potential global preventer of crimes. The conference offers a timely opportunity to reflect and formulate lessons for current and future international prosecutors.

Indeed, although the function of the international prosecutor is becoming more relevant and influential on the international plane, it is still characterized by considerable indistinctness: is he/she a prosecutor, a watchdog, a diplomat, a manager? And to what extent is he/she subject to (judicial) oversight? By critically assessing and engaging with the different aspects of the function, the conference seeks to formulate lessons learnt and recommendations for future holders of such a post – not only in the international, but also in the European context, where the advent of the European Public Prosecutor only seems to be a matter of time.

### **Law and Armed Conflict Lecture Series (HILAC)**

The HILAC Law and Armed Conflict Lecture Series is an occasional evening lecture series on the subject of law and armed conflict. It is hosted by the Hague Initiative for Law and Armed Conflict (HILAC), consisting of the T.M.C. Asser Instituut, the Netherlands Red Cross and the Amsterdam Center for International Law and held at the T.M.C. Asser Instituut.

### **Supranational Criminal Law Lectures (SCL)**

Together with our partners the Grotius Centre (Leiden University, Campus Den Haag) and the Coalition for the International Criminal Court (CICC), the Section ‘International Humanitarian Law and International Criminal Law’ of the T.M.C. Asser Instituut organises the Supranational Criminal Law Lectures Series. These weekly lectures spotlight aspects of international criminal law of current interest.

Lecture by Sureta Chana, Legal Representative in Prosecutor v. Ruto et al. and Morris Anyah, Legal Representative in Prosecutor v. Muthaura et al. at the ICC.

- **25 January, Book Presentation by Hector Olasolo and debate on “The challenges faced by Pre-Trial Chamber I in the first proceedings ever before the International Criminal Court”**

13th and last Supranational Criminal Law Lecture of the season 2011/2012. It was also the first in a series of events organized to commemorate the 10th anniversary of the ICC. For this special occasion, which was attended by some 150 people, an impressive line-up of speakers was arranged, namely: ICC Judge Steiner (who at the very last moment could not make it), ICC Judge Akua Kuenyehia, ICC Prosecutor Luis Moreno-Ocampo and Prof. Hector Olasolo. The speakers discussed the new book of Prof. Olasolo (‘Essays on International Criminal Justice’, Hart Publishing 2012) and the topic ‘The challenges faced by Pre-Trial Chamber 1 in the first proceedings ever before the International Criminal Court’. After that, there was a lively Q&A session with the audience.

- **19 September, “The ICC and Palestine: A Closed Chapter?” by Prof. John Dugard, Prof. Liesbeth Zegveld & Dr. Chantal Meloni**

The book launch coincided with the Supranational Criminal Law Lecture. Prof. John Dugard, Prof. Liesbeth Zegveld and Dr. Chantal Meloni gave their views on the Gaza issue. A record number of 150 people attended this lecture and contributed to a lively discussion.

- **10 October, “International Justice and the Arab Spring”**

A panel discussion on the impact of the ICC intervention and role of international justice in the Arab region.

- **31 October, “Engaging with victims and affected communities in ICC situations”**

A panel discussion on the different means and aims of engaging and communicating with victims and affected communities in ICC situations from the perspective of the Court’s Outreach Unit, the Trust Fund for Victims, and civil society.

- **14 November, “Civil society participation at the Assembly of States Parties”**

The Coalition for the International Criminal Court, a network of over 2500 NGOs advocating for a fair, effective and independent ICC, discussed its global membership's interest and goals in participating at the annual meeting of the ICC’s oversight body, as well as the impact of the Court on national justice efforts.

Baker, Chief Judge, United States Court of Appeals for the Armed Forces and Prof. John Vervaele, Professor in Economic and European Criminal Law at Utrecht University.

The 4th Dutch round of the Philip C. Jessup International Law Moot Court Competition was organised by the T.M.C. Asser Instituut. The team of Utrecht University won and was allowed to participate in the International Rounds in Washington DC, USA.

- **13 July, Conference: “Preventing fraud, corruption and bribery committed by and through legal entities”**

The conference was part of the EU wide project (entitled “Preventing fraud, corruption and bribery committed through legal entities for the purpose of financial and economic gain”) aiming at providing a contribution to the prevention of and fight against economic crime committed

through legal entities. The conference focussed on legal and policy related dimensions of this issue and on best practices regarding the prevention of corruption and other financial and economic crimes.
