Criminal Justice Sector/Rule of Law Capacity Building Project: Protecting Intelligence Sources and Witnesses in Terrorism-Related Court Cases

Combining the experience and expertise of the Netherlands Ministry of Security and Justice in counter-terrorism law making and source and witness protection with Asser/ICCT's work on the use of intelligence in terrorism-related court cases and rule of law based approaches to counter-terrorism, this project aims to:

- create a technical and administrative framework for capacity building missions focused on developing or improving an effective and rule of law-based criminal justice sector response to terrorism, specifically aimed at the usage of intelligence and the protection of intelligence sources and witnesses in terrorism-related court cases;
- coordinate and implement four needs assessment missions and two subsequent capacity building missions within the span of 1,5 year;
- · implement evaluation tools and mechanisms to measure the results of the missions; and
- establish within the proposed 1,5 year of operation a solid and effective programme and targeted outreach that attracts external funding for additional missions in similar or related thematic areas during and after the duration of this project.

Human security as a new operational framework for enhancing human rights protection in the EU's Security and Migration policies

In July 2013, the European Union granted funding to CLEER toward its research project, 'Human Security as a new operational framework for enhancing Human Rights protection in the EU's Security & Migration Policies'. The research project runs from 1 September 2013 until 31 August 2014.

The research project is aimed at facilitating academic interaction in closely interrelated areas of EU external conduct, creating synergies between and raising awareness of global security concerns.

Another aim is to take the so-far distinct and separate research areas under one heading and facilitate the establishment of a comprehensive and operational framework contributing to the overall assessment of the EU's role in tackling challenges stemming from emerging crises.

The first conference, organised under this research project was: 'Human security as a tool for a comprehensive approach for human rights and security linkages in EU foreign policy' (6 December 2013). In 2014 the second conference 'Using Human Security as a legal framework to analyse the Common European Asylum System' was organised.

Study on risk assessment and management and prevention of conflicts of interest in the prevention and fight against betting-related match-fixing in the EU28

The research to be carried out by T.M.C. Asser Instituut in cooperation with the Queen's University Belfast will go towards informing policy on the Commission's recommendation.

Georgia – Support to the Constitutional Court Human Dynamics

In March 2014 the EU delegation to Georgia has awarded a contract for the project "Support to the Constitutional Court of Georgia" to the consortium led by Hulla & Co Human Dynamics (Austria). The consortium includes the following partners: T.M.C. Asser Instituti (The Netherlands), DMI Associates (France), Bureau for Institutional Reform and Democracy (BIRD) GmbH (Germany) and Centre for European Constitutional Law (CECL) (Greece).

The purpose of this contract is the Institutional Strengthening of the Constitutional Court of Georgia (CCG). This will contribute to the effectively fulfilment of its functions, e.g. ensure just and highly professional approaches in constitutional review, separation of powers, adjudication upon complaints challenging constitutionality of laws, treaties, by-laws, and regulations vis-à-vis the basic principles of the Constitution of Georgia as well as fundamental rights and freedoms enshrined therein and in international acts.

The overall objective of the project is to strengthen the rule of law and human rights protection in Georgia in line with Georgia's own international commitments.

The specific objective of the project is the Institutional Strengthening of the Constitutional Court of Georgia. Constitutional justice in the modern democratic society is meant to strengthen the principle of separation of powers and the interaction between them. It is also to help resolving the social and political problems by legal means. The review of constitutionality of laws and their applicability according to the constitutional standards and best constitutional practices is vital and mandatory for any constitutional system nowadays.

EC Commission Study to evaluate the Brussels IIbis Regulation - an appraisal of the application in The Netherlands

Asser contributed to a 'Study on the assessment of Regulation (EC) No 2201/2003 and the policy options for its amendment' that is being carried out by Deloitte & Touche GmbH, Hamburg. This multi-country study, commissioned by the European Commission, undertakes to map out the practice of the Member States courts and authorities in relation to the Brussels IIbis Regulation (Regulation 2201/2003). The report drawn up by Michiel de Rooij (Asser Institute) for the Netherlands describes relevant case law for the year 2012 and identifies specific problems which have arisen in the Netherlands with regard to the application of the Brussels IIa Regulation based on case law. The multicountry study of Deloitte & Touche is expected to be completed in 2015.

EU-Study: Mapping the labour status of sportspeople under EU law

In September 2014, the Asser Institute was awarded a contract by the DG Employment of the European Commission to analyse the impact of intra-EU mobility on the labour status of sportspeople under EU and national law.

The study will result in a report describing the labour concept applicable to sportspeople (worker or self-employed person) under EU law, CJEU case law, decisions of Court of Arbitration for Sport (CAS) and national law and jurisprudence in five Member States (Belgium, Croatia, Czech Republic, United Kingdom and Germany). Stock will be taken of the situation and specificities of contractual relationships at national level in five chosen Member States concerning the status of professional footballers. Participate in club championships and the impact of cross-border movement of sporting

professionals on national systems and contractual relationships, will be studied. The distinction between intra-EU free movements of workers (Article 45 TFEU) from cross-border provision of services (Article 56 TFEU) and freedom of establishment (Article 49 TFEU) in the sports sector will be analysed.
