#### **Enrolment and Participation**

- 3. Upon receipt of the completed online registration form, you will be directed to a secure online payment environment.
- 4. Your place in the workshop is confirmed only when the online registration form has been submitted and the payment has been received.
- 5. The registration form constitutes a legally binding agreement. By submitting the completed registration form the registrant declares to be in accordance with the requirements and provisions described therein.

#### **Cancellation Policy**

- 1. Cancellations will only be accepted when your request for cancellation is submitted by e-mail to <a href="mailto:educationtraining@asser.nl">educationtraining@asser.nl</a>.
- 2. You have the right to withdraw your participation within 14 days of completing the payment, and the full sum paid will be reimbursed.
- 3. Once the abovementioned 14-day withdrawal period has expired, if you cancel less than four weeks prior to the starting date of the workshop, no refund of the course fee will be given.
- 4. Once the abovementioned 14-day withdrawal period has expired, if you cancel within the allotted time (at least 4 weeks before the starting date of the course), a processing fee of €50 will be charged. The remaining sum will be refunded.
