Dr Marieke Hopman and/or Dr Roland Moerland go in depth over the theory and practice of using interviews as a research tool. They will cover how to relate interviews to a theoretical framework, how to draw inferences from interviews, the selection of candidates and navigating ethical issues in interviewing.
