



About the Netherlands Network for Human Rights Research

The Netherlands Network for Human Rights Research (NNHRR) was established in 2017 to sustain and further strengthen cooperation in the field of human rights research. The NNHRR has become an essential platform for human rights researchers seeking to establish meaningful contacts and durable links in the Netherlands. The NNHRR is connecting researchers, academic institutions, innovative ideas and outputs, thus generating relevant societal insights. As such, it maintains and strengthens the institutionalized cooperation among human rights researchers in the Netherlands and facilitates the organization of inter-university research and trainings for PhD researchers. It also enhances the visibility of human rights work conducted at Dutch universities nationally and internationally and constitutes a key focal point for academic work focused on contemporary challenges.

One of the priorities of the NNHRR is the maximization of its member's resources by creating spaces for them to learn from each other through meetings, workshops and exchanges. Therefore, the Network has developed the following flagship activities in addition to the Doctoral Research Forum: the Toogdag (annual research day) and training courses for 1st and 2nd year PhD-students as well as for 3rd and 4th PhD-students. In addition, the NNHRR organizes PhD Meet & Greets and informal gatherings for PhD researchers. Finally, thematic activities and events are organized within the Network's three working groups.

About the NNHRR Doctoral Research Forum 2022

The NNHRR Doctoral Research Forum 2022 brings together PhD candidates from Dutch universities who engage in research in the field of human rights. Established in 2021, this year's edition will take place in Groningen in cooperation with the University of Groningen and the Open University. The Doctoral Research Forum aims at giving participants the opportunity to present their work in a collaborative and informal setting, providing PhD candidates with practical tips and career advice, and facilitating interaction between junior and senior members of the NNHRR.

The day will feature three thematic panels, each containing six presentations by PhD candidates at different stages of their respective PhD projects. Each presentation will last 10 minutes, after which a senior Network member will provide the presenter with feedback. Following the presentations, there will be a general Q&A with the audience. We encourage everyone to use this opportunity to give and receive feedback and exchange thoughts with the other participants. The day will be completed by two informative sessions on writing a blogpost and the work of the Netherlands Institute for Human Rights as well as a social activity to get to know your peers in an informal setting.
