13:15 – 14:45 Workshop: 'What's Wrong with Human Rights Activism?' Prof. dr. Wouter Veraart, professor of legal philosophy, VU Faculty of Law

How far should judges and legal scholars go in their defense of human rights and legal activism? Given the fact that almost everywhere the rule of law is under threat, and that lawyers usually care for checks and balances between the different branches of power, this is an urgent question. This workshop tries to navigate a realm of legal activism in which we are witnessing historic court cases addressing climate change and other pressing issues, but also populist attacks on the 'undemocatric' judiciary, which would possess far too much power. Two divergent views of two former top judges on the role of the judge in a democracy, will serve as a starting point in the discussion.
