## **Recent MATRA-Ukraine Activities**

#### Study visit of Ukrainian judges to The Hague

In April 2023, the Asser Institute hosted jointly with USAID a study visit of ten Ukrainian judges to The Hague in an effort to foster cooperation and coordination between the Ukrainian judiciary and national and international judges, practitioners and policymakers.

During the visit, the judges met with representatives from different

justice institutions located in The Hague and held crucial debates on the current Ukrainian context. These included reflections on whether both Ukrainian legal frameworks and its judicial structure are adequate to deal with international crimes, as well as discussions with a view to identify the most pertinent avenues for international assistance to the Ukrainian judiciary.

The BIS-Ukraine contains a comprehensive overview of relevant theoretical and practical information necessary to effectively document international crimes in Ukraine, distributed among three different resources:

1. The BIS-Ukraine Manual, aimed at ensuring the adequate collection and preservation of evidential information by drawing on standards and best practices derived from both Ukrainian and international law.

2. The BIS-Ukraine Guides, summarising the key standards contained in the BIS-Ukraine Manual through short and easily accessible handouts.

3. A forthcoming BIS-KIT mobile app with practical investigative procedures and tips to identify international crimes.

#### Benchbook on the Adjudication of International Crimes under Ukrainian Domestic Law ("Benchbook")

On 22 June 2023, GRC's Ruby Axelson took part in the presentation of the Benchbook. Building on a judicial needs assessment conducted by the USAID Justice for All Activity in July 2022, the Benchbook was developed in close cooperation with USAID, the Ukrainian Supreme Court, the National School of Judges of Ukraine, UpRights and GRC supported by the MATRA

The Benchbook is designed to help promote accountability for international crimes in Ukraine by providing critical support to judicial processes at the national level, strengthening the legal framework and increasing the capacity of courts to draft high-quality and well-reasoned judgments in international crimes cases. By compiling relevant international legal sources, including international treaties, judicial decisions, and academic commentaries, and evaluating their applicability at the domestic level, the publication aims to assist judges in the interpretation and application of the relevant domestic offences.

### Podcast episode on the arrest warrants against Mr. Vladimir Putin and Ms. Maria Lvova-Belova issued by the International Criminal Court

On 6 July 2023, the Asser Institute launched a two-fold episode of the Hague Courts Dialogue Series podcast, hosted by Carl Emilio Lewis (Asser Institute). He was joined by an expert panel composed of Julie Fraser (Utrecht University), Victoria Kerr (Asser Institute), Sergii Masol (University of Cologne), and Owiso Owiso

(freelance international lawyer).

This episode deepened into the legal nuances of thearrest warrants issued by the International Criminal Court against Mr. Vladimir Putin and Ms. Maria Lvova-Belova for crimes committed against children during the conflict in Ukraine. As such, the expert panel discussed, among others, questions of head of state immunity, the choice of charges raised by the International Criminal Court, the relationship between the arrest warrants and the call for a Special Tribunal for the Crime of Aggression, their potential impact on gender stereotypes during conflict, or whether we are witnessing a transformational moment for the International Criminal Court.
