# 2 Projects

## 2.1 Ongoing projects

Regulation Bla: a standard for free circulation of judgments and mutual trust in the EU (JUDGTRUST)

1 November 2018-31 July 2022

This project identifies best practices and provides guidelines in the interpretation and application of Regulation (EU) 1215/2012 on jurisdiction and the recognition and enforcement of judgments in civil and commercial matters (Regulation Bla). The project evaluates to what extent the introduced changes in 2012 (as compared to the then existing Regulation (EC) 44/2001) have achieved the intended aim, what the remaining shortcomings are, and whether further changes are useful. It also examines how legislative projects on the global level and political developments influence the application of the Regulation.

In addition, the project aims at enhancing a general understanding of the autonomous nature of the EU legal sources. It improves the conditions for a more uniform interpretation and application of the Regulation and so promotes mutual trust and efficiency of crossborder resolution of civil and commercial disputes. Research is conducted by the Asser Institute (Vesna Lazić, senior researcher and project leader and Chukwuma Okoli, researcher), in cooperation with Universität Hamburg, University of Antwerp and Internationaal Juridisch Instituut. The project is funded by the Justice Programme of the European Union (2014-2020). Visit the JUDGTRUST website for more information.

#### Strengthening Ukraine's Capacity to Investigate and Prosecute International Crimes 1 July 2020 – 30 June 2024

The aim of this project is to strengthen the capacity of the newly created War Crimes Unit, enhance the expertise of the judiciary and empower CSOs and defence and victim lawyers in Ukraine to more adequately investigate, prosecute, adjudicate and monitor international crimes. This support is extremely timely, as Ukraine is about to ratify the Rome Statute of the International Criminal Court and suffers from a lack of capacity to deal with international crimes, engendered by amongst others the recent reorganisation of the Ukrainian prosecution service.

The project will ensure that this reform process is informed by best (Dutch) practices and expertise to end impunity, and that the main stakeholders, including civil society, are supported to understand and fulfil their own roles in ensuring respect for international law and providing redress and truth to the victims. In the long-term, the project will contribute to an overall increased respect for the rule of law and greater trust by the Ukrainian population in its government. Moreover, it aims to contribute to regional cooperation and for the country to become more resilient towards (pro-)Russian disinformation and geopolitical aims in the Eastern Partnership region.

This project is a joint initiative of the Asser Institute and Global Rights Compliance. It is funded by the Netherlands Ministry of Foreign Affairs under the MATRA (MAatschappelijke TRAnsformatie: social transformation) Programme and supported by the Netherlands Ministry of Justice and Security. #### **Designing International Law and Ethics into** Military Artificial Intelligence

1 September 2020 - 31 December 2024

This project explores the conditions and modalities that would allow for the leveraging of the potential benefits of AI technologies in the military, while abiding by the rule of law and ethical values. It seeks to ensure that technologies developed to assist in decision-making do not in reality substitute for critical judgement by human agents, and thereby remain under human control. An interdisciplinary research team will work in dialogue and together with partners to address the ethical, legal, and technical dimensions of the project. First, research will be conducted on the foundational nature of the pivotal notion of human agency, to unpack the fundamental reasons why human control over military technologies must be guaranteed. Second, the project will identify where the role of human agents must be maintained, to ensure legal compliance and accountability. It will map out which forms and degrees of human control and supervision should be exercised at which stages and over which categories of military functions and activities. Third, the project will analyse how to technically ensure that military technologies are designed and deployed within the ethical and legal boundaries identified.

Throughout the project, research findings will provide solid input for policy and regulation of military technologies involving AI. In particular, the research team will translate results into policy recommendations for national and international institutions, as well as technical standards and testing protocols for compliance and regulation.

Project leader is Berenice Boutin. The project is funded by the Dutch Research Council (NWO) Platform for Responsible Innovation (NWO-MVI). Visit the DILEMA project website.

#### **Bridging the Gap between Formal Processes** and Informal Practices that Shape Judicial **Culture in the Western Balkan**

1 October 2020 - 30 September 2022

The underlying objective of this project is to complement the European Commission's process of vertical judicial Europeanisation with an internal, horizontal, initiative that would combine an academic and practical approach in detecting and noting the main shortcomings of our judicial culture, and through consultations with international and regional experts, outline recommendations for future steps in the Europeanisation of judicial culture. Taking into consideration that changes in judicial culture occur incrementally and through education and training process, the recommendations resulting from this project will be aimed to be incorporated in the process of judicial training. Therefore, the judicial institutions (academies for judges and prosecutors, judicial councils), government institutions dealing with EU integration of the Western Balkan countries, the general and expert public, as well as the European Commission (DG NEAR, DG JUST) are the targets of this project.

The project is coordinated by the Institute for Democracy "Societas Civilis" Skopje (IDSCS) from North Macedonia, in cooperation with the Asser Institute, the Judicial Research Center (CEPRIS) from Serbia, and the Albanian Legal and Territorial Research Initiative (ALTRI). It is supported by the Dutch Fund for Regional Partnership (NFRP)/Matra. The project will be carried out and have impact in Skopje (North Macedonia), Belgrade (Serbia) and Tirana (Albania). Participating Asser researchers are Narin Idriz and Eva Kassoti.

## Private International Law in Motion (PAX)

1 November 2020 - 30 October 2022

The PAX project has been set up as a followup to the JUDGTRUST project. It attempts to achieve a twofold objective: raise awareness

about EU private international law among the educational community and ensure training in EU private international law for the judiciary. The JUDGTRUST project focuses on the Brussels I bis Regulation and aims to ensure its correct and consistent application. One of its components was the launch of a Moot Court Competition to increase students' awareness of its reach and significance. The first EU sponsored Moot Court Competition took place in 2019. The PAX community now includes a large group of students, legal professionals and academics from a wide array of universities. This project seeks to build further upon these first successes and hopes to consolidate these, but also to contribute to ongoing judicial training programmes on civil judicial cooperation in the EU (for instance, in cooperation with the EJTN and in support of other judicial networks).

The Asser Institute is among the 7 partners in the project, which is coordinated by Antwerp University. Participating Asser researchers are Vesna Lazic, Chukwuma Okoli and Michiel de Rooij. The project is funded by the Justice Programme of the European Union (2014-2020) (JUST-AG-2019). Visit the PAX project website.

## Creation of a European Social Charter for Sport Events

#### 1 January 2021 - 31 December 2022

The creation of a European Social Charter for Sports Events will address the topic of good governance in sport at the European level by approaching the theme of social dialogue in the field of sports. The Social Charter will aim to set policy in terms of social dialogue in the sport field by producing a basis on which European sports event organisers can rely on and benefit from the sustainable positive aspects produced by their sport events. The Charter will be suitable for all sports events organised throughout Europe. Antoine Duval (Asser Institute) will lead the analysis of the social framework in the organisation of sport events in Europe. The analysis will include research on previous commitments in this context and

their limits. This study should clarify the existing needs for organisers of sports events at the European level. The project receives financial support under the EU's Erasmus+ Programme (Collaborative Partnerships).

#### Endowed Chair in Arms Control Law 1 September 2021 - 1 April 2025

In 2020, we received a 5-year grant for an Endowed Chair and post-doc on International Arms Control Law. It entails an extraordinary chair (at the University of Amsterdam, UvA) and a post-doc in International Arms Control Law, both based at the Asser Institute in The Hague. The emphasis is on Arms Control Law regarding nuclear, chemical and biological weapons of mass destruction (including non-proliferation), CBRN (Chemical Biological Radiological Nuclear) safety in general, and nuclear security. This is an initiative undertaken in collaboration with the UvA and financed by the Ministry of Foreign Affairs. Prof. Thilo Marauhn was appointed chair and took office on 1 September 2021. This chair and the ensuing national and international research network will form the basis for a new knowledge hub on International Arms Control Law at Asser in The Hague.

#### The Challenge of Populist Memory Politics for Europe: Towards Effective Responses to Militant Legislation on the Past (MEMOCRACY)

1 October 2021 - 30 September 2024

The MEMOCRACY project will examine the proliferation of the nation-centric governance of memory through laws and policies in Germany and selected countries of Central and Eastern Europe (CEE). The study will also unpack the relationship of this memory governance with rising populism and the erosion of fundamental democratic rights in the region. Employing the concept of 'memocracy', meaning 'ruling on the basis of memory', the study seeks to shed light on how particular abuses of memory laws and policies can undermine common European

values such as democracy, fundamental human rights and the rule of law as well as to facilitate a move towards authoritarianism, in particular, in CEE. Furthermore, the project aims to raise awareness about the inherent dangers of these laws and policies while also upholding liberal democratic standards in all the Member States of the European Union (EU) and the Council of Europe (CoE). The project is led by Prof. Angelika Nußberger (former judge at the European Court of Human Rights and Professor of Law at the University of Cologne), and carried out by Uladzislau Belavusau (Asser Institute), Dr. Maria Mälksoo (Senior Researcher at the Centre for Military Studies, University of Copenhagen), and Dr. Aleksandra Gliszczynska-Grabias (Assistant Professor at the Institute of Law Studies of the Polish Academy of Sciences). The project has received funding from the Volkswagen Foundation, as part of the 'Challenges for Europe' programme.

## 2.2 New projects

#### **ELSA Lab Defence**

1 June 2022 - 31 May 2026

The ELSA Lab Defence is a public-private initiative addressing ethical, legal, and societal issues by developing a future-proof, independent, and consultative ecosystem for the responsible use of AI in the defence domain. The project sets out to develop a methodology for context-dependent analysis, design and evaluation of ethical, legal and societal aspects of military AI-based applications. It will build upon existing methods for value-sensitive design, explainable algorithms and humanmachine teaming. The lab also studies how society and defence personnel perceive the use of military AI, how this perception evolves over time, and how it changes in various contexts. The lab is funded by NWO and led by TNO: Berenice Boutin represents the Asser Institute as one of the nine consortium members.

#### Study on the Potential of Big Data Technologies for the Due Diligence Process

7 October 2022 - 7 April 2023

Commissioned by the Deutsche Gesellschaft für Internationale Zusammenarbeit (GIZ), the assignment will investigate the potential of big data technologies for the implementation of human rights and environmental due diligence. It will aim to bring together recent developments i.e., on the one hand, the rapid diffusion of the human rights and environmental due diligence (HREDD) process as the expected standard of action for businesses involved in transnational economic activities; and, on the other hand, the growing role of technology, and in particular big data and artificial intelligence in managing supply chains. The main objective is to elucidate the current use of such technologies to support HREDD and to offer credible predictions of their long-term potential in this regard. The study is undertaken by Antoine Duval (senior researcher) and Virginie Rouas (researcher).

## Satellite Imagery as Evidence in International Justice Proceedings

1 November 2022 - 31 October 2023

Images acquired by satellites have become key sources of information and evidence within the international criminal justice system. Yet, their use remains hampered by the lack of technical proficiency among legal professionals on one hand and by the unfamiliarity with the legal field among satellite imagery experts on the other. The project addresses this knowledge gap by developing a focused training programme for staff and legal professionals involved in proceedings of the International Criminal Court (ICC). The training will provide expertise in the field of international criminal justice and evidentiary processes, as well as guidance on necessities for content preparation and assistance with delivery from satellite imagery experts, namely from the United Nations Satellite Centre (UNOSAT).

This project is a collaboration with UNITAR/ UNOSAT and receives financial support from the Geneva Science-Policy Interface through the 2022 edition of the Impact Collaboration Programme. Christophe Paulussen represents the Asser Institute.

## Private International Law in Motion 2.0 (PAX 2.0)

#### 1 November 2022 - 31 October 2024

PAX 2.0 combines a number of educational and training activities to ensure a better understanding and application of the main legal instruments in civil justice. The project therefore intends to combine the components of the earlier JUDGTRUST and PAX projects that have proven their worth -i.e. the moot court and partnership with the judiciary-with two new elements: a particular focus put on the further extension of the moot court to student teams from third countries and the development of a guide on the organisation of moot courts on EU private international law that would make the expertise gained in our earlier projects available to the Commission through a practical manual. Ideally, this manual would be made freely accessible online.

A further essential element of PAX 2.0 is that the moot courts and judicial training will focus on topical issues of EU private international law, which should ensure improved knowledge of those legislative instruments that are new and/or raise new legal questions.

The Asser Institute is among the 7 partners in the project, which is coordinated by Antwerp University. Participating Asser researcher is Vesna Lazic. The project is funded by the Justice Programme of the European Union (2021-2027) (JUST-2022-JCOO). Visit the PAX project website.

#### Foreign Fighters in Ukraine

#### 1 September 2022 - 31 August 2023

This project seeks to better understand the foreign fighting phenomenon in both past and present iterations; a phenomenon which continues to confound policy makers and society at large. It also focuses on interventions that seek to redress (moral) injuries, allowing those affected by conflict to resume their lives. The project does so by engaging in multidisciplinary cooperation and by employing a historical-comparative approach. Moreover, this project will not only aid in the scientific understanding of current events, but also to past and future instances of foreign fighting by adding unique research materials (interviews) and by combining various disciplines including history, law, and psychiatry. Societal stakeholders are ARQ Nationaal Psychotrauma Centrum, ARQ Kenniscentrum Oorlog, Vervolging en Geweld, and the Nederlands Veteraneninstituut. The project is funded by the Dutch National Research Agenda (Nationale Wetenschapsagenda) and led by the UvA; Christophe Paulussen represents the Asser Institute as one of the five consortium members.

## 3 Knowledge dissemination

# 3.1 Annual T.M.C. Asser Lecture

In 2015, on its 50thAnniversary (1965-2015), the Asser Institute launched the Annual T.M.C. Asser Lecture on the development of international law. The Lecture has been established in honour of the Dutch jurist and Nobel Peace Prize Laureate, Tobias Michael Carel Asser (1838-1913), and his significant contributions to the development of public and private international law.

# The seventh Annual T.M.C. Asser Lecture: Europe in the world: the emergence of collective power Europe?

10 May (in-person)

On May 10, in a packed Peace Palace in The Hague, Annual T.M.C. Asser Lecture speaker and political scientist Professor Brigid Laffan addressed the European dependencies and vulnerabilities in relation to the war in Ukraine, and in the context of a hardening of geopolitics. According to Laffan, current conceptions of the EU as a normative power and market power have become insufficient. Laffan explained how the concept of 'Collective Power Europe' (CPE) can open a conceptualisation of the EU as a global actor that is 'not a scaled-up version of the nation state, but one that focuses on action and outcomes and on the capacity generated by the collective and the member states'. Professor Laffan called for the EU to hasten its energy transition, as energy dependence is a dangerous vulnerability. Laffan thinks that it is worth for

European member states to borrow collectively to manage the transition and to ensure that the energy transition is a just one. Prior to the Lecture, Asser researchers Eva Kassoti and Narin Idriz, project leaders of the Global Europe project, interviewed Professor Laffan for international law blog Opinio Juris.

Emerita Professor Brigid Laffan is an internationally recognised expert on the European Union. She was director and Professor at the Robert Schuman Centre for Advanced Studies and director of the Global Governance Programme at the European University Institute (EUI), Florence. In the last eight years, Laffan has been the convenor of the State of the Union, the annual summit for high-level reflection on the European Union, which acts as a bridge between academia and policy making at the highest level in Europe. In 2018, Politico ranked Laffan, a long time Professor of political science who grew up in Ireland, among the women who shape Europe. Laffan is a leading thinker on the dynamic of European integration. She has published a number of important books on Europe, such as Integration and Co-operation in Europe (1992), The Finances of the Union (1997), Europe's Experimental Union - Re-thinking Integration (2000, co-authored), Core-periphery Relations in the European Union (2016, co-edited) and Europe's Union in Crisis: Tested and Contested - West European Politics (2016). Brigid Laffan was awarded the THESEUS Award for outstanding research on European integration, and the UACES Lifetime Achievement Award. In 2010, she received the Ordre national du Mérite by the President of the French Republic.

# 3.2 Conferences, workshops, seminars

### The Russian Invasion of Ukraine: international legal implications

8 March (in-person)

The event was held in The Hague Humanity Hub and opened discussions regarding the international legal implications of Russia's invasion in Ukraine. It welcomed experts in international law to address and explain questions on the legal options the international community has for responding to the grave situation in Ukraine. Questions regarding the role of international law in this conflict include current violations in international law, the legal options under the United Nations, individual accountability for actions in Ukraine, the possibility of Putin to be tried and for what crimes and mechanisms, and the legal instruments available to stop the threat of nuclear war. The event was moderated by Dr Carl Emilio Lewis (Asser Institute) and the speakers included Dr Uladzislau Belavusau (Asser Institute), Prof. Dr Thilo Marauhn (Asser Institute), Victoria Kerr (Asser Institute), Sergey Vasiliev (University of Amsterdam), Marten Zwanenburg (University of Amsterdam), and Iryna Hnasevych (Jagiellonian University).

# [Conference] Law and ethics of artificial intelligence in the public sector: from principles to practice and policy

10-11 March (online)

The online conference addressed the multiple challenges raised by the increasing use of Al in the public sector. These include domains such as healthcare, energy, welfare, border security, criminal justice, law enforcement, and defence. The conference resulted in an interdisciplinary dialogue generating insights on the principles, conditions, and methods which facilitated the responsible deployment of Al in the public sphere. More precisely the ethical,

legal, technological, and policy aspects to develop solutions regarding AI challenges were elaborated upon. It brought together scholars from different fields (cognitive scientists, social and political scientists, legal scholars), but also actors from the justice system and policy makers. The two-day event was a journey from the inside to the outside, starting on day one with topics such as algorithmic decision making in public administration, approaches to regulation and accountability, and data and discrimination. On day two, the topics addressed included responsible AI in research, education, and work, and AI in police, justice, and security. The conference was convened by Dr Berenice Boutin (Asser Institute), Dr Machiko Kanetake (Utrecht University), Dr Carl Emilio Lewis (Asser Institute), Dr Giovanni Sileno (University of Amsterdam), and Dr Sadjad Soltanzadeh (Asser Institute). A call for papers was put out in preparation of the conference to stimulate critical reflections and generate innovative approaches towards establishing a solid legal, ethical, and technical framework for the development and use of AI by governments and public institutions. This initiative received financial support from the KNAW (Royal Netherlands Academy of Arts and Sciences) under the Academy Early Career Partnerships Awards.

### Rule of law challenges in the Western Balkans and the way forward

29 March (online)

The online event focussed on recent reforms and rule of law challenges in the Western Balkans which include nations such as Albania, Montenegro, North Macedonia, and Serbia. In particular, the event raised the role of the European Union safeguarding the rule of law central to the accession process, the geopolitical rivalries in the Western Balkans and how these challenges are perceived by the Netherlands, as one of the founding members of the EU. The event was moderated by Dr Narin Idriz (Asser Institute) and has invited an esteemed panel of speakers which include Dr Fjoralba Caka

(Tirana University), Dr Denis Preshova (SS. Cyril Methodius University and the Institute for Democracy, Skopje), Mirko Đuković (Max Planck Institute for Comparative Public Law and International Law), Milan Antonijević (Lawyer), and Thijs Reuten (Member of the European Parliament, Group of the Progressive Alliance of Socialists and Democrats). The event was organised in the context of the Global Europe project. The organisation of this event was supported by the Embassies of Albania, North Macedonia, and Serbia in The Hague, and the Montenegrin Representation to the EU in Brussels.

### [Workshop] Global Justice Cinema 13-14 April (in-person)

The Global Justice Cinema workshop challenges participants to critically watch, assess, and discuss what films communicate and how this is achieved, especially where it concerns human rights. Moreover, participants had the opportunity to see the latest international rights films, including the chance to meet and interact with the filmmakers and activists at the Movies that Matter Festival venue. In this way, the workshop offered the best of the world of global justice and the world of documentary film. The workshop included guest speakers such as Professor Wouter Werner (VU Amsterdam), film director Olivia Martin-McGuire, and producer Brooke Silcox. The event was coordinated by Dr Sofia Stolk (Asser Institute) and organised in collaboration with VU Amsterdam and the Movies that Matter Festival.

[Conference] Regulation Brussels la: a standard for free circulation of judgements and mutual trust in the European Union (JUDGTRUST) 21-22 April (hybrid)

The conference concluded the three-year JUDGTRUST project period and examined the correct and consistent application of Regulation (EU) 1215/2012 on jurisdiction and

the recognition and enforcement of judgements in civil and commercial matters (Bla Reg or the Regulation; priority code: BRUSSELS Ibis). The research findings of the project have been presented and the conference provided an opportunity to share knowledge between academics, legal practitioners, and legislators on how to achieve a greater consistency between various instruments for the enhancement of legal certainty, predictability, and access to justice in cross border legal transactions. The two-day conference and the resulting publication addressed the following: (1) the interpretation of the revised Regulation; (2) major difficulties in the application and interpretation of the Bla Reg by the courts in the EU member states - comparative view; (3) consistency within the European private international law system - comparison with the approaches taken in the Regulations (indicated supra, under 1.1) – which lessons can be learned? And (4) presented as part of the analysis/research outcome, possible solutions for the problems identified modelled along the lines of legal regulation in other legal instruments. The JUDGTRUST project was funded by the European Commission, DG Justice and organised in partnership with Universität Hamburg, University of Antwerp, and Internationaal Jurisdisch Instituut (IJI). The JUDGTRUST project was coordinated by Dr Vesna Lazić (Asser Institute).

[Expert Panel Discussion] Transnational civil litigation and corporate liability: Mexico v Smith & Wesson

2 May (hybrid)

The Mexican Embassy in The Hague — in collaboration with the Asser Institute and the University of Amsterdam — organised an indepth discussion on the transnational litigation implications of the ground-breaking case of Mexico v. Smith & Wesson, which was filed last August in the District Court of Massachusetts. Issues of jurisdiction, admissibility and applicable law related to Mexico's seizing of the U.S. court system, as well as corporate liability

were discussed in greater detail. The panel covered the obligations of companies in respect to damage involving their products occurring across borders, including obligations arising out of international human rights law, international humanitarian law, and the law relating to arms trade. The event was opened and introduced by H.E. Mr. José Antonio Zabalgoitia (Ambassador of Mexico to the Kingdom of the Netherlands), Dr León Castellanos-Jankiewicz (Asser Institute), Prof. Dr Thilo Marauhn (Asser Institute) and Alejandro Celorio Alcántara (Principal Legal Adviser to the Mexican Ministry of Foreign Affairs). The expert panel included leading experts from an array of universities. The event was organised within the framework of the Netherlands Network for Human Rights Research and supported by the Royal Netherlands Society of International Law (KNVIR).

### [PhD Workshop 2022] Methodologies in sociotechnical research

10-11 May (in-person)

The PhD Workshop on methodologies in sociotechnical research aimed to foster dialogue and peer-to-peer exchange on developing methodologies regarding socio-technical research. It provided a forum to discuss the opportunities and challenges of this form of research. The workshop was organised for PhD researchers from diverse fields (e.g., law, philosophy, media and communication studies, social studies, international relations and politics, computer sciences, systems engineering) that take different approaches to studying socio-technical phenomena. The workshop promoted discussion between researchers drawing on diverse technologies such as socio-legal approaches, law 'and' approaches studies, post-humanism, postphenomenology, value-sensitive design, cognitive work analysis, human-centred design, human factors/ergonomics and cybernetics. On day one, participants took part in parallel workshop sessions, introduction to problem-solving exercise, and interactive

interdisciplinary research problem-solving exercise. On day two, further interactive interdisciplinary research problem-solving exercises and a plenary session was conducted. The workshop was coordinated by Klaudia Klonowska and Taylor Woodcock (Asser Institute).

# [Conference] Corporate crimes and international criminal law – moving beyond the Nuremberg Paradigm

18 May

This conference critically reflected on the evolution of individual and corporate criminal accountability for international crimes since Nuremberg. The event highlighted recent developments regarding the criminal liability of corporations and corporate officers for international crimes; and discussed the role of the International Criminal Court (ICC) and national jurisdictions in moving forward the agenda of corporate accountability for international crimes. The conference was jointly organised by the European Centre for Constitutional and Human Rights (ECCHR), the T.M.C. Asser Instituut and Amnesty International's Corporate Crimes Project. Speakers included: Rasheed Alfagih (Mwatana for Human Rights) and Dr Miriam Saage-Maaß (ECCHR). The online gathering was initiated by Dr Antoine Duval (Asser Institute).

# [Event] Martti Kosenniemi's 'To the uttermost parts of the earth': a discussion with the author 19 May (online)

The Asser Institute welcomed Martti Koskenniemi, Professor of international law (University of Helsinki), and director of the Erik Castrén Institute of International Law and Human Rights to discuss his latest book, 'To the uttermost parts of the earth': Legal imagination and international power 1300-1870 (Cambridge University Press, 2021). The book tracks the rise of modern European statehood through the ideas of sovereignty and property rights and

explains how they were harnessed to deploy and consolidate European empires overseas. His book serves as a prequel to his work on The gentle civilizer of nations: The rise and fall of international law 1870-1960 published in 2001. Martti Koskenniemi was joined by Asser Institute's academic director Professor Janne E. Nijman, Dr León Catellanos-Jankiewicz and Dr Geoff Gordon.

[Book Launch] Seminar on interdisciplinary approaches to make sense of legal practices and discourses in international law 2 June (in-person)

The Asser Institute and VU Amsterdam jointly organised a seminar on monographs by Dr Sofia Stolk (Asser Institute), Dr Lianne Boer and Prof. Dr Wouter Werner (VU Amsterdam). The seminar launched three recently published books which include: (1) Lianne Boer, International Law as we Know It: Cyberwar Discourse and the Construction of Knowledge in International Legal Scholarship (Cambridge University Press 2021); (2) Sofia Stolk, The Opening Statement of the Prosecution in International Criminal Trials: A Solemn Tale of Horror (Routledge 2021); (3) Wouter Werner, Repetition and International Law (Cambridge University Press 2022). The foregoing books grew out of cooperation between the Asser Institute and VU Amsterdam. While different in topic, style and method, they share an interest in themes such as aesthetics, style, narration, and the power of the irrational in international law. All three books, therefore, take excursions to other disciplinary fields to make sense of legal practices and discourses in international law. The seminar did not discuss the exact detail of all three books, instead discussants have been invited to elaborate on future perspectives. What could these books mean in terms of new research questions, new directions and approaches of making sense of international law? Speakers included Professor Sarah Nouwen (European University Institute, Florence), Dr Katja Freistein (Centre for Global Cooperation Research/University DuisburgEssen) and Prof. Dr Ingo Venzke (University of Amsterdam). The event was moderated by Dr Geoff Gordon (Asser Institute).

### [Event] Europeanisation of judicial culture in the Western Balkans

21 June (in-person)

The event presented the findings of the MATRA project 'Bridging the gap between formal processes and informal practices that share judicial culture in the Western Balkans'. It elaborated on the main research results that combine an academic and practical approach to finding the main shortcomings of judicial culture in three target countries in the region, namely, Albania, North Macedonia, and Serbia. The project aims to complement the European Commission's process of judicial Europeanisation and is a collaboration between the Institute for Democracy (IDSCS), Albanian Legal and Territorial Research Institute (ALTRI), Judicial Research Centre (CEPRIS) and the Asser Institute. Speakers included Dr Narin Idriz (Asser Institute), Zoran Necev (IDSCS), Dr Denis Preshova (Ss. Cyril and Methodius University/ IDSC), Dr Fjoralba Caka (Tirana University/ ALTRI), and Professor Tanasije Marinkovic (University of Belgrade/CEPRIS).

# [Book Launch] The ecology of war and peace: marginalising slow and structural violence in international law

24 June (in-person)

The book launch was co-organised by the Amsterdam Center for International Law (ACIL) and the Asser Institute. The author of the book, Eliana Cusato, is a Marie Skłodowska-Curie postdoctoral research fellow at ACIL. Her research explores the interrelation of political ecology/economy, violence, and conflict in the theory and practice of international law. Her interests also include legal questions raised by the unequal distribution of natural resources, environmental justice, and human rights and global extractives. Her book draws

upon environmental justice perspectives and other theoretical traditions, the book unpacks and problematises some of the assumptions that underlie the legal field. Additionally, the book analyses the practice of international courts, the UN Security Council, and the Truth Commissions, and conveys how international law silences and even normalises forms of structural and slow environmental violence. The book launch was moderated by Prof. Dr Ingo Venzke (University of Amsterdam) and included a panel of speakers: Judge Hilary Charlesworth (International Court of Justice), Dr Sofia Stolk (Asser Institute), and Dr Marie-Catherine Petersmann (Tilburg University).

### The Forum of Legal Actors

4-6 October (in-person)

The Asser Institute, UNESCO, Free Press Unlimited and the Netherlands Ministry of Foreign Affairs, co-organised the second edition of the Forum of Legal Actors on freedom of expression and safety of journalists from 4 to 6 October at the premises of the Asser Institute. The Forum brought together 40 judges, prosecutors, lawyers, academics and representatives of legal institutions to exchange views and share best practices on specific topics related to the protection of freedom of expression and the safety of journalists, drawing on global, regional and national experiences across Latin American, Africa and Europe. The event featured presentations by high-level speakers, leading specialists and scholars, addressing the issues topical for Francophone Africa and Latin America, thus providing for a live platform that enabled the two regional groups to establish channels for the exchanges of experiences. The sessions analysed current trends and emerging challenges of freedom of expression, safety and protection of journalists, the role and independence of the judiciary, ways to improve cooperation between civil society actors, judiciary and media, as well as the regional jurisprudence from Africa and Latin America. The Forum was launched on December 9<sup>th</sup> 2020 as part of the online World Press

Freedom Conference hosted from the World Forum in The Hague. The event was coordinated by Dr Uladzislau Belavusau and funded by the Netherlands Ministry of Foreign Affairs.

# ISLJ Conference 2022–Transnational sports law and governance in turbulent times 25-26 October (hybrid)

The Asser Institute hosted the 2022 edition of the International Sports Law Journal (ISLJ) Conference. The conference dealt with several complex issues and disputes on the top of the transnational sports law agenda. The conference was structured around five panels spread over in the span of two days: (1) reforming the governance of sport with a little help of competition law; (2) transnational sports law meets international law; (3) competition law and sport in comparison: national experiences; (4) international sports law & governance at the intersection with human rights; and (5) restoring PRIDE in sports in South Asia: case studies of queer and trans representation in Thailand, Singapore and India. Speakers of the ISLJ conference included Professor Jonathan Grix (Metropolitan Manchester University), Dr Nataliia Mazaraki (Kyiv National University of Trade and Economics & Max Planck Institute for Innovation and Competition), Alessandro Marinaro (Graduate Institute of International and Development Studies), and Mary Harvey (CEO of the Centre for Sport and Human Rights). The event was organised by Dr Antoine Duval (Asser Institute) and Professor Johan Lindholm (Umeå University).

[Discussion] The private side of transforming our world - UN Sustainable Development Goals 2030 and the role of private international law

7 December (hybrid)

The Asser Institute and the Royal Netherlands Society of International Law hosted a discussion on the seminal book *The Private* Side of Transforming our World – UN Sustainable

Development Goals 2030 and the Role of Private International Law which was edited by Ralf Michaels, Verónica Ruiz Abou-Nigm and Hans van Loon and published in November 2021 by Intersentia. The seminal book is the first volume to engage with the intersection between the SDGs and private international law. The event aimed to debate the main questions raised by this volume and, some of its chapters. The discussion started with a general introduction to the book and the ambition of the editors and was followed by a discussion about the two chapters, dedicated to SDG 6 (clean water and sanitation) and SDG 11 (sustainable cities and communities). Speakers included Professor Richard Frimpong Oppong (author of chapter on SDG 6, California Western School of Law, San Diego & Ghana Academy of Arts and Sciences) and Dr Klaas Hendrik Eller (author of chapter on SDG 11, University of Amsterdam). The following commentators provided feedback during the discussion: Professor Liesbeth Enneking (Erasmus University Rotterdam), Dr Lucas Roorda (University of Utrecht), Dr Carlo M Colombo (Maastricht University), and Dr Lucy Reimers (Graduate Institute of International and Development Studies). The event was moderated by Marta Pertegás (Maastricht University) and Dr Antoine Duval (Asser Institute).

# [Book Launch] How effective are international courts and tribunals in protecting the environment?

### 8 December (in-person)

This lecture was organised to celebrate the launch of the Asser Press publication *The Environment Through the Lens of International Courts and Tribunals*. The book examines the strengths and weaknesses of different international judicial and arbitral fora with respect to the settlement of environmental disputes and contrasts their role with that of other means of enforcing international obligations in the sphere of environmental law, such as treaty compliance mechanisms and national courts. The lecture allowed for debate

between leading practitioners and scholars on the promise (or otherwise) of the international resolution dispute system to protect our planet and deliver justice for those most affected by environmental crises. Speakers included H.E. Mr. Philippe Couvreur (International Court of Justice), Dr Mamadou Hébié (Leiden University), Sarah Mead (Climate Litigation Network), and Sumeyra Arslan (previous Centre for International Environmental Law).

# Roundtable Discussion] Governing European football: what role for the European Union? 16 December (in-person)

The roundtable event was co-organised by the Globalization & Law Network (GLawNet) and the Asser Institute one day after the publication of the Opinion of Advocate General Rantos in the European Super League (ESL) case. The event gathered academics and stakeholders to reflect on the role played by the EU (primarily through 'negative integration'), as well as the role it ought to play (possible through 'positive integration'), in determining the way football is governed. The event took place at the Campus Brussels of Maastricht University. The programme was opened by Mariolina Eliantonio (Maastricht University), followed by a roundtable discussion moderated by Carlo Colombo (Maastricht University). The following speakers partook the panel discussion: Dr Antoine Duval (Asser Institute), Benoit Keane (Keane Legal), Alexander Bielefeld (FIFPro), and Arnout Geeraert (Utrecht University).

### 3.3 Research Seminars

### Towards non-extractive work relations: lessons from worker cooperatives

3 March (online)

Dr Vladimir Bogoeski a postdoctoral researcher in the N-EXTLAW project and member of the Amsterdam Centre for Transformative Private Law (ACT) presented his paper titled *Towards* non-extractive work relations: lessons from worker cooperatives, co-authored by Andrea Iossa (Kristianstad University) and Miriam Kullmann (VU Amsterdam). The article argues that worker cooperatives provide valuable lessons on alternative ways of organising labour and economic activity overall. In addition, the article debates that the values inherent to the worker cooperative model endow working members with governing power over the production process as well as real influence over the distribution of benefits generated through that process and the overall relation of that economic activity to society and environment. The article also considers the challenges demonstrated by the degeneration theory and points to some cooperative relatives where the above ideas are abused to the determent of working members, depriving them of basic worker rights.

#### Citizenship Renvoi

### 7 September (hybrid)

Dr Péter Szigeti is an Assistant Professor at the University of Alberta. He received his SJD from Harvard Law School in 2015 and began teaching at the Faculty of Law of the University of Alberta in September 2018. He has held postdoctoral positions at New York University, McGill University and the European University Institute; and holds and LL.M. from Harvard Law School (2008), a Master 2 recherche from Université Paris I (2006), and a bachelor's degree in Hungarian law from ELTE University, Budapest (2005). His paper titled Citizenship Renvoi addresses whether states

can apply other states' nationality laws and if states can declare that such a person is in fact or could easily become the citizen of another state – against the second state's claims. His paper argues that some starts are in fact doing this, a phenomenon that he calls 'citizenship renvoi'. The paper also deals with discrimination toward certain ethnicities and nationalities, who sometimes enjoy extended protections from third countries and how it threatens to make refugee protection impossible for all but the poorest applicants, once the rapidly spreading practice of citizenship-for-sale programs are factored in.

### 3.4 Lectures

### 3.4.1 SCL lectures

The Supranational Criminal Law (SCL) Lecture Series is a lecture series on international criminal law and has been organised by the Asser Institute since 2003, in cooperation with the Grotius Centre for International Legal Studies of Leiden University (Campus The Hague) and the Coalition for the International Criminal Court (CICC).

### [SCL Lecture] Environmental harm and international criminal law

14 December (in-person)

The year of 2022 marked the 50th anniversary of the 1972 Stockholm Declaration. With the threat of anthropogenic harm becoming clearer each year, it is imperative to explore legal means to tackle severe damage to the environment. The ICC has signalled that it will place emphasis on prosecuting the most egregious incidents of environmental destruction. Experts have suggested adding the crime of ecocide to the court's statute. However, the ICC is subject to jurisdictional limits that restrict its ability to adjudicate ecocentric cases. This lecture

focused on the possibility of using judicial proceedings to establish responsibility for serious environmental harm (including ecocide) under international criminal law. The event was moderated by Christophe Paulussen (Asser Institute) and the keynote presenter was Matthew Gillet (Senior Lecturer at the University of Essex and a UN Special Mandate holder on the Working Group on Arbitrary Detention). The respondent speakers were Phoebe Okowa (Queen Mary University, University of London and the International Law Commission), Larissa van den Herik and Daniëlla Dam-de Jong (Grotius Centre for International Legal Studies, Leiden University), Stavros Evdokimos Pantazopoulos (Asser Institute and Law Interest Group of the Environmental Peacebuilding Association), and Rosario Salvatore Aitala (ICC). This lecture is organised in collaboration with the International Union for Conservation of Nature World Commission on Environmental Law (IUCN WCEL) Environmental Security and Conflict Law Specialist Group and the International Humanitarian and Criminal Law (IHCL) Platform.

### 3.4.2 HILAC lectures

The Hague Initiative for Law and Armed Conflict (HILAC) Lecture Series is an occasional lecture series about law and armed conflict organised by the Asser Institute since 2005. The lectures are organised in cooperation with the Netherlands Red Cross and the Amsterdam Center for International Law of the University of Amsterdam.

### [HILAC Lecture] Expert manuals in international humanitarian law

26 September (hybrid)

This HILAC event launched the new volume of the Yearbook of International Humanitarian Law (YIHL) which focuses on the role of 'expert manuals' in the interpretation and development of international humanitarian law, as well

as, connected branches of international law relating to military operations. The lecture was opened by Dr Stavros Pantazopoulos (Asser Institute; managing editor, YIHL); after which introductory remarks by the authors: Dr Heather Harrison Dinniss (Swedish Defence University) and Alfons Vanheusden (International Society for Military Law and the Law of War). Additionally, comments were presented from the editors of the YIHL: Professor Terry Gill (University of Amsterdam; former Editor-in-Chief, YIHL), Professor Pablo Kalmanovitz (Instituto Tecnológico Autónomo de México in Mexico City), and Professor Eliav Lieblich (Tel Aviv University). The closing remarks were presented by Professor Heike Krieger (Freie Universität Berlin, Editor-in-Chief, YIHL), Dr Christophe Paulussen (Asser Institute; former managing editor, YIHL and coordinator IHCL Platform), Frank Bakker (T.M.C. Asser Press), and Professor Terry Gill. The HILAC lecture was organised in collaboration with the IHCL Platform.

### 3.4.3 CLEER Events

The Centre for the Law of EU External Relations (CLEER), coordinated by the Asser Institute, has offered a platform for discussion and implemented various activities to connect those interested in the EU's actions on the global plane since 2008. As of 2011, a special lecture series focuses on the role of the incumbent presidencies in coordination and leadership in regional and global issues.

[CLEER Conference] Comprehensive security: The EU's strategic autonomy from a practical legal perspective

21 October (hybrid)

The CLEER Conference was organised in cooperation with the General Court of the European Union and the Department of European Economic Law of the University of Groningen. The conference aimed to explore the different legal dimensions as well as the

practical legal questions related to 'strategic autonomy'. The conference approached 'security' - a core idea underpinning it - in a more comprehensive fashion. Security questions are not only relevant in military terms, but also present themselves in areas such as energy policy, data protection, sanctions, extraterritorial effects of foreign law, investment policy, or public procurement. The event was therefore structured around a roundtable on member state's perspectives on European security and three topical panel discussions and brought together academics as well as practitioners working at, inter alia, courts and tribunals, ministries, embassies and law firms. Key speakers included Professor Marc van der Woude (President of the General Court of the EU), H.E. Ms Frances Lanitou (Ambassador of the Republic of Cyprus), H.E. Mr Ilkka-Pekka Similä (Ambassador of Finland), Babs Kamsteeg (Dutch Ministry of Defence), Professor Federico Casolari (University of Bologna), Professor Peter van Elsuwege (Ghent University), and Professor Josephine van Zeben (Wageningen University). The CLEER conference was coordinated by Dr Eva Kassoti (Asser Institute).

### 3.4.4 Doing Business Right events

The 'Doing Business Right' (DBR) events aim at discussing innovative fundamental legal research connected to the regulation of transnational corporations. It hosts presentations by leading scholars on emerging legal topics. The DBR events bring together an audience of academics, practitioners and stakeholders to disseminate crucial findings among relevant audiences, to bridge the gap between theory and practice, and to initiate a conversation on the research of responsible business conduct.

### Expert meeting on business and human rights arbitration

12 April (in-person)

The expert meeting was hosted by the Asser Institute with the support of the Working Group on the Hague Rules (WG). The meeting aimed to bring together a wide range of key stakeholders to discuss the potential of arbitration regarding business and human rights (BHR) disputes in a variety of constellations including ad hoc direct business-rightsholder issues or in a contractual relations context. The expert meeting was divided in three sessions. In the first, the WG provided a brief introduction to the background, drafting process and salient aspects of the Hague Rules on Business and Human Rights Arbitration. In the second session, a diverse set of invited speakers shared short reflections on the advantages and drawbacks of arbitration in the BHR context. In the final round-table, the discussion focused on the implementation of the Hague Rules, starting with a presentation from the WG members on the main achievements and challenges so far. The meeting was followed by an exchange of views with invited participants regarding the future of the Hague Rules and their limits. The event was coordinated by Dr Antoine Duval (Asser Institute) and speakers included Professor Martijn Scheltema and Professor Jan Eijsbouts.

### 3.4.5 DILEMA Events

The DILEMA (Designing International Law and Ethics into Military AI) project explores interdisciplinary perspectives on military applications of artificial intelligence (AI), with a focus on legal, ethical, and technical approaches on safeguarding human agency over military AI. It analyses subtle ways in which AI can affect or reduce human agency, and seeks to ensure compliance with international law and accountability by design. An interdisciplinary research team works in dialogue and together with partners to address the ethical, legal, and technical dimensions of the project. Within the framework

of the project, the Asser Institute organised several events. The project is funded by the Dutch Research Council (NWO) under the research programme 'Responsible Innovation. Designing for Public Values in a Digital World'.

### [Book Launch Symposium] The role and impact of technologies on human activities

8 June (in-person)

The Asser Institute and the DILEMA project hosted a book launch symposium around the published manuscript of Dr Sadjad Soltanzadeh, Problem-Solving Technologies: A User-Friendly Philosophy (Rowman & Littlefield Publishers, 2022). As technologies become ubiquitous in our everyday personal and social life, it is essential to understand the role and impact of technologies on human activities. Against the background of discussions on approaches to ethics and philosophy of technologies, the symposium explored the complex interrelationships between technologies and humans, and re-examined our societal and governance structures. The event comprised of a panel discussion by guest speakers namely Dr Maarten Franssen (Delft University of Technology), Dr Rebecca Mignot-Mahdavi (University of Manchester), and Dr Filippo Santoni de Sio (Delft University of Technology). Dr Berenice Boutin (Asser Institute) provided the introductory words, and the author Dr Sadjad Soltanzadeh (Asser Institute), the concluding remarks.

### <u>DILEMA Symposium on interim research</u> results

29 June (hybrid)

The Asser Institute organised a small scale DILEMA symposium, where the research team presented ongoing research and interim results. Topics included: autonomy in decision-making, meaningful human control, and responsibility at the pre-deployment stages.

### DILEMA Lecture on the ethics of human-robot interaction

17 November (hybrid)

The DILEMA lecture was delivered by Dr Sven Nyholm (Utrecht University) on the topic of 'The Ethics of Human-Robot Interaction and Traditional Moral Theories'. Due to the rapid introduction of various kinds of robots and artificial machines with artificial intelligence into different domains of life, the lecture raised questions on whether robots can be moral agents and moral patients. Additionally, Dr Sven Nyholm delved into new areas of the ethics of human-robot interaction to traditional ethical theories which include utilitarianism, Kantian ethics, and virtue ethics. The opening remarks were provided by Dr Berenice Boutin (Asser Institute) and Dr Sadjad Soltanzadeh (Asser Institute) moderated the discussion with the audience.

# 3.4.6 'Zoom In' webinars on Transnational Sports Law

In 2020, the <u>Asser International Sports Law</u> <u>Centre</u> headed by Dr Antoine Duval introduced in collaboration with Dr Marjolaine Viret (University of Lausanne) a new series of Zoom webinars on transnational sports law: 'Zoom In'.

[Zoom-In] Governing international sports in times of war: sports governing bodies and the Russian invasion of Ukraine

12 October (online)

The event explored the regulatory powers of the sport governing bodies and their political impact on international relations. Three outstanding scholars discussed issues regarding the exclusion of Russian teams from international sporting competitions after the Russian invasion of Ukraine. They these issues from different methodological perspectives. The speakers included Professor Carmen

Pérez (Universidad Carlos III de Madrid), Dr Daniela Heerdt (Asser Institute and Centre for Sports and Human Rights), and Carole Gomez (University of Lausanne and Institut de Relations Internationales et Strategiques).

# 3.5 Trainings and educational programmes

### [Winter Academy] Artificial Intelligence and international law

21-25 February (online)

The fourth edition of this interdisciplinary programme offered participants an in-depth and comprehensive overview of AI and International law: from ground notions to complex debates on AI and the rule of law. The programme was structured along seven themes: understanding Al technology, responsible Al and ethical design, human-machine relationships, ensuring respect for human rights in the context of AI, military applications of AI and the international law of military operations, individual and collective responsibility in relation to AI, and international governance of Al. Speakers included: Dr Evgeni Aizenberg (Delft University of Technology), Irakli Beridze (UNICRI), Maria Eira (UNICRI), Dr Matthijs Maas (University of Cambridge), Zoltán Turbék (Ministry of Foreign Affairs and Trade of Hungary), and Professor Frederik Zuiderveen Borgesius (Radboud University). The winter academy was coordinated by Asser researcher Dr Berenice Boutin.

[Spring Academy] Due diligence as master key to responsible business conduct

4-8 April (in-person)

The 2022 edition of the Doing Business Right spring academy examined the idea

and reality of due diligence. The programme retraced the genealogy of the concept, investigated its theoretical underpinnings, and provided participants with a comprehensive understanding of its practical operation through specific case studies conducted by experienced practitioners. The programme blended theory and practice to equip its participants with the necessary skills to navigate and actively engage with the growing practice of due diligence in various fields. The training course was structured along five key topics: business and human rights, responsible business conduct, human rights due diligence, OECD guidelines for multinational enterprises, and the UN Guiding Principles on Business and Human Rights. Speakers included: Marian Ingrams (OECD Watch), Charlotte Michon and Laurent Lhopitallier (Enterprises pour les droits de l'homme), Caroline Omari Lichuma (University of Göttingen), Juliette Renaud (Les Amis de la Tere), and Lara Strangways (Global Rights Compliance). The spring academy was coordinated by Asser researcher Dr Antoine Duval.

[Summer Law Programme] on international criminal law & international legal & comparative approaches to counter-terrorism 31 May-24 June (online)

For the 16<sup>th</sup> time the War Crimes Research Office of American University's Washington College and the T.M.C. Asser Instituut joined forces in organising this training course. As last year, the programme was translated into an online format. The programme was, as usual, structured into two pillars. Part one provided a comprehensive overview of international crimes, criminal responsibility, immunities, amnesties, and practical matters in international criminal law. Participants experienced the law in practice, by virtually visiting international and national courts and international organisations. The second part of the programme was about international legal and comparative approaches to counter-terrorism. It delved into the definitions of terrorism, and its evolution

since 9.11. Participants had a virtual meet and greet with Catherine Marchi-Uhel, first Head of the International, Impartial and Independent Mechanism to assist in the investigation and prosecution of persons responsible for the most serious crimes under international law committed in the Syrian Arab Republic (IIIM). Other key speakers included Judge Fausto Pocar (International Court of Justice), Judge Silvia Fernandez de Gurmendi (ICC), Dr Julie Coleman (ICCT) and Dr Jide Okeke (United Nations Development Programme).

### [Advanced Summer Programme] Terrorism, counter-terrorism and the rule of law 29 August-2 September (in-person)

The twelfth edition of this Advanced Summer Programme organised in collaboration with the International Centre for Counter-Terrorism (ICCT) in The Hague, addressed the legal aspects pertaining counter-terrorism and counter-extremism through inspiring and interactive classes and study visits led by leading experts in the field. The programme offered policy makers, academics, diplomats and other practitioners a solid grasp of the various legal challenges and fundamental dilemmas when adopting and implementing counter-terrorism measures. The programme included sessions by top speakers such as Dr Eviane Leidig (Tilburg University, ICCT), Professor Richard English CBE (Queens University Belfast), Dr Joana Cook (Leiden University, ICCT), Dr Bibi van Ginkel (The Glocal Connection), and Professor Noémi Bouhana (UCL). The participants also had the opportunity to visit Europol and Eurojust. The advanced summer programme was coordinated by Asser researcher and ICCT Associate Fellow Dr Rumanya van Ark and Dr Tarik Gherbaoui (Asser Institute). Scholarships were made available through the Netherlands Ministry of Foreign Affairs.

### [Summer Programme] The governance of sport and human rights

### 5-9 September (in-person)

The Asser Institute and Centre for Sport and Human Rights (CSHR) organised the first summer programme on the governance of sport and human rights. The programme focused on the link between the governance of sport and human rights as well as the underlying challenges which include human rights impacts of mega-sporting events, the rights of child athletes, and remedies for sport-related human rights harms. Experts from the Asser Institute, the CSHR, FIFPro, and high-profile guest speakers provided participants with practical know-how and theoretical knowledge using concrete case studies related to human rights management and labour risks in the context of the Qatar World Cup. Key speakers included Stephen Cockburn (Amnesty International), Andreas Graf (FIFA), Ambet Yuson (BWI), Andrea Florence (Sport & Rights Alliance), and Florian Yelin (World Players Association). In addition, the participants visited FIFPro in Hoofddorp. The training course was coordinated by Dr Daniela Heerdt (Asser Institute and CSHR).

### [Training Programme] Disarmament and non-proliferation of WMD 2022

### 19-23 September (in-person)

The Asser Institute organised in collaboration with the Organisation for the Prohibition of Chemical Weapons (OPCW), the thirteenth training programme on disarmament and non-proliferation of weapons of mass destruction (WMD). The programme provided a comprehensive overview of non-proliferation and disarmament efforts regarding WMD. Participants had the chance to learn from renowned speakers and practitioners as well as, engage in active discussions regarding relevant topics and ongoing debates. The topics included nuclear weapons, biological and chemical weapons, export controls, chemical weapons, and current challenges.

The participants visited the TU-Delft Nuclear Research Reactor, the OPCW building, and the OPCW Laboratory and Equipment Store. Speakers included Ambassador Fernando Arias (Director-General of the OPCW), Ionut Suseanu (International Atomic Agency), Natalia Silkina (Comprehensive Nuclear Test-Ban-Treaty Organization), Alex Lampalzer (United Nations Office for Disarmament Affairs), Elayne Whyte (Ambassador to UN 2014-2020), and Ingeborg Denissen (the Netherlands Ministry of Foreign Affairs). The training programme was coordinated by Prof. Dr Thilo Marauhn and Thea Coventry (Asser Institute). The OPCW and Netherlands Ministry of Foreign Affairs financially supports the training through scholarships.

3.5.1 <u>Lebanon Lecture</u>

### 2 February-6 June 2022 (online)

Since 2011, the programme was set up to enable law students from eleven different universities in Lebanon to follow lectures on international criminal law and procedure. The programme was initiated by the Asser Institute and the Special Tribunal for Lebanon (STL). There was no specialisation in international criminal law offered at any Lebanese university prior to that time. It was the first of its kind and unprecedented in the Middle East and North Africa region. In December 2020, the STL handed over the organisation of the online lectures to the International and Transitional Justice Resource Center (ITJRC). The ITJRC is representing the eleven Lebanese universities.

The tenth season coordinated by both the Asser Institute and ITJRC took place between February 2022 and June 2022. Speakers included Olga Kavran (Vrije Universiteit Brussel and IUSTICOM), Darina Saliba Abi Chedid

(International Center for Human Sciences and UNESCO), Alexis Demirdjian (ICC) and Judge Ralph Riachi (STL). The training received financial support from the Konrad Adenauer Stiftung.

# 3.5.2 <u>ICL-TCL training</u> programme

Since 2018, the Asser Institute, together with the Antonio Cassese Initiative and International Nuremberg Principles Academy, organises training courses on International Criminal Law (ICL) and Transnational Criminal Law (TCL) for judges and prosecutors from African countries. The training course in 2018-2019 marked the beginning of increased cooperation between the three organisations, which aims to set up a permanent training centre for judges and prosecutors in The Hague, offering a bi-annual programme, supported by e-learning, in the field of ICL, TCL and International Humanitarian Law (IHL).

The third training cycle kicked-off with an online component in February and May 2022. A follow-up one-week in-person training took place in The Hague from 4-8 July 2022. The training was attended by 18 judges and prosecutors from the following countries: Burkina Faso, Democratic Republic of Congo, Niger, Chad, Côte d'Ivoire and Mali.

The overall objective of the training course is to empower judges and prosecutors from French-speaking African countries to deal with international and transnational crimes. Namely to:

- 1. Enhance their ability to protect human rights, including fair trial rights as enshrined in international instruments;
- To ensure effective cooperation with the ICC and other international criminal tribunals, and;
- 3. To increase cooperation among national judiciaries.

The ICL-TCL training featured several top speakers coming from international courts and

tribunals in The Hague and several academic and professional institutions and organisations focusing on ICL and TCL. This training cycle included honoured guests such as: Jérôme de Hemptinne (Utrecht University), Julia Grignon (Laval University), Emmanuelle Marchand (Civitas Maximas), Valerie Gabard (UpRights), Rufina Khusniyarova (ICC), Yvan Cuypers (ICC) and Arnaud d'Oultremont (Belgian prosecutor).

This project is led by Dr Marta Bo on behalf of the Asser Institute and the Antonio Cassese Initiative and by Anabela Alves on behalf of the International Nuremberg Principles Academy. The training is part of the Orange Knowledge Programme funded by the Ministry of Foreign Affairs as part of the Netherlands' development policy and managed by Nuffic. And receives additional financial support from the Nuremberg Academy.

# 3.5.3 Strengthening Ukraine's capacity to investigate and prosecute international crimes

1 July 2020 - 30 June 2024

The objective of this project is to strengthen the capacity of the newly created War Crimes Unit, enhance the expertise of the judiciary and empower Civil Society Organisations and defence and victim lawyers in Ukraine to more adequately investigate, prosecute, adjudicate and monitor international crimes. This support is extremely timely, as Ukraine is about to ratify the Rome Statute of the International Criminal Court and suffers from a lack of capacity to deal with international crimes, engendered by amongst others the recent reorganisation of the Ukrainian prosecution service. The project will ensure that this reform process is informed by best (Dutch) practices and expertise to end impunity, and that the main stakeholders, including civil society, are supported to understand and fulfil their own roles in ensuring respect for international law and providing redress and truth

to the victims. In the long-term, the project will contribute to an overall increased respect for the rule of law and greater trust by the Ukrainian population in its government. Moreover, it aims to contribute to regional cooperation and for the country to become more resilient towards (pro-) Russian disinformation and geopolitical aims in the Eastern Partnership region.

This project is a joint initiative of the Asser Institute and Global Rights Compliance (GRC). It is funded by the Netherlands Ministry of Foreign Affairs under the MATRA (MAatschappelijke TRAnsformatie: social transformation) Programme and supported by the Netherlands Ministry of Foreign Affairs.

- [Conference] Strengthening Ukraine's national efforts to investigate, prosecute, adjudicate and report on international crime

The MATRA-Ukraine mid-term conference "Strengthening Ukraine's national efforts to investigate, prosecute, adjudicate and report on international crimes" was held on 14 November 2022 at Beeld & Geluid in The Hague and online. The aim of the conference was to listen to Ukrainian perspectives and re-assess their needs, identify the main challenges, learn best practices from (inter)national experts, and share ideas and insights on how the Ukrainian national authorities could proceed going forward. The conference was opened by Christophe Paulussen, Senior Researcher at the Asser Institute and Ruby Axelson, Senior Legal Adviser at GRC, who led the MATRA-Ukraine project. Further opening remarks were made by Myroslava Krasnoborova, Counsellor of the Ukrainian Embassy in The Hague and Mauritz Verheijden of the Netherlands Ministry of Foreign Affairs. Furthermore, the conference sought to inform and further fine-tune the activities planned for the second phase of the Asser/GRC MATRA-Ukraine project. The

conference was structured in the form of a series of panel discussions which include topics such as (1) strengthening and coordinating investigations and prosecutions; (2) strengthening the judicial capacity to adjudicate international crimes; and (3) enhancing the fairness of the justice process. Other speakers included David Vaughn (USAID), Hanna Maina (The Novomoskovskyi Court of Dnipropetrovsk region), and Wayne Jordash KC (GRC).

# 3.5.4 The Asser Institute Doctoral Seminar Series on international arms control law

The Asser Institute Doctoral Seminar Series on international arms control law provides a select number of doctoral and postdoctoral researchers with insights into the current and future issues raised by international arms control law with perspectives from international law and related disciplines. At each seminar, academics and practitioners will deliver four expert lectures on the international legal framework of arms control, geo-political perspectives on arms control, institutional and procedural frameworks for control and disarmament, as well as emerging issues and trends. Additionally, the seminar series provides an opportunity for doctoral and postdoctoral researchers to present an aspect of their research as a springboard for discussions on the topic of international arms control, seeking to foster interdisciplinary exchange among peers in a lowstakes environment. The seminar series is funded by the Municipality of The Hague. The seminars are coordinated by Asser researchers Prof. Dr Thilo Marauhn and Thea Coventry.

### [Seminar] Arms trade and conventional weapons

16-17 June (in-person)

The first 2022 doctoral seminar featured the topic 'Arms trade and conventional weapons'. Conventional weapons encompass a wide range of military equipment other than weapons of mass destruction. Participants undertaking doctoral/postdoctoral research in legal, historical, political or theoretical fields presented an abstract which summarised an aspect of their doctoral research about arms trade and/or conventional weapons. Starting with day one, the topics addressed entailed the arms control from geo-political perspective, the Arms Trade Treaty, and a public lecture on the impact of the conflict in Ukraine on conventional arms control presented by Col (ret) Wolfgang Richter (Stiftung Wissenschaft und Politik (SWP) and the German Institute for International and Security Affairs). On day two, the participants delved into the topics of arms export controls and conventional arms control and disarmament; in particular the role of civil society organisations. Speakers included Dr Matúš Halás (Institute of International Relations Prague), Professor Zeray Yihdego (University of Aberdeen), Sabine Visser (the Netherlands Ministry of Foreign Affairs), and Frank Slijper (PAX).

### [Seminar] Nuclear weapons: challenges and opportunities

### 26-27 September (in-person)

Following the success of the first PhD and postdoctoral research seminar, the second edition focused on the topic of nuclear weapons. The participation in this workshop was per invitation and extended to a limited group of doctoral candidates and postdoctoral researches. The programme was structured around three lectures spread over two days on topics regarding: (1) the normative shift in nuclear arms control; (2) negotiating arms control treaties; and (3) the Tenth NPT Review Conference. On day two of the

seminar, participants engaged in an early career researcher roundtable presenting their research topics. The seminar concluded with a public expert panel regarding the Tenth Review Conference of the Nuclear Non-Proliferation Treaty (NPT) just a month after its conclusion. Speakers of the entire seminar programme included Dr Susan Martin (Kings College London), Dr Rebecca Johnson (ACRONYM Institute), and Ana de Velde Harsenhorst (the Netherlands Ministry of Foreign Affairs).

[Seminar] Chemical weapons and biological weapons: international investigative mechanisms

### 19 December (in-person)

The third 2022 arms control doctoral seminar elaborated on the topic of chemical weapons and biological weapons and its international investigative mechanisms. The thematic scope of the programme covered (1) the role of the **OPCW Investigation and Identification Team** in identifying individuals or entities involved in chemical weapons use falling outside the remit of the OPCW-UN Joint Investigative Mechanism; (2) the frameworks and process developed by the International, Impartial, and Independent Mechanism (IIIM) to collect and consolidate evidence in its central repository of crimes and violations of international law committed in Syria since 2011; and (3) the phenomena of unsubstantiated allegations of chemical and biological weapons use in armed conflicts as well as the deployment of disinformation campaigns to evade attribution and accountability for actions that breach global non-proliferation treaty obligations. Additionally, participants engaged in a roundtable discussion pertaining their research topics. Speakers included Dr Alexander Kelle (IFSH, Hamburg University) and Santiago Oñate (OPCW).


