## "Legal Activism in Human Rights PhD Research"

Date: Thursday 22 and Friday 23 May 2025 Venue: Schouwburgstraat 2, Den Haag

This year's 1<sup>st</sup> and 2<sup>nd</sup> year PhD training will take place on Thursday 22 and Friday 23 May 2025 at Leiden University.

The training is an exploration of the intersection between legal scholarship and activism within the field of human rights. Through a series of lectures, seminars, and discussions, participants will engage with leading academics and practitioners. The training will provide insights into how legal research can inform and support human rights activism, addressing both the opportunities and challenges that arise when scholars engage with advocacy. Participants will critically examine the role of legal frameworks in advancing human rights, discuss the ethical and methodological implications of activist-oriented research, and explore practical strategies for integrating activism into their academic work.

Beyond the formal sessions, the training offers a valuable opportunity for participants to meet fellow PhD researchers, exchange ideas, and build a network of colleagues working on similar topics.
