Conference Attendance Grants application deadline 31 January



Dear NNHRR Members,

We would like to remind you that the first round of the **Conference Attendance Grants** scheme is closing shortly on 31 January. The aim of the initiative is to support PhD members in attending key academic events in the field of human rights, giving them the opportunity to develop their expertise, build connections, and strengthen their presence in the global academic community.

Application Rounds

In the pilot year of 2025, there will be three rounds of applications:

- **31 January 2025**
- 30 April 2025
- 30 September 2025

For each round, **four grants of maximum €1,000** will be awarded.

Eligibility

To be eligible, applicants must:

- Be a member of NNHRR;
- Be currently affiliated with a NNHRR member university as a PhD candidate;
- Have not yet defended their PhD at the time of the proposed conference attendance;
- Demonstrate that the event that they wish to attend has a strong connection to their human rights research;
- The event should take place within six months of the closing of the application round.

The following criteria are not required, but will be prioritised in the selection of applicants:

- The applicant is an external PhD without funding from their institution;
- The applicant is presenting their own research at the event.

What Will Be Reimbursed?

- Travel costs
- Accommodation for the duration of the event
- Conference fee (if applicable)

Application Procedure

Applicants should submit the following documents via email to nnhrr@asser.nl with the title 'Application for Conference Attendance Grant':

- CV (including previous academic conferences attended);
- Evidence of anticipated costs;
- A statement of support from one of the applicant's PhD supervisors (an email from the supervisor to nnhrr@asser.nl is sufficient).

The outcome of the application will be communicated to all applicants within **two weeks** of the deadline for applications.

Criteria to Be Taken Into Consideration for Selecting Applications

- Availability of other funding to attend events, such as Erasmus+ or internal funding through projects or department funds
- Whether the applicant is presenting at the conference
- Connection of the event to the applicant's human rights research
- Whether the applicant has had previous opportunities to attend academic conferences
