L. et Autres c. France: A Landmark Judgment Concerning Sexist Judicial Bias - Himpathy and Victim-Blaming – in Cases of Sexual Violence Against Girls by Margarita S. Ilieva [3 June]

For the first time, the European Court of Human Rights has acknowledged that judicial gender-based negative stereotyping of a sexual violence survivor not only revictimised her but was also discriminatory. On 24 April 2025, the Court found that France had violated its duties to protect girls, victims of sexual predators, from inhuman or degrading treatment (Article 3 of the European Convention of Human Rights (ECHR) and to respect their private lives/ dignity (Article 8 ECHR), as well its duty not to discriminate (Article 14 ECHR). The French judges had made 'guilt-inducing statements', propagating gender stereotypes. Previously, in such cases, the Court refused to even consider Article 14 allegations.

On 11 April 2025, the Netherlands Network for Human Rights Research (NNHRR) held its annual PhD training for 3rd and 4th year PhD students at the University of Groningen, focusing on publishing, wellbeing, and career development in human rights research. The event offered valuable insights ranging from information on blog writing and Open Access publishing to managing emotionally challenging research and navigating careers inside and outside academia. Sessions also covered grant opportunities and ethical challenges in human rights funding. An inspiring day of learning, reflection, and networking – co-organised by Dr. Katerina Tsampi, Sophia Salziger, Chiiun Miin Seah, and Sina Platzbecker.

#### Deportations Trigger Inter-American Protection Regarding El Salvador by Kate Murphy [23 June]

On May 9, 2025, several human rights organisations filed a landmark request for precautionary measures before the Inter-American Commission on Human Rights on behalf of Venezuelans deported from the U.S. and imprisoned in El Salvador's CECOT facility. If granted, these would be the first measures for prisoners in El Salvador in a decade, marking a potential turning point for legal mobilisation in a context where sustained advocacy remains uncertain.

Recognising Changes in Gender Identity Under EU Law: The Impact of Mirin and Deldits for Legal Gender Recognition Across Borders by Chiara Raucea [25, 27, 30 June]

This contribution consists of a series of three interconnected blog posts that explore whether, and to what extent, EU law can protect the right of trans European citizens to have their gender identity legally recognised across the borders of EU Member States. Currently, procedures and conditions for Legal Gender Recognition (LGR) are governed by national laws, and the EU lacks direct legislative competence in this area. As a result,

the absence of harmonised rules means that trans Union citizens who move to or reside in another Member State risk having their legal gender identity inconsistently recorded or misrecognised.
