COURT OF BOSNIA AND HERZEGOVINA Section I for War Crimes of the Criminal Division of the Court Preliminary Hearing Judge Sarajevo

Pursuant to the provision of Article 35(2)(h) and Article 226(1) and 227(1) of the Criminal Procedure Code of Bosnia and Herzegovina, I hereby file the following

INDICTMENT

Against:

Zijad Kurtović, aka Zijo, son of Bajro and mother Saja, née Hodžić, born on 30 January 1967 in Donja Drežnica, personal identification number 3001967150018, with residence at 75 Donja Drežnica, Mostar Municipality, Bosniak, worker, unemployed, married, citizen of Bosnia and Herzegovina, convicted by the Verdict of the Municipal Court in Mostar in the case Km-3/84 of 18 January 1985 for the criminal offence referred to in Article 148(1) of the CC SR BiH whereby the educational measure of committal to an educational institution was imposed on him; by the Verdict of the Municipal Court in Stolac in the case K-44/85 of 24 September 1985 for the criminal offence referred to in Article 153(1) and sentenced to a one-year imprisonment; by the Verdict of the Basic Court in Mostar in the case number K-400/89 of 28 September 1990 for the criminal offence referred to in Article 42(1) of the CC SR BiH and sentenced to a sixmonth imprisonment; these sentences were deleted by the Decision of the Police Station Mostar number 03-11/1-4-13/96 on 3 April 1996,



Because:

In the second half of 1993, during the armed conflict between the Croat Defense Council and the Army of the Republic of Bosnia and Herzegovina, in the place Donja Drežnica, Mostar Municipality, in the Roman Catholic Church of All Saints, as a member of the Army of R BiH, in his capacity as the Commander of the Military Police Platoon of the Independent Battalion Drežnica of the 4th Corps of the Army of R BiH, he acted contrary to the provision of Article 3(1)(a) and (c) of the Geneva Convention relative to the Treatment of Prisoners of War of 12 August 1949, Article 3(1)(a) and (c) of the Geneva Convention relative to the Protection of Civilian Persons in Time of War of 12 August 1949 and, during the armed conflict between the HVO and the Army of R BiH, violated the laws and customs of war, acting contrary to the provision of Article 22 of the Regulations Respecting the Laws and Customs of War on Land, which are a constituent part of the Convention Respecting the Laws and Customs of War on Land of 18 October 1907, intentionally damaging the Roman Catholic Church of All Saints, in the way that:

1. On an unknown date in late September or early October 1993, during the first night of detention, in the place Donja Drežnica, Mostar Municipality, after transferring around twenty detained Croats, civilians

from the Parish Office and detaining them in the Roman Catholic Church of All Saints, he ordered them to sit in pews two by two, and then he put on a clerical dress – a monastic habit and, holding a cross upside down in his hand, ordered them all to raise their hands above the heads and bow their heads down towards the floor; they remained in this position for a rather long period of time and that terrified them; and then, after some time, he ordered them to put on orange roadman clothes and, upon his order, unknown members of the Army of the Republic of Bosnia and Herzegovina wrote numbers from 1 to 20 on the back of each detainee, whereupon Zijad Kurtović called them out by numbers, took them out in front of the altar, questioned and punched them, and beat them with iron pipes and wooden laths, calling them "Ustashas" and using other abusive language;

2. During October 1993, in the place Donja Drežnica, Mostar Municipality, in the Roman Catholic Church of All Saints, on several occasions, he beat the detained Croats, civilians and prisoners of war,

with truncheons, crosses, candlesticks, statues of saints over their heads and other parts of their bodies, rammed pictures of saints into their heads, made them eat leaves of the Bible and other religious books and swallow a rosary, ordered them to sing "od negdje do nekih vrata, neće biti Srba ni Hrvata" /"from somewhere to some door, there will not be any Serbs or Croats"/, ramming the pictures depicting the Christ's Way of the Cross into their heads as they were singing, keeping them in constant fear;

several occasions to the Vrdi front lines between the HVO and the Army of RBiH, where they were used as human shields, forced to dig trenches, make dugouts, and carry ammunition, food, water and the dead;

- 4. On an unknown date in October 1993, in the Roman Catholic Church of All Saints in Donja Drežnica, after he, together with Hasan Delić, forced the detained HVO members, brothers to strip naked, and then, together with Hasan Delić, he beat him with a truncheon over different parts of his body for several hours and stubbed out cigarettes on his neck several times, as a result of which the detainee lost consciousness, while his body became completely black as a consequence of heavy blows;
- 5. On an unknown date in early October 1993, in the night hours, in the Roman Catholic Church of All Saints in Donja Drežnica, together with unknown members of the Army of the Republic of Bosnia and Herzegovina, he forced the detained Croats, civilians and prisoners of war, including

catch a live wire with their bare hands and then hold their hands and make a circuit in this way, whereupon, in order to improve electrical conductivity, he spilt water over the church floor, under the detainees' feet, as a result of which the detained Croats suffered intense physical pain;



6. On an unknown date in October 1993, during the night hours, in the
place Donja Drežnica, Mostar Municipality, in the Roman Catholic Church of
All Saints, together with Hasan Delić, aka Nono, Senad Bobić, aka Seno, Izet
Kurtović, aka Bimbo, and other unknown members of the Army of RBiH, he
ordered the detained Croats, civilians and prisoners of war, to play the church
organ, and then, since he did not like how they played, he pulled out a pipe
organ key and beat the following detainees over their heads with the side of the
key with a nail -

- 7. On an unknown date in October 1993, in the place Donja Drežnica, in the Roman Catholic Church of All Saints, after a certain Amir, member of the Army of R BiH unit *Igmanski vukovi /The Igman Wolves/*, in his presence, took a watch from the detainee he approached the detainee telling him: "Hey, the seventh, come here! Why didn't you say last night that you had a watch?", and ordered him to turn towards the wall and hit him several times with a wooden leg in the kidney region;
- 8. On an unknown date in early October 1993, during the first night of detention, in the place Donja Drežnica, Mostar Municipality, in the Roman Catholic Church of All Saints, he touched the detained with his hand and ordered him to stand up, and then held his left shoulder with his hand, while an unknown soldier of the Army of R BiH was kicking him with a boot in the spine region, whereupon Zijad Kurtović punched the detained several times in his head;
- 9. On an unknown date in early October 1993, in the Roman Catholic Church of All Saints in the place Donja Drežnica, he ordered the detainee to lie down on the church floor and turn round like a crocodile, while four unknown soldiers of the Army of R BiH, in his presence, were kicking the detainee in his ribs;
- 10. On an unknown date in October 1993, in the evening hours, in the Roman Catholic Church of All Saints in the place Donja Drežnica, after an unknown member of the Army of R BiH, upon the order from and in the presence of Zijad Kurtović, kicked the detainee in his mouth with his boots on and pulled out several teeth with his bare hands, saying: "Here, I have pulled your teeth out. Do you have 50 marks to pay?", Zijad Kurtović threw the detainee over a pew and hit him several times in his back;

11. During October 1993, together with Hasan Delić, Nijaz Alić, aka Spina, Senad Bobić, aka Seno, Izet Kurtović, aka Bimbo, in the Roman Catholic Church of All Saints in Donja Drežnica, beating the detained Croats with religious pictures and statues, he destroyed and broke them, destroyed the altar and sacristies, burnt the pews, scribbled insulting words all over the church walls, drew testicles to saints on the pictures, destroyed the pictures of saints, taking them off the wall and ramming them onto the heads of the detained Croats, damaging the church interior in that way.

Therefore, violating rules of international law during the armed conflict, he tortured the detainees – civilians and prisoners of war, inflicted great suffering on them and violated their bodily integrity, participated in the infliction of great suffering and violation of bodily integrity, treated them inhumanely and participated in inhumane treatment, applied measures of intimidation and terror, forced them to labor and violated the laws and customs of war during the armed conflict by deliberately damaging and participating in the deliberate damaging of the establishment designated for religious purposes,

Whereby he committed:

- the criminal offence of War Crimes against Civilians referred to in Article 173(1)(c), e) and (f) of the CC BiH by the actions stated under items 1, 2, 3, 5, 6, 7, 8, 9 and 10 of the operative part of the indictment,
- the criminal offence of War Crimes against Prisoners of War referred to in Article 175(1)(a) and (b) of the CC BiH by the actions stated under items 1, 2, 3, 4, 5 and 6 of the operative part of the indictment

and

- the criminal offence of Violating the Laws and Practices of Warfare referred to in Article 179(1) and (2)(d) of the CC BiH by the actions stated under item 11 of the operative part of the indictment,
- all in conjunction with Article 180(1), Article 29 and Article 53(1) of the Criminal Code of Bosnia and Herzegovina.



Therefore, I hereby





INVESTIGATION RESULTS

The results of the investigation conducted by the Prosecutor's Office of BiH indisputably confirm the well-foundedness of this indictment, namely the assertions that the suspect, personally and together with other members of the R BiH Army, in the manner, at the time, in the place and under the circumstances stated in the operative part of the indictment, ordered, perpetrated and participated in the perpetration of the criminal actions stated under items 1 through 11 of the indictment, which constitute all essential elements of the criminal offence of War Crimes against Civilians referred to in Article 173(1)(c),(e) and (f) of the CC BiH, the criminal offense of War Crimes against Prisoners of War referred to in Article 175(1)(a) and (b) of the CC BiH and the criminal offence of Violating the Laws and Practices of Warfare referred to in Article 179(1) and (2)(d) of the Criminal Code of Bosnia and Herzegovina, in conjunction with Article 180(1), Article 29 and Article 53(1) of the Criminal Code of Bosnia and Herzegovina.

The following has been established by both the material evidence and statements of the examined witnesses obtained by the Prosecutor's Office of Bosnia and Herzegovina during the investigation:

- The criminal actions that the suspect Zijad Kurtović has been charged with under this indictment were committed during the armed conflict between the HVO and the Army of R BiH in the Roman Catholic Church of All Saints in Donja Drežnica, Mostar Municipality.
- All criminal actions that Zijad Kurtović has been charged with under this indictment constitute serious violations of the Geneva Convention relative to the Protection of Civilian Persons in Time of War of 28 August 1949 (Article 147), serious violations of the Geneva Convention relative to the Protection of Prisoners of War of 28 August 1949 (Article 130) and violations of the provision 22 of the Regulations Respecting the Laws and Customs of War on Land, which are a constituent part of the Convention Respecting the Laws and Customs of War on Land of 18 October 1907, and they are a result of the armed conflict.



throughout the period of time relevant for this indictment they were persons protected by the Geneva Convention relative to the Protection of Civilian Persons in Time of War of 28 August 1949 and the Geneva Convention relative to the Protection of Prisoners of War of 28 August 1949.

- The suspect Zijad Kurtović was, as a member of the Army of R BiH and, based on the statements of the witnesses injured parties and material evidence, as the Commander of the Military Police Platoon of the Independent Drežnica Battalion within the 4th Corps of the Army of R BiH, "obliged to observe the provisions of the Geneva Convention relative to the Protection of Civilian Persons in Time of War of 28 August 1949 and the Geneva Convention relative to the Protection of Prisoners of War of 28 August 1949 and the laws and customs of war on land.
- No criminal action committed by Zijad Kurtović in his capacity as the Commander of the Military Police of the Independent Drežnica Battalion was justified by any military necessity.
- The suspect Zijad Kurtović was a member of the armed forces participating in the armed conflict (member of the Army of R BiH).

In the statements given in the Prosecutor's Office of BiH during the investigation, the witnesses – injured parties clearly, decidedly and consistently described the circumstances of the captivity of a group of 20 Croats in the Roman Catholic Church in the place Donja Drežnica, Mostar municipality.

The witnesses – injured parties point out in their statements that at the time of the perpetration of these criminal offences Zijad Kurtović was "in charge" of the group of the Army of R BiH members who were "responsible" for twenty Croats detained in the church in Donja Drežnica. The examined witnesses – injured parties, twelve of them, state that Zijad Kurtović tortured them, inflicted great suffering on them, violated their bodily integrity, treated them inhumanely, applied measures of intimidation and terror, issued orders to members of the Army of R BiH to torture the detained Croats, treat them inhumanely, use them as human shields, forced them to labor (to carry ammunition and food, as well as the dead from the front lines between the HVO and the Army of R BiH), which they carried out unquestioningly, and that the interior of the Roman Catholic church in Donja Drežnica, where they were detained for almost a month, was completely destroyed. The examined Croats who were detained in the church in Donja Drežnica state that, at the moment of their detention in the church, the church was in a perfectly normal condition, ready for the mass, that the statues of saints were intact and at their places, pictures of saints intact

and hanging on the church walls, pews well preserved and arrayed as if mass was going to be celebrated that day, the altar in a normal condition, sacristies at the altar and well preserved.

The detainees - injured parties

testify about the

condition of the church at the end of the captivity in it.

They all consistently state that the interior of the church was completely devastated after around 20 days of captivity. Different insulting words were scribbled all over the walls, the pictures of saints were destroyed, holy books were torn and thrown over the floor, statues of saints broken, the altar and sacristies destroyed, pews burnt or cut.


The witnesses, detainees in the church in Donja Drežnica, Croats - Catholics, particularly point out that their captivity in the Roman Catholic church, in their God's house, beating them with the statues of saints, ramming the pictures of saints onto their heads, forcing them to eat leaves of the Bible and other holy books and to swallow a rosary, was a flagrant violation of their human dignity, national and religious affiliation.

Armed conflict between the HVO and the Army of R BiH

It is evident that there was an armed conflict between the HVO and the Army of BiH in Herzegovina and in the territory of the Mostar municipality in the critical period of time.

From the material evidence which the Prosecutor's Office of Bosnia and Herzegovina obtained during the investigation and from the statements of the witnesses who were examined in the Prosecutor's Office of Bosnia and Herzegovina indisputably follows that there was an armed conflict between the HVO and the Army of R BiH in the second half of 1993 in the territory of Herzegovina and the territory of the Mostar municipality.

The Peace Agreement and the Annex to the Peace Agreement between the HVO and the Army of R BiH were signed on 23 February 1994 in Zagreb. The agreement was signed by General Ante Roso on behalf of the HVO and General Rasim Delic on behalf of the Army of R BiH. The signatories of this agreement on behalf of the international community were Mr. Akashi and General Cot.




With this agreement, both sides agreed to the cease-fire which included immediate and complete cessation of hostilities, cessation of offensive operations and attacks, and cessation of all types of propaganda of one side against the other.

The agreement came into force on 25 February 1994 at 12:00 hours.



Before being brought to Donja Drežnica, all 20 detained Croats were detained in Rogića kuće /the Rogićs' houses/ in Donja Jablanica, where the base of the Army of R BiH special unit Zulfikar was located. Prior to being brought to and detained in Zukina baza /Zuko's base/, some of them had been detained in the Buturović Polje primary school and some of them in the camp Muzej /Museum/ Jablanica.

Escorted by unknown members of the Handžar division and the Zulfikar unit, all 20 Croats were brought from the detention in *Zuko's base* in Donja Jablanica to Donja Drežnica and handed over to Zijad Kurtović and "his team" in the late evening hours in late September or early October 1993.

When they were brought to Donja Drežnica, Zijad Kurtović took all the detainees to the Parish Office, where they were questioned, and, a couple of hours later, he transferred this group of Croats, escorted by unknown members of the Army of R BiII, to the Roman Catholic Church of All Saints.

Conditions in prison in the church were brutal and unhealthy.

The detainees were sleeping on wooden benches, they did not have the ability to meet their hygienic needs, they relieved themselves outside the church under escort, and they had small quantities of food and water.

For the entire time the detainees were kept in the church, Zijad Kurtović, Hasan Alić, aka Spina, Izet Kurtović, aka Bimbo, Hasan Delić, aka Nono, and other unknown members of the Army of R BiH were subjecting the detained Croats to beatings and cruel treatment, keeping them in constant fear of physical and mental abuse.

The detained Croats were maltreated, insulted on grounds of their ethnicity and humiliated. Such treatment had a lasting effect on their mental and physical health.

Independent Drežnica Battalion

It is evident from the statements of the examined witnesses

that the
Independent Drežnica Battalion was formed on 15 April 1992, that the area of
responsibility of this battalion was the territory of the local community Drežnica, and
that the Military Police Platoon operated within this battalion.

The capacity of the suspect

It has been indisputably established on the basis of the material evidence obtained during the investigation (VOB-8 forms, personal file of Zijad Kurtović, Decision of the R BiH Presidency on commissions – promotions in the Army of R BiH of 5 October 1994) that the suspect Zijad Kurtović, in the critical period of time, was a member of the Army of R BiH, that he joined the Army of R BiH on 15 April 1992, that he was demobilized on 1 June 1996, that he was the commander of a squad with the rank of lieutenant 11107, and that, by the Decision of the R BiH Presidency on commissions – promotions in the Army of R BiH of 5 October 1994, he was promoted to the rank of lieutenant as the Commander of the Military Police Platoon of the Independent Battalion Drežnica of the 4th Corps.

That Zijad Kurtović was the Commander of the Military Police in Drežnica in the critical period of time follows also from the statements of the witnesses examined before the Prosecutor's Office of Bosnia and Herzegovina during the investigation.

The examined witnesses – injured parties. and knew Zijad Kurtović since before the war. Marinko Ljoljo points out in his statement that, during the captivity in the church in Donja Drežnica, he learnt from Ahmet Kurtović, brother of Zijad Kurtović, that Zijad Kurtović was the Commander of the Military Police in Drežnica. Witness states in his statement that he learnt the name of Zijad Kurtović after the first night of captivity, since all the soldiers who were torturing the detainees said their names. Witnesses and also confirm this. and Witnesses concluded that Zijad Kurtović was "in charge" first of all on the basis of his behavior. Zijad Kurtović was ordering other members of the Army of R BiH to torture the detainees, treat them inhumanely, apply measures of intimidation and terror, and take them to perform forced labor and the soldiers were carrying out these orders unquestioningly.

It is indisputable that with these actions, that is, by carrying out the actions stated under items 1 through 11 of this indictment, Zijad Kurtović committed serious violations of international humanitarian law referred to in Article 147 of the Geneva Convention relative to the Protection of Civilian Persons in Time of War of 12 August 1949 and serious violations of international humanitarian law referred to in Article 130 of the Convention relative to the Protection of Prisoners of War of 12 August 1949, and acted contrary to the provision of Article 22 of The Hague Regulations Respecting the Laws and Customs of War on Land from 1907, which are a constituent part of the 4th Hague Convention Respecting the Laws and Customs of War on Land (The Hague, 18 October 1907), by destroying the interior of the church in Donja Drežnica.

Also, it is indisputable that Zijad Kurtović acted contrary to the Order on the application of the rules of the international law of war in the Armed Forces of the Republic of Bosnia and Herzegovina and the Instruction on the application of the rules of the international law of war in the armed forces of the Republic of Bosnia and Herzegovina, in the way that he ordered others to torture the detained Croats in the Church of All Saints in Donja Drežnica, to take them to perform forced labor, to treat them inhumanely, on his own and together with others tortured the detained Croats, applied measures of intimidation and terror against them and treated them inhumanely and with these actions destroyed the interior of the church.

The Order on the application of the rules of the international law of war in the armed forces of the Republic of Bosnia and Herzegovina was issued by the President of the R BiH Presidency, Alija Izetbegović, on 23 August 1992. It orders that unit commanders and each member of the armed forces individually are responsible for the application of the rules of the international law of war, that trainings will be regularly organized in order to get acquainted with the rules of the international law of war in the armed forces and that all members of the armed forces have to attend it, and that a wartime commanding officer is obliged to initiate proceedings to pronounce legally prescribed sanctions against persons violating rules of the international law of war.

On the basis of this Order, the defense minister of the Republic of Bosnia and Herzegovina, on 5 November 1992, under M. number 22/67-1/92, issued the Instruction on the application of the rules of the international law of war in the Armed Forces of the Republic of Bosnia and Herzegovina. This Instruction, among other things, regulates that the Armed Forces of the Republic of Bosnia and Herzegovina shall apply the rules of the international law of war in the armed conflict and that "war crimes and other serious violations of the rules of the international law of war shall include: the crime of genocide, war crimes against civilians, against the wounded, the sick, medical staff, against prisoners of war and other serious violations of the rules of the law of war..."

It indisputably follows from the results of the investigation, statements of the examined witnesses and material evidence that the suspect Zijad Kurtović, Commander of the Military Police Platoon of the Independent Battalion Drežnica within the 4th Corps of the Army of Bosnia and Herzegovina, at the time and place stated in the operative part of the filed indictment, ordered that the detainees be tortured, taken to forced labor, used as human shields, treated inhumanely, and inflicted with great suffering, and that he tortured, violated bodily integrity, inflicted great suffering, treated inhumanely, applied measures of intimidation and terror, inflicted severe mental pain and participated in the torture, inhumane treatment, infliction of great suffering, violation of bodily integrity, infliction of severe mental pain upon the group of 20 detained Croats and damaged and participated in damaging the Church of All Saints in Donja Drežnica, committing the criminal offence of War Crimes against Civilians referred to in Article 173(1)(c), (e) and (f) of the CC BiH, the criminal offence of War Crimes against Prisoners of War referred to in Article 175(1)(a) and (b) of the CC BiH and the criminal offence of Violating the Laws and Practices of Warfare referred to in Article 179(1) and (2)(d) of the CC BiH, all in conjunction with Article 180(1), Article 29 and Article 53 of the Criminal Code of Bosnia and Herzegovina.

Given that the investigation results indisputably show that the suspect Zijad Kurtović, at the time of the armed conflict between the Croat Defense Council and the Army of the Republic of Bosnia and Herzegovina, in October 1993, as a member of the Army of R BiH, in his capacity as the Commander of the Military Police Platoon of the Independent Battalion Drežnica within the 4th Corps of the Army of R BiH, perpetrated the criminal offences in question, I propose that the preliminary hearing judge confirm the indictment of the Prosecutor's Office of Bosnia and Herzegovina number KT-RZ 115/06 of 10 May 2007 in its entirety.
