**Virginia Dignum** is an Associate Professor at the Faculty of Technology, Policy and Management, Delft University of Technology. She got her Ph.D. in 2004 from the Utrecht University. Previously, she worked for more than 12 years in consultancy and system development in the areas of expert systems and knowledge management. Her research focuses on agent-based models of organisations, in particular in the dynamic aspects of organisations and the applicability of agent organisations to support knowledge creation, sharing and representation in distributed environments and the interaction between people and intelligent systems in particular the behaviour of hybrid teams. **Sarah Genner** studied in Zurich and Berlin specialising in Internet research. She holds a Master’s degree in Political Science, Linguistics and Media Studies from Zurich University and is currently a Research Associate in Media Psychology at Zurich University of Applied Sciences (ZHAW) in Switzerland. Her professional experience is in journalism, communications, and teaching. **Catholijn M. Jonker** (1967) is Full Professor of Man-Machine Interaction at the Faculty of Electrical Engineering, Mathematics and Computer Science of the Delft University of Technology. She studied Computer Science, and did her Ph.D. studies at Utrecht University. After a postdoc position in Bern, Switzerland, she became an Assistant (later Associate) Professor at the Department of Artificial Intelligence of the Vrije Universiteit Amsterdam. From September 2004 until September 2006, she was a full-time Professor of Artificial Intelligence/Cognitive Science at the Nijmegen Institute of Cognition and Information of the Radboud University Nijmegen. She chaired De Jonge Akademie in 2005 and 2006, and she was a member from 2005 through 2010. Her recent publications address cognitive processes and concepts such as trust, negotiation, and the dynamics of individual agents and organisations. **Eva Lievens** Ph.D., obtained a law degree at the University of Ghent and a Master’s degree in Transnational Communications and Global Media at Goldsmiths College, London. Eva has been a member of the Interdisciplinary Centre for Law and ICT (K. U. Leuven) since 2003 and obtained her Ph.D. in law in June 2009. Taking a comparative, critical and contextualised approach, Sonia's research examines the opportunities and risks afforded by digital and online technologies in a range of contexts, including children and young people's experience of digital media at home and school, developments in media and digital literacies and the implications of the changing media environment for audiences, publics and the public sphere. More broadly, she is interested in how citizen values (public sphere, rights-based, equity-focused, diversity-promoting) can be better embedded in information and communication infrastructures in institutions, regulators and the lifeworld. Currently, she directs a 33-country network, EU Kids Online, funded by the EC's Safer Internet Programme. She also directs The Class, as part of the MacArthur Foundation-funded Connected Learning Research Network. She participates in the European COST network, Transforming Audiences, Transforming Societies, leads ECREA's Children, Youth and Media group and blogs for the LSE Media Policy Project. She was President of the International Communication Association in 2007–2008, and serves on the Executive Board of the UK's Council for Child Internet Safety, for which she is the Evidence Champion.

**Jamie-Lee Mooney** began her Ph.D. following graduating with first class honours from Lancaster University Law School in 2010. Alongside being a Ph.D. candidate for the school, she is also a Postgraduate Teaching Assistant within the areas of Criminal law, Criminal Justice, Family and Child law. Her research explores the legal and societal challenges posed by misconceptions of the phenomenon of child sexual grooming. Her recent publications provide a critical analysis of the growing awareness of group localised grooming and the ways in which offenders operate in groups to facilitate contact and sexual abuse/exploitation of vulnerable children. She has also published in the area of prevention of crime exploring the effectiveness of proactive police investigations. Since 2011, she has been working within the Publication Protection Unit of Lancashire Constabulary to develop the effectiveness of the criminal justice system and frontline response to sexual violence and child exploitation.

In 2012, he held a Government of Ireland senior research fellowship leading a project called Digital Childhoods with a focus on children's use of ICTs and implications for national digital

strategy. This includes disseminating findings to a wide range of stakeholders in education, policy, civil society and industry. He was chair of the IAMCR Audience section (2007–2013) and is vice-chair of the ECREA's Temporary Working Group for Children, Youth and Media. He is a member of Ireland's Internet Safety Advisory Committee and is the author of reports on media literacy for the Broadcasting Authority of Ireland and UNICEF. He co-edits a new book to be published this year by Nordicom entitled *Towards a Better Internet for Children: Policy Pillars, Players and Paradoxes*.

**Bart Schermer** is an Assistant Professor at the University of Leiden, Faculty of Law (eLaw research group) and a fellow at the E. M. Meijers Institute for Legal Studies. Furthermore, he is co-founder and editor of the Dutch Journal of Internet Law (*Tijdschrift voor Internetrecht*) and a member of the Cybercrime expert group for the Court of Appeal in The Hague. Apart from his work at the University Bart is a partner at Considerati, a legal consultancy specialising in the legal and policy aspects of IT and new media ([www.considerati.com](http://www.considerati.com)).

**Nathalie Sonck** obtained a Ph.D. in Social Sciences at the University of Leuven (Centre for Sociological Research) and a Master's degree in Communication Science at the University of Antwerp. Since 2011, she works as media researcher at The Netherlands Institute for Social Research (SCP). She specialises in research on media use in the public, and in particular related to skills and cultural interest. Recent publications include SCP-reports (for general public, policy-makers and social researchers) about children's internet risks, and cultural participation by new media, as well as academic articles (published in the *International Journal of Public Opinion Research*, *Journal of Children and Media*). As representative of The Netherlands in the EU Kids Online network, she investigates the consequences of Internet use by young people, their digital skills and the role of parental mediation strategies and discusses related policy issues with national stakeholders.

**Isolde Sprenkels** studied philosophy at Tilburg University. **Adam Thierer** is a senior research fellow at the Mercatus Center at George Mason University where he works in the Technology Policy Program. Thierer covers technology, media, Internet and free speech policy issues with a particular

focus in online child safety and digital privacy policy issues. Thierer has spent over two decades in the public policy research community and is the author or editor of seven books on diverse topics such as media regulation and child safety issues, mass media regulation, Internet governance and jurisdiction, intellectual property, regulation of network industries and the role of federalism within high-technology markets. He earned his B.A. in Journalism and Political Science at Indiana University, and received his M.A. in International Business Management and Trade Theory at the University of Maryland. Thierer has served on several distinguished online safety task forces, including Harvard Law School's Internet Safety Technical Task Force, a 'Blue Ribbon Working Group' on child safety organized by Common Sense Media, the iKeepSafe Coalition and the National Cable and Telecommunications Association, and the National Telecommunications and Information Administration's 'Online Safety and Technology Working Group'. In 2008, Thierer received the Family Online Safety Institute's 'Award for Outstanding Achievement'.

**Bibi van den Berg** (1975) is an Assistant Professor at eLaw, the Center for Law in the Information Society of Leiden University. In 2004, Van den Berg obtained an M.A. (with distinction) in Philosophy, with a specialisation in philosophy of technology and philosophical anthropology, at Erasmus University Rotterdam in The Netherlands. In 2009, she completed her dissertation on Identity and Technologies of the Near Future, at the same university. The title of her dissertation was 'The Situated Self: Identity in a world of Ambient Intelligence'. After her Ph.D., Van den Berg had a postdoc position at the Tilburg Institute for Law, Technology and Society (TILT) at Tilburg University for a few years. In 2012, she transferred to Leiden to take up her current position. Her research focuses on four themes: (1) regulation by technology (techno-regulation), (2) identity and privacy, (3) regulation and governance of/on the Internet and (4) robotics and artificial intelligence. Aside from her role as Assistant Professor, Van den Berg is also a Meijers Fellow at Leiden Law School and research director of eLaw.

**Simone van der Hof** is Full Professor of Law and Information Society at the Center for Law and the Information Society of Leiden Law School at Leiden University. Simone's research concentrates on the impact of new technologies on individuals and their rights. Her current research topics include online privacy, data protection and privacy statements, digital identities, digital child rights, (legal, social, technological) regulation of online child safety and empowerment of individuals through technology.

**Leontien M. van der Knaap** is an Associate Professor at the International Victimology Institute Tilburg (INTERVICT) at Tilburg University. She is a developmental psychologist and received her Ph.D. at the Free University of Amsterdam (2003). Her main research interests cover developmental victimology, domestic violence and risk assessment. She is involved in studies on ethnic differences in child abuse and delinquency, child sexual abuse of youth with an ethnic minority background, and the developmental effects of poly-victimisation in

childhood and adolescence. Previously, she was a senior researcher at the Research and Documentation Centre of the Dutch Ministry of Justice where she studied, among other things, topics such as risk assessment in forensic populations, domestic violence offenders and violence prevention.

**Irma van der Ploeg** (1964) holds degrees in Philosophy and Science and Technology studies. She has a background in Artificial Intelligence (2006, University of Amsterdam) and Science Communication (2008, VU University). Her research concerns the design and evaluation of a virtual empathic buddy that provides emotional support and practical advice to victims of cyberbullying. In 2010, she was a finalist for the Google Anita Borg Memorial Scholarship.

**Heidi Vandebosch** is an Associate Professor at the Department of Communication Studies at the University of Antwerp (Belgium). She is a member of the Research Group MIOS (Media and ICT in Organisations and Society).
